Tony Norman kicks off re-election campaign

District 3 school board incumbent Tony Norman drew a crowd Wednesday evening in a campaign kickoff event at the Holiday Inn on Cedar Bluff Road. The well-respected former Knox County Commission Chairman and former Knox County Schools biology teacher drew praises from supporters including Law Director Richard (Bud) Armstrong, and Deputy Law Directors David Buuck and Daniel

Residents and supporters from his district loudly applauded Norman's address where he spoke of the changes he helped bring about on the board of education. Norman said the school board was divided and in disarray when he was elected. His election and the election of other reformers tipped the scale to public representation and led to the retirement of Superintendent Jim McIntyre.

"The administration did not understand what it meant to be in the classroom. They didn't appreciate the classroom, the teachers or the working teams," Norman said, adding, "I think we've been able to change the direction of this system."

IMG Academy pulls away from Catholic late, wins 71-53

Knoxville Catholic took a shot at one of the nation's premier high school basketball teams Saturday afternoon and gave them all they wanted.

IMG Academy got out of town with a 71-53 win, but it wasn't easy for the tall and talented squad from Bradenton, Fla.

"I thought we played toe to toe with one of the best teams in the nation until 2:55 to go," said Catholic Coach Mike Hutchens.

A standing room only crowd of 1,625 watched the battle that saw the Fighting Irish (15-4) overcome a 12-point deficit at halftime and take a 45-43 lead late in the third quarter.

IMG Academy (14-4) retook the lead, but Catholic still had a chance to make it a two-score game with 2:45 remaining, but twice missed the front end of 1-and-1 free throw opportunities.

The 6-10 Moussa Diabiate from Paris, France was a force inside and led IMG with 20 points. Duke commitment Mark Williams, a 7-footer from Virginia Beach, added 14 points and point guard Jaden Springer, a Tennessee signee and crowd favorite,

Sophomore guard B.J. Edwards, who has offers from UT and Auburn, led Catholic with 17 points. Blue Cain added 12 and 6-9 senior power forward Akeem Odusipe 10 before fouling out with 6:48 left

Hutchens said "their size and depth" was the difference.

"They're amazing," he added. "That's why they are one of the top 12 teams in the country now and won the national title last year.

"That kind of game is only going to make us better and that game was great for basketball in Knoxville. That's probably the most talent between two teams that's ever been on a high school floor in the City of Knoxville."

IMG Coach Sean McAloon was impressed by Catholic.

"What we did had a lot to do with them," he said. "Their zone was very good and active. We turned the ball over way too much, but that's a credit to them. They did a good job of being super active and we didn't do a very good job of finding guys that were wide open. But we did enough to be able to pull away towards the end."

5G tower plans upset **Farragut** residents

Some Farragut homeowners are finding markings in their lawns and are upset about the planned location of 5G towers there. They stood before the mayor and aldermen Thursday evening to ask for help but found there's little the town can do other than seek help from their state lawmakers.

Although the tower placement was not on the agenda the citizens demanded some type of action during the public forum.

Eleven sites were approved earlier in the month by the Farragut Planning Commission and the towers would be built on public right of way in the town. Some 120 people attended the meeting and heard Town Attorney Tom Hale tell them there's little the town can do to stop the towers.

If the Board of Mayor and Aldermen fail to vote within 61 days then Verizon's application for eleven towers would automatically be approved. Two other companies, AT&T and T-Mobile, may also apply for the small 5G towers.

One resident, Bill Bryant, said his lawn has been marked for a tower but the neighborhood has underground utilities. He called on help from the area's state legislators to protect Farragut home

Laura Squire told the meeting she feels "violated" with the proliferation of the towers.

"We only have the powers given to us by the state," Attorney Hale said.

"No one understands it, what is a 'right-of-way?'" Squire inquired, encouraging the body to go to the state and see about opting out of the tower placements.

"State law trumps ours," Town Administrator David Smoak said of the difficulty of the town to fight the state and federal regu-

lations. One resident said the powerful little towers cause cancer and asked that the towers be located

in commercial areas only.

Mike Mitchell said that state Senator Richard Briggs is asking for a resolution for the town to opt out. He called the 5G towers a "massive overkill" of data capacity and added, "There's no need for those in a residential neighborhood."

He said the state legislators don't understand the impact that residential towers on rightof-ways will have on Farragut. Mitchell said the towers will reduce home values as much as 21 percent.

Several other homeowners spoke against the location of the 5G towers. It was noted that the

Former Mayor Rogero to receive \$3,001 per month retirement

Among the twenty-four consent items on the Knoxville City Council's agenda Tuesday evening is a pension of \$3,001.44 to former mayor Madeline A. Rogero. Rogero served as mayor for eight years, with former Mayor Bill Haslam's administration before that and also served as a Knox County Commissioner.

The council may also agree to appoint Councilwoman Lynn Fugate to fill out the unexpired term of resigning Councilwoman Stephanie Welch on the City Pension Board.

The city council will also consider a \$4.4 million contract with Rogers Group Inc. for road resurfacing this

The property at 1615 East Fifth Avenue, currently zoned for Park and Open Space, may be rezoned to Planned Residential with 24 units per acre. The ordinance involves closing of part of Myrtle Street adjacent to the current apartments and using that land for expansion by Volunteer Ministries for additional apartments for the homeless. It does not include the two lots to the east which will remain part of the Caswell Park open spaces.

A decision by the Board of Zoning Appeals by Jennifer Arthur is on the agenda. She is appealing a decision that approved four variances for property as 931 Langford Avenue. A lot at 2350 Robinson Road will be considered for a zoning change from Agricultural to single family residential.

Three items ask for closing of roads or alleys on West Cliff Drive, Maryville Pike, and Sevier Avenue.

Travel, school activities reported to Audit Committee

The Internal Auditor's Office of Knox County presented its findings on county travel expenses and policies to the audit committee Tuesday. Zac Fullerton told the committee that overall the county has an adequate control over processing employee and elected officials' travel expenses but offered examples of abuse and suggestions on improvements.

Fullerton's report included

incidents of claiming unreason- with cost saving measures. Fullerable mileage, self-authorized travel, lodging and meals exceeding allowable amounts or being reported for deductions even when free. He also noted instances of overpayment of travel expenses, and missing or incomplete authorizations or summaries associated with prepayment.

He urged the finance department to return incomplete forms to the employee to be completed; perform tests for claimed mileage, and update the Travel Policy ton wants to remind department heads that travel cards are available and should be used for larger expenses, and require employees to indicate if meals are part of the travel.

He said that the finance department handles more than 1,200 payment requests per month from outside vendors and county employees. The audit committee also heard

a report on school activity funds from Ted Hotz of Pugh CPA. He

said the audit looked at the county's 88 schools and found fewer violations than last year. He said that, combined, the schools have more than \$10 million in their accounts from school activities and fund raising.

Issues were found with the high turnover of in-school bookkeepers, the segregation of duties, tracking cash receipts, and disbursement of funds. He also reported on purchase orders, ticket sales, fund raising, travel policies and unclaimed accounts.

Final vote on TVA Tower move?

When the Knox County Commission meets tonight the members may finally decide on Mayor Glenn Jacobs' push to lease the TVA East Tower and move the school administration offices there.

After a lengthy discussion during Tuesday evening's work session Commissioner Randy Smith moved to approve the deal and Brad Anders seconded the motion, but Carson Dailey moved to move the vote to tonight's meeting with no recommendation. The motion passed unani-

The meeting, from 5 p.m.

A proposed apartment complex on Beverly Road and New Beverly Baptist Church Road passed the Knoxville-Knox County Planning, 13-0. The multi-family unit development on the 80-acre tract was recently approved by the planners for 210 units. Attorney Charles Taylor may speak for the opposition. Developer Randy Guignard has been trying to develop the sloped property and finally won planner's approval.

Police shootings on PARC agenda

The quarterly meeting of the Police Advisory & Review Committee this week will deal with two officer involved shootings. Director Clarence Vaughn II told The Focus that the Merchant Drive shooting death of Tom "Philly" Pheap may not be heard until it is released by the internal affairs unit and probably will reach the committee for its next meeting in April.

Vaughn said that two other officer involved shootings, one from 2018 and one in 2019, will be reviewed. He said the first shooting involved several officers who responded to an incident at 4901 Lowe Street where, after gunfire was exchanged, the suspect was found after an apparent suicide.

The 2019 shooting involved a female

police trainee and was ruled a justifiable homicide. She was investigating a parked car and noticed the person had a weapon in the car. Instead of responding to the officer the person drive away quickly and the officer fired one shot, killing the suspect.

Texas Avenue in Lonsdale. On the agenda is the presentation of the annual report including the number of cases received in 2019, and an overview of crime in the city. The quarterly meeting will also have

January 27, 2020 Commissioners meet with state legislators

"All politics is local" is the saying but Knox County Commissioners know that a lot that happens in Nashville directly affects what goes on here.

Recently the commissioners had a lunch meeting at Crown Plaza with our area's elected state senators and representatives to express concerns over recent, pending and proposed legislation. Chairman Hugh Nystrom led the discussion by saying mental health funding and tax administration changes are needed.

Commissioner John Schoonmaker, who heads the commission's legislative committee, outlined several concerns. He asked for the abolition or a reduction of the amount the state withholds from the county to calculate those taxes to be returned to the county.

He suggested the amount the Knox County Register of Deeds returns locally be increased from 2.4% to 5%. He also asked that the "single article" sales tax the legislators.

locally be increased from \$1,600 to \$3,200

Schoonmaker also encouraged the legislators to develop a funding program for housing and health care for state prisoners being held in county

The meeting also saw a discussion on prohibiting smoking on the grounds of a playgrounds owned or operated by city or county governments. Also discussed was "kin-

ship care" and how the state could possibly help fund relatives who have custody of grandchildren. It was estimated that \$9,000 per year is the cost of holding children in state custody and one suggestion is to use some of the state's surplus for that purpose.

The lack of state laws limiting vaping was also discussed as was more financial support for veteran services.

Following the commission session the Knox County Board of Education shared their concerns with

worth. Alice Roosevelt Longworth, eldest child of former President Theodore Roosevelt, had been in the public eye since the assassination of William McKinley in 1901. Banned from the White House during the administration of Theodore Roosevelt's chosen successor, William Howard Taft, due to her public comments about First Lady Helen Taft, Alice found herself in the same position during Woodrow Wilson's reign as president. Theodore Roosevelt had a particular dislike for Wilson and when the President refused to allow him to raise a division and fight in France during the First World War, TR's dislike boiled to a red-hot hatred. Roosevelt campaigned hard for Republican candidates in 1918 and President Wilson made a crucial mistake in telling the American people the election of a GOP Congress would be a repudiation of him and his administration. Nobody was more gleeful than Theodore Roosevelt when the Republicans won a majority in Congress that year. Alice Roosevelt Longworth regularly attended committee meetings, sessions of both the House and Senate, and threw intimate dinners where she lobbied against American entry into the League of Nations. Dinner at the home of Alice Longworth was a prized invitation and the food was excellent, although apparently she had the

Virtually everyone who knew Alice Roosevelt Longworth personally attested to the fact she was one of the most stimulating and erudite conversationalists he or she had ever met. 

A convivial man with a love of music, women, and liquor, Nick Longworth was enormously popular with his fellow congressmen, Democrats and Republicans alike. Longworth was especially good friends with his counterpart on the Democratic side of the aisle, John Nance Garner of Texas. Garner certainly enjoyed taking a drink himself and instituted what he referred to as the "Board of Education" in a Capitol hideaway office where he poured drinks for a favored few each day. The Longworth marriage was not what it once had been and while Nick and Alice loved each other, the congressman continued drinking and kept mistresses, a fact known to Alice. For her part, Alice did not seem as upset about her husband's lady friends than she did his drinking. Alice Roosevelt Longworth never tolerated drunks and her husband overindulged on numerous occasions. As to affairs, Alice had embarked on her own with Senator William E. Borah of Idaho. Bill Borah was an impressive man, a constitutional expert. a highly regarded lawyer, and a brilliant orator, one of the few members of the Senate thought to be able to change the votes of his colleagues with one of his powerful speeches. Borah was an isolationist and profoundly opposed to American participation in the League of Nations. Along with California senator Hiram W. Johnson, Borah had trailed Woodrow Wilson across the county during the President's ill-fated speaking tour to change the minds of the American people and pressure the U.S. Senate into ratifying the Treaty of Versailles. Wilson suffered a serious stroke on his speaking tour which left him highly disabled, a fact that was successfully kept from the public by his physician and First Lady Edith Bolling Wilson. with Senator Borah; nor does anyone know if he knew that the daughter Alice bore was that of Bill Borah. Nick seemed not to suspect as he positively doted on the daughter Alice named Paulina. Certainly Alice's affair with the senator was hardly news to many denizens of Washington. Some wags referred to Alice as "Aurora Borah Alice" while others snickered she should name her daughter "De-Borah." Yet Mrs. Longworth was one of those rare and exceptional people who simply did not give a continental what others thought of her and while Paulina's true paternity was suspected by many, Nick Longworth either did

not know or did not care. For the remainder of his life, Nicholas Longworth took his daughter with him everywhere he could, as often as he could. Paulina could be found playing with the typewriters in his office, especially after he became Speaker of the House in 1925. Paulina was deprived of her beloved father when the ailing Speaker had gone to the home of friends in South Carolina where he eventually died of pneumonia in 1931. While Nicholas Longworth had been wealthy, evidently he did not leave Alice set for life. Mrs. Longworth wrote an autobiography, "Crowded Hours", that sold well and was encouraged to write a newspaper column like that of her cousin Eleanor, who was then First Lady. To augment her income, Alice cheerfully appeared in paid advertisements for cigarettes (which she loved), as well as Pond's cold cream.

Eleanor was an inviting target for Alice's malevolent wit and the First Lady had heard about her cousin's impersonation of her. Eleanor Roosevelt asked Alice to perform the impersonation, which included Alice protruding her front teeth. Alice gave Eleanor a demonstration of the impersonation, which had been seen many times by much of

Washington's society,

and while the First Lady managed a little laugh, it was utterly devastating. Eleanor readily granted Alice's intelligence but observed her cousin's life appeared "to be one long pursuit of pleasure and excitement and rather little real happiness." Alice's tart tongue usually found its target and she sniffed Franklin Roosevelt was "one-thirds mush and two-thirds Eleanor."

Eleanor did have the satisfaction of knowing her newspaper column, which expanded to radio, was much more popular and widely read than Alice's; the problem with Mrs. Longworth's column was it exhibited none of her vibrant personality and mordant wit. Eventually, Alice discontinued her column while Eleanor's lasted until her death. Still. Alice continued to be invited to the White House by Eleanor until Franklin Roosevelt could stand it no longer. Alice, being a Republican, heartily denounced FDR and the New Deal Justily every four years. Still, Alice did not spare some of those in her own party and was credited with the statement that haunted Wendell Willkie, the 1940 GOP presidential nominee, throughout his campaign. When an acquaintance marveled at Willkie's surprise win at the Republican **National Convention** in Philadelphia and speculated his candidacy had been boosted by the "grassroots", Alice retorted, "Yes, the grassroots of 10,000 country clubs." It was Alice Longworth who said of Calvin Coolidge, "He looks as if he's been weaned on a pickle." Alice's opinion of Warren G. Harding was even lower, saying the president was "just a slob."

the 1944 Republican
presidential nominee
was the victim of another
supposed Alice Longworth
bon mot. Allegedly, Alice
was thought to have said
Dewey "looks like the little
man on the wedding cake."
For the rest of her life, Alice

Longworth denied she had

ever said any such thing.

According to one of Mrs. Longworth's biographers, two women who thought it would be clever went around Washington, D. C. quoting the remark and crediting Alice. The fact it spread so far and quickly is tribute to Alice's usual wit.

When Republican senator Joe McCarthy encountered Alice, he met his match. Putting his arm around her, something she genuinely disliked, he tried to make a joke, saying he considered Mrs. Longworth his date and would therefore call her "Alice." Mrs. Longworth snapped, "No, Senator McCarthy, you are not going to call me Alice. The truckman, the trash man and the policemen may call me

Alice, but you may not." Alice Roosevelt Longworth remained an isolationist, serving on the Board of America First. until the United States entered World War II with the bombing of Pearl Harbor. With the death of Franklin Roosevelt and the presidency of Harry Truman, Alice's company was still much sought after and invitations to her home still highly prized, but Eleanor's comment about happiness seemed prescient as Paulina descended into depression. Paulina had married well, but her husband, Alexander Strum, while remarkably talented and intelligent, had a very serious drinking problem. Strum died at age twentyeight from viral hepatitis after having produced a daughter, Joanna, with Paulina. Five years after Alex Strum's death in 1951, Paulina Longworth Strum died from a combination of sleeping pills and alcohol. Alice was faced with raising her ten year-old granddaughter. Whatever failings she had as a mother, Alice made up for as a grandmother. Joanna remained the person whose company Alice craved the most until the end of her life. Fortunately, Joanna proved to be as happy an adult as her mother had been unhappy. The

year before Paulina's

death, Alice Longworth

had suffered a fall and

broken her hip; a year later she was diagnosed with breast cancer and underwent a mastectomy. In 1970, cancer was found in her other breast and once again she had a mastectomy. Alice referred to herself as "Washington's only topless octogenarian."

Alice Longworth, or "Mrs. L" as she was popularly known by those who knew her, remained a fixture of Washington society and was preeminent amongst the Capitol's "cave dwellers." Alice had long liked Richard Nixon and supported him in his 1960 campaign against John F. Kennedy, but even she was not immune to the Kennedy charm. While Alice was sorry Nixon lost the election, she admitted until she met the Kennedy clan she did not realize "how amusing and attractive Democrats could be." Despite her affection for the Kennedy family, Alice Roosevelt Longworth was one of the very few people knowledgeable about politics who did not believe Richard Nixon's career was over, even after losing the 1962 gubernatorial race in California. Alice also abandoned her own political party briefly when she voted for Lyndon Johnson over Barry Goldwater in 1964. Yet Alice scalded LBJ when he complained about her habit of wearing broad brimmed hats, saying it prevented him from

ment upon you. Although this list is probably not exhaustive, here are some of the different judges you might find yourself in front of.

SUPREME COURT JUS-**TICE** There are Supreme Court Justices on both the federal and state level. These are the most important judges there are. If a case gets heard by them, then it has been appealed at least twice. Also, the Supreme Court gets to choose which cases it wishes to hear, and which cases it does not want to hear. There are five Tennessee Supreme Court Justices and nine federal Supreme Court Justices. Unlike in a trial court, multiple judges hear the cases simultaneously and then they vote as to how they wish to rule and issue a written decision stating

what their ruling is. **APPELLATE JUDGE** If the decision of a trial judge gets appealed, the first court to hear the appeal

Appeals. This is usually a panel of three judges. the Supreme Court, cases appealed. In Tennessee, some appellate judges will hear only criminal cases, and

some will hear only civil cases.

JUDGES Everyone knows what a judge is. The person hearing and deciding their case, right? There are many different types of judges. There are circuit court judges, general sessions judges, and juvenile judges, to name a few. Judges in Tennessee must run for office and be elected, while federal judges are appointed to their positions.

CHANCELLOR Chancellors preside over Chancery Court and are similar to judges in their level of authority, however, they hear different types of cases. There is not a ton of difference between chancellors and judges as to what they are doing day to day. Typically, they are both hearing cases and making decisions on a daily basis. Chancellors are also elected to their positions.




