Renovations coming for Claude Walker Park

The ball fields at Claude Walker Park will soon be getting a facelift as the city has received a \$1.6 million philanthropic gift courtesy of GEM Development Group.

Claude Walker Park, located in East Knoxville adjacent to Austin-East Magnet High School, is home to the Lady Roadrunners softball team, the Baby Roadrunners youth football program and the Knox Area Youth Alliance.

The gift is earmarked to improve Claude Walker Park and contains a pair of key components.

The majority of the money, \$1.1 million, will go toward the installation of new state-of the-art turf baseball and football fields. The money will also be used to making lighting and fencing improvements and the

City budget passes 8-1

Includes co-responder funds, affordable housing

It took a while but the Knoxville City Council approved a \$253,558,130 budget for the upcoming fiscal year, an 8.1% increase. The second reading took place Tuesday evening and much discussion centered on the budgeted \$400,000 to increase the number of social workers that accompany police on calls when needed.

Councilwoman Amelia Parker attempted to delay the vote in order to hold additional public input meetings. Parker suggested the additional funding go to reserve fund status and the creation of an "alternative response" rather than social workers responding with a police officer. Her motion failed

for the lack of a second. Councilwoman Janet

social workers and added, "We're not hiring more police officers."

"I'm tired of hearing the same conversation, the same kind of empty promises," said Parker, adding she believes the public that needs those services haven't been heard from.

Councilwoman Lauren Rider said the police officers can't be expected to respond to emotional crisis adding, "That's not what they are trained to do."

Councilman Tommy Smith spoke at length on his support of the budget proposal saying," It makes progress on the most urgent items."

Parker also objected to the Lakeshore Park funding and the proposed downtown baseball stadium.

Committee dissolved, free parking and stadium study

It only took one vote for the Knox County Commission to dissolve the Committee on Health and Economic Well-Being last week during a work session. Commissioner Kyle Ward, who had suggested the alternate health advisory group originally, moved to disband the group.

Ward said a couple of the committee members reached out to him to end the board, which never got to a point of advising the mayor or commission. The mayor and commission dissolved the Board of Health last month and Mayor Glenn Jacobs took over emergency public health regulations ending masking mandates, social gatherings, etc.

Dr. Martha Buchanan, relieved of her emergency powers, continues to meet with the former Board of Health members now serving in an advisory capacity.

The commission passed on first reading an amendment to the Knox County Code to provide free monthly

ees in the City-County Building and Dwight Kessel garages beginning on July 1. A tentative tax break was approved for the development of a project known as Farragut Town Center at Biddle Farms. Final approval will come back for a vote when the plans are completed. The mixed development is being proposed for the former Kroger complex and the tax break would be for \$6 million over 20 years. Additional property there is being considered bringing the new development to 45 acres.

"We haven't seen a study," he said, asking Finance Director Chris Caldwell about the results. "We can send what they

"The stadium is not a done deal," Caldwell said, adding that when the cost analysis study comes back it might prompt an increase in the annual lease rate.

When asked about how many firms submitted bids on the study, Caldwell's answer was seven, with three estimates coming in late. Four firms were reviewed before CSL was selected.

The commission also passed along a change in the code to permit public notices to be published in newspapers of general circulation but Commissioner Kyle Ward pointed to the Tennessee legislature possibly moving to permit the county to advertise notices on a special website in future years.

Also discussed briefly were the regulations concerning allowing churches to locate in shopping centers. Current county law prohibits restaurants to serve alcohol near a church. The questions is if a beer-serving restaurant is located in a center before a church rents space there how does it affect the statute?

The planning commission will be asked to look at the regulation and report back to the commission.



Some of the money will also be used to provide uniforms and sports equipment for athletes.

Both components of the gift will be managed by Knoxville's Emerald Youth Foundation, an inner-city youth ministry.

Claude Walker Park will continue to be operated by the City of Knoxville. The renovations will be performed by Elite Diversified Construction. Construction at the facility is expected to begin in the fall.

GEM Community Development President and Chicago resident Steve Davis, who grew up in East Knoxville before going on to play football at the University of Tennessee under legendary head coach Johnny Majors, was thrilled to return home for the renovation announcement, which was celebrated in a ceremony on Monday, May 17 at the park.

"I'm here today because I grew up a couple of streets over from the park," Davis said. "I played little league football in this park.

"Today is an exciting day for the children in our city. As a young person who grew up in Knoxville myself, I know firsthand the value these fields have brought over decades and decades of play. After many years of heavy use, the fields are

in need of improvement. We believe this investment will help transform them into a world-class facility for our city's young people."



This would be in the tradition of colonial America (which probably condemns the idea as being racist) which was derived from the English Bill of Rights of 1689. Knoxville Cable Television has set its upcoming annual budget at \$748,000, based on city and county contributions and franchise license fees from cable providers. With Comcast no longer making an additional contribution annually of \$137,000, the cable board and staff are looking at a new Memorandum of Understanding additional ways to raise funds.

Funds from upcoming events, such as donor campaigns, and grants are not included in the operational budget. The station came in under budget this year.

Chairman Jim Idol described the proposed funding as a "maintenance budget" and noted that station duties will be split between Kevin Jeske-Polyak and Jason Oaks rather than hiring a general director. Jeske-Polyak has taken over efforts on the budget, grants and auctions. Oaks will oversee day to day operation at CTV.

"We're not yet near an emergency situation," Idol told the board about funding. Several board members, including Charles Lomax Jr., suggested they start

looking at additional fundraising opportunities. Somewhere between \$10,000 and \$30,000 in additional funds are expected to be raised this year and it was suggested that board members get involved in promoting the station and also in pursuing donations.

Stephanie Cook reminded the board that needs to be made with the city and county in their split funding of closed captioning.

Oaks reported an upgrade to the operating system and said next year they may look to replace some of the production computers. He also said CTV will conduct a workshop in June for the Alliance for Non-Profits, a PSA workshop, and how to involve the community.

Idol said the bylaws need to be changed to reflect the two "station managers" rather than "general manager" and the slot on the board for Comcast should probably be dropped. He also said the board could use an attorney as a member or a new producer. It was also suggested that a religious leader be added to the board.



How Long is a Judgment Good For?

If you ever have to sue someone, and the matter proceeds to trial, and you win, you will be awarded a judgment against the person who you sued. For example, if a credit card company sues someone for not

paying their bill, they may obtain a judgment against the person for \$5,000.00.

When that happens, there is not a safe full of cash sitting in the courthouse where they bring out the amount awarded to the credit card company. they believe the defendant lives and assume they will never collect the fees they are owed.

Does that judgment follow the defendant forever? Do they simply owe this money until the end of time? No.

Under Tennessee Code Annotated section 28-3-110, a judgment against a defendant is only good for 10 years. There are a few very narrow exceptions to this, but that is generally the rule. So, if someone gets a judgment against a defendant, they do nothing to collect that money, and 10 years pass, the defen-

I do not know what you may feel about defendants getting out of judgments awarded against them after 10 years (assuming the judgment is not renewed), but at least in Tennessee that is the law.

Practically though, if someone has significant assets, it is hard to hide that fact and therefore a person receiving a judgment against such a person will doggedly pursue what they are owed well within 10 years.

If however, a defendant with a judgment against them is destitute or has little to no assets, it may not be worth it to the credit card company to squeeze the few dollars they have out of them. It's a straight cost/benefit analysis, and after 10 years have passed, this defendant can be unburdened from this judgment hanging over their head.

Tennessee's 'Unholy Trinity' Walter 'Pete' Haynes

Pages from the Past

For decades the Tennessee General Assembly was largely ruled by three men: Walter M. "Pete" Haynes of Decherd; I. D. Beasley of Carthage and James H. Cummings of Woodbury. Known as the "Unholy Trinity," the three men were powerful legislators and highly important in their respective communities. Beasley, Haynes and Cummings were all country lawyers by trade and each represented rural districts in the legislature. All of them spent decades as members of the state legislature and not only did they know where the bodies were buried in Nashville, the Unholy Trinity buried many of them personally. More politely, Beasley, Haynes and Cummings were known simply as the "Triumvirate."

Walter "Pete" Haynes was born October 2, 1897 in Decherd, Tennessee. Haynes earned his law degree and began practicing law in Winchester before winning the election to the Tennessee House of Representatives in 1922 when he was twenty-five years old. Altogether, Haynes served nine terms in the House of Representatives and three in the State Senate representing Franklin, legislature as speaker of either the House or Senate. Pete Haynes was Speaker of the Tennessee House of Representatives in 1931, 1935 and 1937; Haynes was Speaker of the State Senate in 1949 and 1951. Haynes was also Tennessee's first lieutenant governor through an act passed by the legislature in 1951. Haynes quickly allied himself with I. D. Beasley and "Mr. Jim" Cummings as members of the Tennessee General Assembly. All three men were remarkably colorful characters, each with his own particular strengths and weaknesses. As a combine, they were a force to be reckoned with. Haynes was a masterful parliamentarian, while the rotund Beasley carried the fight on the floor of the legislature. Beasley was also renowned for being a superb mimic, possessing an uncanny ability to impersonate most anyone, man or woman. I. D. Beasley was playfully referred to as "The Mockingbird of Capitol Hill."

profoundly interested in helping the rural people they represented, as well as making Tennessee a better place to live. All three of the Unholy Trinity liked good food, smoking, and drinking whisky and they all had a sense of humor. None of the three men took themselves especially seriously.

Joe Hatcher, the political columnist for the Nashville Tennessean, had covered Pete Haynes since Haynes' first legislative session in 1923. Hatcher wrote, "Old Pete is a legend in legislative history, one of the most colorful characters ever to serve, especially for so long and so well." Hatcher guessed Haynes' name was "probably on more legislation than any other member in history, because leadership and progressive thought."

Recognition began to dawn on Haynes' face and he barked, "Where is I. D. and Jim?" Haynes knew "The Mockingbird of Capitol Hill" had summoned the sleepy legislators by mimicking his friend. Pete Haynes managed Governor Gordon Browning's bid for a third consecutive term in 1952, a contest won by thirty-two year old Frank Clement. **Evidently Governor Clement** had a long memory and the two were never close. When Haynes sought election to the State Senate in 1964 and was defeated by Ernest Crouch, many thought it was through the efforts of the Clement organization even though Pete Haynes had been a floor leader for Clement's successor Buford Ellington in 1959. Quarreling with governors was nothing new to Pete Haynes, who had been a member of the opposition to chief executive Austin Peay during his first years in the House. Haynes was also opposed to Governor Henry Horton and presided over the impeachment hearings against Horton. Haynes was a staunch supporter of Senator Kenneth McKellar and

Crump's legislative generalissimo Frank "Roxie" Hot Springs, Arkansas. commitments to get himself elected Speaker. Crump was astonished when Pete Haynes was elected Speaker over his personal opposition. While on a vacation supported in Florida together, I. D. Beasley had some fun with Haynes after he had upset the Memphis Boss. Beasley planted a loudspeaker under Haynes' bed. As Haynes was drifting off to sleep, he heard "a ghost-like voice" saying, "Pete, this is Ed Crump. You doublecrossed me in 1935." Haynes worriedly asked his roommate if he had heard the mysterious voice and naturally his friend insisted he hadn't heard a thing. Haynes went back to bed, only to hear the voice once again. Repeatedly, Pete Haynes heard Ed Crump remonstrating with him for having double-crossed him to win the speakership, while his roommate adamantly insisted he didn't hear a word. In a fit of rage and frustration, Haynes finally defiantly stood up in his bed and cried, "If you're Mr. Crump ... I double-crossed you three times, and you didn't know it until 1935!" During Pete Haynes' time in Nashville, lawmakers were especially wary of attempting to pass legislation regarding dogs. Man's best friend

was a touchy subject with many Tennesseans and legislators were all too well aware those unfortunate souls who trifled with what they termed "dog laws" usually didn't come back. One enterprising opponent made headway against Haynes during a campaign when he reprinted a "dog law" bearing the signature of Pete Haynes. In truth, Haynes had not been the sponsor of the bill and may not have even voted for it, but as Speaker, his signature was on it. After the election, a friend asked "It would take an hour to explain it, and chances are nobody would believe me anyhow. My name was there, wasn't it?' Haynes, like Crump, former Congressman Gordon Browning for governor in 1936. Pete Haynes became Speaker of the House during Browning's first term in 1937. It was the beginning of a long association between the two men. Pete Haynes was also an excellent attorney, even if he was just a country lawyer. John Jay Hooker, Sr., father of the future gubernatorial candidate, believed Haynes had a "way with a jury you don't see very often." Hooker thought Haynes suffered due to his political prominence, causing some to think the legislator's legal abilities were subpar. The elder Hooker said, "I regarded him as one of the greatest trial lawyers that ever lived in this state."

law firms. During his career as an attorney, Haynes defended more than 400 individuals charged with crimes that carried the death penalty. When asked why he refused to consider lucrative offers from big law firms, Pete Haynes replied, "I like it where I am."

Haynes was as a delegate to Tennessee **Constitutional Convention** in 1953 and attended the national Democratic conventions in 1928, 1952, 1956 and 1960. of practical politics. His ability to put together the possible made him one of the most effective Tennessee political leaders of our time." Governor Frank Clement said Haynes was "a hard fighter" as well as an "able lawyer" and a dedicated public servant to the people of Tennessee. John Jay Hooker described Haynes as "a great personality who brought good humor and joy to every meeting." Hooker noted Haynes was "highly intelligent", an intrinsically kind man and "an unfailingly marvelous human being.'

Pete Haynes, although a Middle Tennessean, was important enough a political figure to merit an editorial on his passing in the Kingsport Times. The Times naturally referred to Haynes' association with I. D. Beasley and Mr. Jim Cummings while remembering the late legislator as "a robust, strong-voiced man who could get the attention of everyone when he rose to speak." Sadly recalling the last session of the legislature in which Pete Haynes served, the Times noted: "ill health had taken its toll, but he was still an effective lawmaker."

Describing Haynes as "widely known in Tennessee and elsewhere in the nation," the Tennessean likely summed up Pete Haynes' character when it noted the late lawmaker's "circle of friends ranged from great national leaders to regular courtyard whittlers." Beasley got to the legislature two years before Haynes and Jim Cummings arrived four years after Pete Haynes had first been elected. The three were not to be mistaken for mere rabble-rousers; they were serious legislators,

Haynes practiced law from 1919 until his death, save for two years. Pete Haynes served for one year as a bankruptcy referee and gave another year of his life to work as an assistant state attorney general.

Pete Haynes died in 1967. An employee who had come to the historic Haynes home to drive the former legislator to Haynes' law office discovered his body; apparently, the sixtynine year old Haynes had died in his sleep. Haynes had been in declining health for some time, having suffered a heart attack during the late forties and a light stroke in the early sixties. The death of the long-time legislator came as a profound shock to his many friends as he had appeared to be in relatively good health for the past several years. Haynes had spent the previous Friday working at his law office. Tributes to Pete Haynes poured in from Tennessee Democrats. Senator Albert Gore thought, "Mr. Haynes mastered the art





Farragut mystique strikes again

Sept. 27, will long live-in infamy in the history of Tennessee football. The Vols are likely to be in the record books forever on this one.

It wasn't because the score was No. 3 Auburn 13. Tennessee 0.

It wasn't because Auburn scored all its points in the fourth quarter to break open a tenacious defensive struggle.

One statistic tells the story.

First downs: Auburn 11, Tennessee 0.

You read that one right, in a full 60 minutes of football, the Vols didn't make a single first down, not by rushing, not by passing, not even by penalty.

It hasn't happened since in the annals of major college football and rarely before that.

The Vols ended up with a minus-49 yards rushing and 19 passing. Wyatt searched for the right words to explain how things transpired.

"The only thing we can do now is start from scratch and try to get an offense going," he said. "The ball carriers didn't have a chance. The blocking wasn't there. As everybody could see, we simply couldn't move the ball. So, we had to kick and scratch, and that's what we did."

To say that tennis is a huge part of Trey Ambrose's life would be a huge understatement.



"We are getting out of our coop," said Dr. Martha Buchanan in meeting with the Advisory Board of Health Wednesday. She was talking about the progress made against COVID-19.

The Advisory Board met in the main assembly room of the City-County Building and heard Dr. Martha Buchanan report that two of the health benchmarks are in "Yellow" or cautious status.

Buchanan said that testing and the percent of those vaccinated are not where they should be and she said the health department has given more than 50,000 of the 377,802 COVID-19 vaccines administered in the county. She also reported that about 180,000 citizens have been fully vaccinated.

She said the number of requested vaccine shots has fallen and the health department is reaching out to places of work, the homeless, AMR and the fire department. She said the number of staff at the Broadway Clinic has been reduced but continues with some employees, volunteers and the National Guard.

The board heard from Knox County Deputy Law Director David Sanders who said that since the board is now advisory the presence of a county attorney is not needed. "I'll still be available to you," he promised but added there was no need for him to sit through a meeting.

Buchanan said her proposed

budget for the new fiscal year includes a 2% pay increase and adds \$1 million including two more employees, one to specialize in women's health. She said that \$237,000 of the budget may go to upgrading the department's health records.

Dr. John Shamiyeh asked about the disparity in the budget and the revenue and Buchanan said that 35 to 50 grants are not included. She said Knox County Mayor Glenn Jacobs wants the department to focus on mental health. Since the board is now

only "advisory" there was no need to approve the budget.

Shamiyeh reported that the positivity rate of infection is down to 4.3% but the pandemic "is still real."

Buchanan reminded the board, meeting without masks, that there is no mask requirement in the county nor is social distancing required.

The board discussed future meetings and decided to hold a June meeting and then go to a quarterly meeting cycle.
