Ask any public school teacher if he's ever heard this from his students, and he'll likely laugh in recognition.

Knox County Schools has a plan to try to give those students an emphatic and satisfactory answer. If it proves successful, graduates from Knox Co. high schools will be much better prepared to meet the workplace challenges of the future. Last Thursday morning at Central

"Gone are the days when a kid is either smart or good with their hands," Rysewyk went on. "Today you have to be smart and have the technical skills to go into the workplace."

It is a landmark in Gibbs Community. Coming from Knoxville on Tazewell Pike, the Midway IGA is located on the left soon after passing through the gap. For those coming by way of Harbison's Crossroads where Tazewell Pike intersects Emory Road, the anchor tenant of Gibbs Center at 7345 Tazewell Pike is on the right across from the entrance to Clear Springs Baptist Church. I recall that the land where the store is located was once a hayfield before Joe and Dale Longmire purchased it in 1995. The Midway IGA, commonly referred to by locals as "the IGA," was built in 1997. According to Joe, "it is the biggest independent grocery store this side of Nashville in Tennessee."

Since 1951, the private non-profit has been a sailboat haven for more than 200 dues-paying members, some of whom are not county residents. Located on Lakeshore Drive at Concord Park, the yacht club offers sailing instruction, hosts events and races, and manages docks for members' sailboats.

City Council: Chained dogs must be supervised

Is it fair to chain or tether a pet dog in your backyard without being out there to watch the animal?

That was the question debated for two hours Tuesday in the Knoxville City Council meeting, a discussion that split the council into a tie vote. Options for the total ban on unattended tethering were offered but, in the end, the council decided that one must be in the yard watching the pet when it is on a tether starting in July.

The issue has been discussed for more than a month and pitted the Young-Williams Animal Center against some other local humane organizations. Considerations within the new regulation debate included the effect on the understaffed animal control department, possible warnings or fines, the safety of the animal, and the duties of the pet owners.

Young-Williams Animal Center, sided with the unwatched tethering idea, citing that being present while an animal is tethered outside is unfair to people in poverty. She said that many people own more than one dog and deserve equal treatment.

Councilman Tommy Smith offered an amendment that and see how it works," would permit pet owners to be inside for 15 minutes to do chores while the animal is chained outside. Vice Mayor Andrew Roberto countered that the 15 minutes means animal control officers would have to wait that long at a house before taking action.

Several council members voiced differing opinions and Mayor Indya Kincannon described the proposed amendments that failed as "the devil in the details."

Councilwoman Lauren Rider noted many cities have tethering regulations that work and Testerman

> Reportedly animal control received 34 calls about uncontrolled animals on the day of the council meeting and more than 10,000 calls last year. Smith said requiring owners to be outside with a tethered dog would increase the number of calls about the animals.

> The final vote on Smith's suggested 15-minute break option led to "Yes" votes from Lynne Fugate, Smith, McKenzie and Testerman. Voting "No" were Seema Singh, Roberto, Rider and Thomas.

IN OTHER ACTION, the council voted to require posting variances and appeals prior to city Board of Zoning Appeals meetings, acquire property for greenway projects, renew KUB's tax break, hire a firm to audit KUB, and give the Community Action Committee \$260,000 for emergency services to help with loss of federal funding.

The council also heard Police Chief Paul Noel describe a new position with the department to oversee the Internal Affairs division.

Can the Knoxville mayor break a tie vote of council?

Following a tie vote of the Knoxville City Council last week, the question came up if Mayor Indya Kincannon

could have broken the stalemate by voting.

Councilwoman At-Large Janet Testerman told The Knoxville Focus the mayor could have chimed in and broken the tie. It was a 4-4 vote on a motion by Councilman Tommy Smith to permit pet owners a 15-minute break inside their homes while watching their dog secured with a tether outside

Councilwoman With Amelia Parker abstaining from the vote, the tie vote meant the Smith motion failed under the city code.

So, can a Knoxville Mayor break a tie vote?

"The mayor has the option of breaking a tie vote but she is not required to do so," City Attorney Charles Swanson told The Focus.

"The mayor shall preside over all meetings of the council, but shall not have the right to vote, except in the event of a tie, [and] then the mayor shall have the right to cast the deciding vote upon the question then before the council," according to the city code.

Testerman lamented that Mayor Kincannon didn't choose to vote and break the tie.



Tethered Dog Ordinance Approved

The Knoxville City Council recently approved an ordinance making it illegal for people to chain their dogs up outside unattended. The change was adopted after a sometimes pointed debate, but the ordnance ultimately passed with only one dissenting vote. Known for making the odd random comment, Councilwoman Lynn Fugate said it was sad people contributed to things involving dogs more

than they do girls. Girls? What happened to boys or even people? The answer likely has something to do with the fact that Fugate is the director of the Girl Scouts of East Tennessee and she failed to explain why one was mutually exclusive of the other. My guess is, when one considers all the spending done by the government, spending on people - - - and girls are people - - - that spending far outweighs whatever individuals donate to the welfare of dogs and animals. I also guess Lynn is well-paid in her role for the Girl Scouts and I doubt they have to take up a collection for her at church as she seems pretty comfortable in Sequoyah Hills. Burchett Appointed To Additional Committees

Congressman Tim Burchett has kept his place on the House Committees on Transportation & Infrastructure and on Foreign Affairs, but has also been assigned to the House Committee on Oversight and Accountability.

The bill would make TVA's decision making more transparent to the public. The bill requires the TVA Board of Directors meetings to be held in public and contains a provision requiring TVA to "provide public notice of no fewer than 6 calendar days" before any meetings. The bill sponsored by congressmen Burchett and Cohen also requires TVA to make the minutes of those meetings, along with summaries, accessible to the public.

"The TVA has recently been working to improve its transparency, and I was proud to introduce this bill last year to ensure those efforts continued," Burchett said in a statement released by his office. "TVA transparency is no less important this year than it was last year, so I'm happy to bring this bill back to the House as part of our efforts to improve transparency across the board."

Pace Surfaces

Last week a good-sized crowd attended the Three Rivers Republican Club, which is a combination of the 8th & 9th Commission Districts. For the first time, at least as far as I know, Randy Pace, the former chairman of Knox County's Republican Party, showed up. Pace, well known for his ability to talk a stump to death, was more subdued and had little to say. Nor did Pace receive an especially warm welcome.



For customers looking to upgrade their bathrooms, a local company is willing to help.

Knoxville Tub To Shower Conversions was founded two years ago on the premise of providing a better product for a better price, in a niche market dominated by regional companies selling cheap acrylic products for exorbitant prices.

"For tub to shower conversions we have simplified the design process to three simple steps," said sales manager John Baucom. "Choose a base, then choose the wall panels and then the plumbing options.

"The presentation takes about an hour, because we have 28 different wall panel styles, the 100% waterproof panels look and feel like real tile and stone with

indented faux grout lines and aluminum edge trim."

The inaugural step in the process is selecting a low-profile curb shower base-the low-profile base is important to bathroom safety. Choosing shower walls is next and the final step is picking plumbing options so the shower is plumbed to meet your individual needs.

The company, which has been in existence for two years, has yet to open a showroom location, however, one is coming in the near future.

"The one thing that we want people to know is that we are a local company and we believe that supporting local business ends in a higher customer satisfaction rate.

He noted that 30-40 percent of residential bathrooms in Europe are constructed with Fibo panels. The product was introduced to the U.S. market in 1977.

Ridgecrest development decision postponed until May

John Bolton's drive from Evansville, Indiana, apparently ended with a surprise in Knoxville where he learned many people on Ridgeview Road were opposed to him building two homes per acre on property he owns in Knox County. That's what he said last week at a zoning meeting.

Bolton, who said his family has owned the land since 1984, appeared before the zoning session of the Knox County Commission. Although the planning commission voted for a density of one house per acre on four lots, Bolton's request, to change the zoning from Agricultural to Planned Residential, calls for two houses on each acre.

Bolton said that meeting with neighbors about the rezoning request has been difficult because of his Indiana residence. He said he sent ten letters to neighbors. Ridgeview Road runs northwest off Tazewell Pike in North Knox County.



A friend observed how gloomy the weather has been lately with overcast skies and "southern cold." I know what she means. I no longer ski, but I remember riding lifts to 12,000 feet in the Rocky Mountains and schussing down snowy glades. And yet the cold was not as penetrating as it seems to be in Knoxville. The low humidity of western climes must be the reason. Our southern higher humidity transmits cold more readily to the bones. Brrr!

Years ago Becky and I came to a marital agreement. I am more coldnatured than she is, and I get cold in late October and often don't warm up until April. Through negotiation, she agreed to allow our dual-controlled electric blanket to go on the bed

My feet would be a block of ice without socks, and I doubt I'd survive winter nights without an electric blanket. I thought about mountain winter snow as I watched World Economic Forum (WEF) elites traipse around Davos during their yearly pilgrimage to the Swiss Alps. These preening climate hypocrites arrived on more than a thousand private jets to hobnob while sipping wine and nibbling caviar canapés and then lecture the rest of us about global warming...er climate change. I object to John Kerry and Al Gore types who will never have to sit in the dark or be cold to

The second book is "Irresistible" by Andy Stanley. This Christian apologetic is very readable and has been impactful to me. Stanley presents two important concepts. The first is that Jesus ushered in the New Covenant and therefore his followers are not bound by Old Testament regulations.

Nonetheless, Jesus said he abolish it (Matthew 5:17).

Stanley then offers cal and horizontal axes to describe our relationship with God (vertical) and with each other (horizontal). 

at Tennessee Code Annotated section 36-5-121. Even if you read that law, you will still have no idea how much alimony is going to be awarded.

What I tell people is that there is no formula for how long alimony is awarded for or for what amount, but here are some general guidelines as to whether alimony is on the table for discussion and the length for which it may be awarded:

1. Alimony is typically not going to be awarded if you have been married less than seven years

2. Except in extremely long-term legal issue and other legal issues.

One of the questions that I often navi- marriages (30 years or more), alimony is typically only awarded for one-third the length of the marriage, at most

3. Is there a significant difference in the income of the parties? If the parties make the same amount of money, or close to it, alimony is not typically going to be awarded

As to the amount, Tennessee law states that the two primary considerations in determining the amount of alimony awarded are: the need for alimony by the person requesting it and the ability to pay alimony by the person from whom it is being requested.

How do we determine what is needed? A monthly budget is put together for the person requesting it to see how short they are on their monthly bills. Their monthly deficit is their need for the purpose of requesting alimony. Will that person always get the amount of their deficit? No, of course not but that is the starting point for what the amount of their monthly alimony request will be.

Pages from the Past

No Republican had represented West Tennessee since Congress in Reconstruction yet Dan Kuykendall was making a spirited challenge to incumbent George W. Grider to represent Memphis in the House of Representatives. Kuykendall, a native of Texas whose family had left Tennessee to follow Sam Houston to the Lone Star State, had come to Memphis for work with Proctor & Gamble. Later Kuykendall said "on a whim" he had begun volunteering to work in campaigns for Republican candidates. Dan Kuykendall had worked on behalf of GOP presidential nominee Richard Nixon in 1960 and had been the campaign manager for Republican Bob James who ran against Congressman Clifford Davis in 1962. James had shocked not only Congressman Davis but the entire political establishment when he came within 1,200 votes of upsetting the veteran representative who was the last vestige of the old Crump machine.

Memphis and Shelby County had once been the political domain of E. H. Crump, but when the Boss died in 1954, his machine began to disintegrate. Many of those who had backed Crump and his machine began drifting away from the Democratic Party. Even Crump had bolted it in 1948, refusing to support President Harry Truman, preferring instead States' Rights candidate Strom Thurmond. Shelby County gave 26,396 votes to Thurmond, 23,854 to Truman, and 14,566 to Republican Thomas E. Dewey. Crump had lived long enough to see Tennessee vote for Dwight D. Eisenhower and Richard Nixon in 1952, albeit quite narrowly; even in Shelby County the Democratic presidential candidate Adlai Stevenson won 71,779 votes to 65,170 for Eisenhower. Eisenhower once again carried Tennessee in 1956 with Tennessean Estes Kefauver running as the vice presidential candidate with Stevenson. Richard Nixon won the Volunteer State decisively in 1960 over John F. Kennedy. Lyndon Johnson became the first Democrat to carry Tennessee since Harry Truman in 1948. While Tennessee had boasted the occasional Republican governor, the Volunteer State had never voted to elect a GOP candidate to the United States Senate since popular election had chosen the state's senators. Only twice had Tennessee Republicans really offered serious candidates for the U.S. Senate. The first instance occurred

with the first popular election in 1916 when former Governor Ben W. Hooper Congressman faced Kenneth D. McKellar. Hooper's 45% of the vote remained the high mark for a GOP candidate for the United States Senate until 1964. The second effort by Republicans to win a seat in the Senate had occurred in 1948 when former GOP National Chairman and congressman Carroll Reece thought it would be a banner year for his party. Virtually everyone but Harry Truman believed Tom Dewey would be elected president and the Republicans would sweep Congress. Reece was the GOP candidate for the U.S. Senate while country music legend Roy Acuff was the Republican nominee for governor. Reece and Acuff drew tremendous crowds, which frightened the Democrats but the GOP ticket won only a third of the ballots cast in the general election.

With both of Tennessee's seats in the Senate up for election in 1964, Howard Baker and Dan Kuykendall won more votes than ever before received by GOP candidates for the U.S. Senate. Baker was running for the Senate once again in 1966 while Dan Kuykendall was the GOP nominee for Congress against freshman George W. Grider.

Lyndon Johnson had won to downplay inflation, which the election in 1964 in a was an issue with many landslide against GOP can- American households and, didate Barry Goldwater. Numerous Republican incumbents had been swept out of office that year. The success of LBJ and the Democrats was beginning to tarnish, especially with inflation beginning to seriously affect Americans' cost of living. GOP candidates across the country were pounding the hell out of the Johnson administration and Democratic incumbents over inflation. The GOP candidates in Tennessee were no different. Howard Baker hammered the Johnson administration, although his opponent in the general election, Governor Frank Clement, had not been in Congress to support LBJ's agenda. Dan Kuykendall enthusiastically campaigned against the Johnson administration and labeled Congressman George W. Grider as a rubber stamp for the president.

snapped, "I'm not going to bail out the Great Society with a tax increase." Congressman Grider, while saying he didn't think a tax increase was necessary, stated he would vote for it if all else failed. Then as now, Democrats argued wages were running ahead of prices. Democrats insisted a smaller percentage of the average family's budget was spent on food than at any time previously.

The race for Congress from Tennessee's Ninth District overshadowed every other race on the ballot in Shelby County in the general election. The Memphis Commercial Appeal labeled the congressional race as "the hottest contest on the November ballot." Congressman Grider and Dan Kuykendall differed on virtually every significant issue facing the people of Shelby County at the time. Basically, it could be boiled down to a single issue: Grider's support for the administration of President Lyndon Johnson and Dan Kuykendall's Democrat, Congressman opposition to the "Great Society." Grider attempted not surprisingly, a real concern to many housewives who managed family budgets. Congressman Grider acknowledged inflation was "annoying", but dismissed it as a major problem for Americans. Kuykendall pointed to the Johnson administration's free spending on the domestic front while financing the war in Vietnam. Kuykendall said the spending policies of the Johnson administration had caused a decline in the purchasing power of families. Grider had cause for concern when some Democrats openly defected to support Dan Kuykendall. Former Judge Beverly Boushe was the nominal head of "Democrats for Kuykendall." Two former state senators, J. Weldon Burrow and Harry Scruggs, endorsed Kuykendall for Congress, as did former state Representative John Maxwell. Boushe claimed to never have supported a Republican candidate before but said he was supporting Dan Kuykendall "because I think it my duty to do whatever I can to stop this downhill rush to centralized government and socialism." "I hope other Democrats who feel as I do won't be afraid to stand

up and be counted," Judge Boushe added.

The Nashville Tennessean, the state's vociferously most Democratic newspaper, accused Kuykendall, "the Goldwater image in 1964," of attempting "to whip up a white backlash" and "whatever else against U.S. Rep. George Grider, who has built an image of serving Memphis' best interests." The Tennessean claimed GOP hopes of electing Kuykendall had once run high but had diminished over time.

The Memphis Press-Scimitar declared one statement made by Dan Kuykendall its "quote of the week" in the middle of October. Both Kuykendall and George Grider had served in the Second World War; Kuykendall had been a pilot while Grider had commanded a submarine. "I'm not a military expert," Kuykendall said. "The airplane I flew in World War II is out of date. And I believe my opponent's submarine is out of date too. So I don't forty-two-year-old Dan think he is a military expert Kuykendall heralded his Election Day in Tennessee either."

On October 23, 1966, the **Commercial Appeal issued** its endorsements for West Tennessee congressional races. The endorsement of Robert "Fats" Everett could have surprised exactly nobody. The Commercial Appeal endorsed Governor Frank Clement for the United States Senate over Howard Baker. In the race for the Ninth Congressional District, the Commercial Appeal endorsed incumbent George Grider. The editorial stated the election of Kuykendall "would mean lost time and doubtful outcome as the new man feels his way in unfamiliar territory." "I want to be remembered when I die that I was a member of the Education Congress, the 89th Congress," George Grider said. The congressman praised the Johnson administration's anti-poverty initiatives and claimed Congress was heading towards its goal of "breaking the hereditary cycle of poverty." Congressman Grider sounded confident as Election Day approached. "I'm going back up there (to Washington) next year to continue these programs." On October 27, 1966, the Memphis Press-Scimitar endorsed the congressional candidacy of Dan Kuykendall. While the Press-Scimitar

readily admitted George W. Grider was an honest and honorable man, as a congressman the newspaper concluded his record was "hurting this community and the rest of the nation." The editorial went on to make the case against Grider, as well as a case for electing Dan Kuykendall. The Press-Scimitar openly disliked "the national Democratic Establishment's philosophy, which has spawned an ever-growing, ever more powerful federal bureaucracy" which cheerfully ignored the increasing national debt.

That same day Gerald Minority Ford. the Leader in the House of Representatives, came to Memphis to campaign for both Dan Kuykendall and Julius Hurst.

The last week of the campaign was hectic for both candidates. The fifty-three-year-old congressman reiterated his support for the Great Society and President Johnson. The Department of Defense.

Kuykendall's picture was liberally plastered all over the Ninth Congressional District and many people who had never met the GOP congressional candidate nonetheless called him "Dan." One fellow asked, "How's it going, Dan?"

"Well, we think we're going to make it this time," Kuykendall replied. "I'll tell you, I'm tired of coming in second. I've decided moral victories are immoral." The Republican candidate concentrated on personally meeting voters during the last week of the election, meeting and shaking hands with approximately 1,200 people daily. Kuykendall said of Congressman George Grider, "My opponent believes in what he's doing, he's fighting for what he believes in and for his political life. Should I lose, I would thank my people and wish him well, and hope he will have the same feeling toward me if he loses. I know he is sincere, and I consider him a gentleman."

November 8, 1966, was support for free enterprise, and around the country. At law and order and fiscal a time when there was no early voting, voting by mail or the like, voters trooped to the polls to cast their ballots. Most observers had thought the race between Congressman George W. Grider and challenger Dan Kuykendall would be close and it was. 1966 proved to be a very good year for Republicans across the nation and Tennessee was no exception. Dan Kuykendall led in the returns and the faces at the Grider headquarters reflected dismay and worry. Dr. Tom Stern, a strong supporter of Congressman Grider, tried to reassure his friends. "These are all strong Republican precincts in East Memphis." Dan Kuykendall bested George Grider with 47,489 votes to 43,553. Grider had only picked up 1,383 votes from his total in the primary election. Kuykendall had picked up 40,933 votes in the general election. At 10:30 p.m. Congressman Grider climbed atop a table and the old submarine commander said, "Every time we sink we always surface later." Dan Kuykendall had just become the first Republican ever to be elected to Congress from West Tennessee since Reconstruction.

Grider had some reason to be confident; he had received more than 42,000 votes in the August Democratic primary while Kuykendall had gotten a paltry 6,500 in the GOP primary.

As the possibility of a tax increase was considered by the Johnson administration, Dan Kuykendall restraint.

"When a man says he's going to do a job and then he goes to Washington and does it, I think the people will agree to give him a second term," Congressman Grider opined the day before the election. Grider saw little or no difference between the campaigns of Bob James and Dan Kuykendall; the congressman described both Republicans as "Goldwater obstructionists." Grider thought Kuykendall's campaign was motivated by the same "negativism and fear of the Federal Government" which had been the primary issue championed by Barry Goldwater in the 1964 presidential race. While campaigning, Grider ran into a woman who, as it turned out, informed the congressman she was from California. Grider asked who her congressman was and the lady replied she couldn't remember, but said he was a Republican. "No wonder you can't remember," Grider replied. "He's probably never done anything."

Another woman "haughtily refused to accept" the congressman's campaign brochure but immediately engaged Grider in a conversation to seek his help in obtaining her husband's war record from the





When John Brady was coaching hoops at LSU, he once spent a great deal of time post-game arguing with a writer from Tiger Rag about something written in the publication that didn't meet Brady's exacting standards. Never mind about the game. The game just played was secondary to whatever they were

arguing about.

Arkansas in nearly reverential tones. A long and glorious relationship seemed in the offing.


