# **Real Time Information** Center approved by **City Council**

Adding \$1.02 million to the new Public Safety Center project to house a Real Time Information Center passed in a 7-2 vote at the Knoxville City Council meeting Tuesday evening. That brings the current estimated total of remodeling the former St. Mary's Hospital just as is not part of the \$1.02 off North Broadway to \$53.43 million.

The addition and creation of the Real Time Center, which would be used to view and collect images from cameras around Knoxville, would be similar to observation cameras already in place in New Orleans, Chattanooga and elsewhere. The police department estimates the facility would have three certified professionals, two operators and five other employees.

Chief Paul Noel estimated the cost of cameras, to be placed at selected sites with high crime

each but Councilwoman Lauren Rider said quality cameras could cost more than \$15,000 each. Councilwoman Gwen McKenzie said that if the city is putting money into the safety of the community, high-resolution cameras should be purchased.

# Isn't it time to fire incompetent bank regulators?

The failure of Silicon Valley Bank sparked a mini-panic in financial markets. The word "contagion" was tossed around as if the banking system were replete with other

banks in similar straits as SVB. There was even an old-fashioned bank run at SVB and some other banks resulting in the failure of Barney Frank's Signature Bank. You may recall that Frank was a cosponsor of the Dodd-Frank Act which was supposed to lessen bank failure.

I presume the run was from depositors who held more that the federally insured \$250,000 since 94% of SVB's deposits were over the insured amount. Those depositors would only be able to access \$250,000 and

> This will inspire continued recklessness by some bankers to conduct unsafe and unsound banking practices. Moreover, the bailout was for depositors who likely did not need to be rescued. The SVB episode is a prime example of incompetence at all levels. The banking executives, the California state banking regulator and the Federal Reserve Bank of San Francisco were all complicit and all should be fired.

To recount. SVB was heavily involved in the tech industry, startups and venture capital. It expanded its loan portfolio rapidly taking

That SVB grew so rapidly should have been a warning sign to its regulators. Too rapid growth is a fundamental warning sign and was apparently ignored by the regulators. Another warning sign that the bank was in trouble was its borrowing of \$15 billion from the Federal Home Loan Bank system. SVB's management was incompetent and obviously did not learn its lesson from the S and L failures of the 1980s.

> The S&Ls failed because they had short-term liabilities (deposits) and longterm assets (mortgages). When interest rates rose, the cost of their liabilities rose while the return on their assets stayed the same, eventually resulting in insolvency. The same thing happened with SVB. They took their deposits and either loaned them out

They then were doubly exposed by the downturn in the tech industry and the Fed's raising of interest rates. The downturn in tech brought about defaults on SVB's loans and the rise in interest rates meant that SVB's bond portfolio lost value. As a result, SVB started borrowing liquidity from the Federal Home Loan Bank system. Surely, the regulators had to have been aware of the borrowing and should have moved to examine the bank. Since SVB was a state-chartered bank, the primary responsibility for examining the bank for safety and soundness lies with California's Department of Financial Protection and Innovation. The state regulator did not act until it took possession of SVB citing inadequate liquidity and insolvency and turned the bank over

The regional Fed banks have the responsibility for supervising and examining the Fed member banks in their districts and the San Francisco Fed failed to heed the warning signs from SVB and shares the responsibility of this debacle. Mary Daly has long been recognized as one of the least able of all Fed bank presito the FDIC to dispose of its dents. She does not have

a background in bank regand has not made these an important part of her tenure at the head of the reserve bank. In fact, she was once a "labor inequity researcher" - whatever that is - at the San Francisco Fed and said that the Marxist economist Gene Wagner "has mentored me my whole life."

It is time for the Fed to reexamine the role of the regional banks and emphasize safety and soundness. It is also time for the Fed to insist that its regional presidents have training and background in these areas. The stability of the banking system is too important to be left in the hands of amateurs and the incompetent. Both the heads of the California regulator and the Federal Reserve Bank of San Francisco bear responsibility and both should be fired.

## Districts Should Be Districts, At-Large Should Be At-Large

It is an interesting thing to see the Left in Knox County defend the last relic of segregation in our community. I am referring to the system of voting inside the City of Knoxville for the supposed "districts." The Knoxville City Council is comprised of nine seats: three elected at-large, meaning citywide, and six from districts. The present law requires candidates to run in the primary, which is restricted to the confines of a district. The general election is then run citywide. In an article last week, the Knoxville News Sentinel sought an opinion from professor Eitan Hersh from Tufts University about Knoxville district to citywide voting. "Racial discrimination issues aside, I can imagine for any city where policy differences differ by district, this system simply grants the overall city majority an outsized power relative to a district system," Hersh replied. Neither Hersh nor another professor asked for a quote had ever heard of a city holding elections as does Knoxville.

Although the Sentinel clearly has a different opinion, to its credit the daily newspaper did quote former elections administrator Cliff Rodgers as saying, "What business do I have in deciding who represents another disthis place and how it was set up."

I've said it before and I am saying it again; take out articles about race and food and the daily newspaper would be as blank as a ream of copy paper.

What did surprise me was the Sentinel's acknowledgment of the fact that the existing method of electing our city councilmen is one of the last relics of segregation as - - - and these are the words from the News Sentinel - - - it "allows a 'white veto' of Black candidates. . ." The daily newspaper says it has rarely worked out that way. The system seems designed, at least originally, to prevent the election of a Black candidate by forcing that candidate to run citywide rather than in what was then a majority Black district. While the district is still predominantly a minority district, it is no longer a Black majority district. Much as the woke writers at the News Sentinel might wish otherwise, there is no guarantee a Black candidate will win either the primary or general elections under the present system. Each time a Black and White candidate has faced off for the seat, there has been grumbling about changing the law should the Black candidate lose. Frankly, we've moved past this conversation everywhere but in the pages of the Knoxville News Sentinel. Amelia Parker defeated two White candidates to win an atlarge seat on the City Council, one a Republican and the other a Democrat. Still, I can only imagine what the dialogue will be like the first time a White candidate runs citywide and ends up was acknowledged by Bill Lyons pontificating his own

The truth is the winner of any election is the candidate who gets the most votes. Unfortunately, the City of Knoxville government is loath to repair, much less fix its own defects. That is why the legislation pending in Nashville would restore the ability of districts to pick their own representatives. Electing every city council member citywide dilutes the responsiveness of representatives who, in name only, represent a district. One can easily ignore a neighborhood knowing he/she can find votes elsewhere in the city wards. The current system also puts neighborhoods and homeowners' associations at a disadvantage, and it aids the special interests who finance city campaigns. Obviously, it costs less to finance a district race than a citywide race. One can also easily argue the current system has depressed the vote and the voting patterns in the city, running in off-year elections has consistently spiraled downward. Property Tax Increases Not Good For Renters Or Homeowners

Average rental prices are up in Tennessee by 12% over last year and up 35% since 2020. That's according to Rent, an apartment search engine. Tennessee is one of 13 states that saw rents increase by double digits. Tennessee is ranked ninth in the nation for the largest rent increases. The median rent price in Tennessee is \$1,605 according to Rent. The median rent in Nashville is \$2,117. The median rental price in Tennessee in 2020 was \$1,187, which is \$418 less than it is presently.

Both Nashville and Knoxville raised property taxes substantially. Davidson County property taxes went up 35% and Knoxville's went up 40%. ## **Biologicals**

Recently I told my wife, Becky, "I am no longer employable." My regular readers know I am now retired from medical practice. In fact, I decided to let my medical license expire on my birthday this May because paying to renew the license, as well as Tennessee's tax on professionals, was foolish. Actually, the decision was more psychological than monetary. I worked hard to become an MD and for the license that has been in effect for 48 years.

In Ecclesiastes, the Teacher said, "There is a time for everything and a season for every activity under the heavens." There is a huge difference between being responsible for someone's medical care, versus explaining medical issues or medical jargon to friends and

a privilege to be someone's doctor, but that demands you stay on top of your game.

I still routinely peruse three medical journals. However, the complexity of evolving medical science and my age convinced me it was time to step down down.

I've advised many people that you should not retire without a plan. You can only play so much golf, garden, help with grandkids or travel. Humans need purpose which the French call raison d'être (reason for being). I believe our ultimate purpose is a relationship with God. The 17th-century scientist/ theologian Blaise Pascal said we have a God-shaped vacuum in our hearts that only God can fill. So, I seek Him every day. And fortunately, I also have an avocation as a writer. It is a creative enterprise and

of medicine.

Medical science is a blessing, but the potions and pharmaceuticals hawked on TV are a pain. People have asked me if I was ever persuaded to prescribe a drug because of a commercial. In my four and half decades of medical practice, I can't remember a single instance of a patient asking me to prescribe drug X because of an advertisement. Maybe they sensed I would not be receptive. However, advertisements prompted this week's column.

It's been eight years since I wrote about "biologicals." In fact, it was so long ago that I had forgotten I once wrote about this arcane aspect of medical before I was told to sit science. So, if you have an eidetic memory and recall my discussions of monoclonal antibodies (moAb) you can skip this week's column. However, the "back to the issues crowd" should be happy the Doctor is focused on medicine this week rather than his other interests.

> Biologicals, biologics or biopharmaceuticals are "complex molecules produced through biotechnology in microorganisms, plant and animal cells." These agents may be used in diagnostic testing, prevention of disease or treatment.

Medical terms can be less constrained than the confusing, especially the body operates by proteins

complexities and demands names of drugs. Often a medication's generic name derives from its chemical class. Examples are penicillin, ampicillin, etc. which end in the suffix -lin.

> Brand names of drugs are often influenced by marketing considerations. An example is Antivert, the brand name of meclizine, a drug used to combat vertigo (anti-vertigo). Sometimes a drug is remarketed with a different name. An example is dextropropoxyphene which was originally marketed as the anti-anxiety drug Novrad. Hadn't heard of it? Well, it turns out Novrad was woefully inferior to Valium (diazepam), but had some analgesic properties. So, Eli Lilly reversed the drug's name and remarketed it as Darvon, an analgesic medication.

You may have noticed ads for medications whose names all end in the suffix, -mab, which indicates a monoclonal antibody class. There are currently dozens of monoclonal antibody drugs approved for treatment and more are on the way. Examples are adalimumab (Humira) for inflammatory conditions like rheumatoid arthritis, and trastuzumab (Herceptin) for breast cancer. Monoclonal antibody pharmaceuticals are "designer drugs," some of which are designed to even treat high cholesterol, asthma and migraines.

Virtually everything in the

binding to receptors to produce or suppress a function. Think of electrical outlets and the plug on a lamp cord. If you insert the plug into the wall outlet, electricity flows to the lightbulb to produce light. When our kids were small, we covered unused outlets with plastic covers to prevent a youngling from sticking a fork, etc. into the outlet and getting electrocuted. By analogy, monoclonal antibodies are designed to bind to specific receptors, suppressing or stimulating cellular function.

The monoclonal antibody class name derives from its Bragg plans to arrest bioengineering. Injecting mice or other experimental animals with the protein of a microbe, cancer cell or a target cell's receptor generates an immune response. This produces specialized white blood cells which generate antibodies, and a host of other white cells which aid in eliminating the foreign agent and remembering the invader in case the foreign protein is encountered again.

The spleen is a large lymph gland-like organ in the left side of the abdomen where memory cells reside. These can be harvested, and here's the scientific magic: the memory cells can be fused with an immortal cell line to produce a "hybridoma." These bioengineered cells are continuously grown in tissue culture and produce

the specified antibody. These antibodies are then harvested and purified for therapeutic use or testing. It's almost like Star Trek!

God's creation is truly majestic, even if His highest creation, mankind, is sometimes less than noble. As I finish this essay, Alvin Bragg, the odious Democrat and Manhattan District Attorney, is moving to indict President Trump on a bogus case of salacious "he said/she said." If this travesty goes forward, Bragg will effectively be interfering in a presidential election. Furthermore, President Trump which might expose him to the danger of a Jack Ruby-like attack.

I don't know what will happen in Gotham. I am fearful for President Trump's safety and for my country. Desperate people do desperate things. And Democrats are terrified by Trump. 
Chickamauga Cherokee Chief Doublehead and Chief John Watts led 1,000 warriors to avenge the death of Doublehead's brother in an attack on the territorial capital in what is now Knoxville. As they approached the little town the frontier militia there fired a cannon, part of their daily drill, and the warriors turned around and went to Cavett Station, 13 miles to the west. Alexander Cavett had settled there on 640 acres and built a fortified cabin or blockhouse in 1793. His family took shelter inside and prepared for the attack. Cont. from page 1 to the cabin to speak with the settlers. He told them that if they surrendered they would be spared and taken captive.

The whites left the cabin and stood in the clearing when Chief Doublehead rushed them and killed all except a small baby. Chief Watts picked up the child and was holding it when Doublehead grabbed it and bashed the baby to death on a tree.

The warriors went off

after setting fire to the cabin. The militia, seeing the smoke, went to the cabin and discovered the bodies. The Chickamauga Cherokee retreated back to their home base near what is now Chattanooga.

Many tribe members nicknamed Doublehead "Baby Killer" following the incident. Doublehead lived several years after peace was declared, illegally sold some land to whites, and was assassinated by his own tribe.

Settlers killed in the massacre were buried in a cemetery created nearby and later a church was located there and burials continued


Hull Crump on October the senator was seventy-16, 1954, changed Shelby County and Memphis politics forever. As Memphis was on the cusp of the first mayoral election without the influence of E. H. Crump in half a century, the contenders appeared to be set for the general election. Mayor Frank Tobey had assumed office after his predecessor had angrily resigned from the mayoralty. Tobey was set to face that same predecessor, Watkins Overton, in the November election. Neither man would have been prominent in local politics without some affiliation with the late Memphis Boss. Both had come to the office with the assent and approval of E. H. Crump.

Throughout history, there are constant reminders man does not control time nor the march of events. On September 11, 1955, the race for mayor between Frank Tobey and Watkins Overton ended. Mayor Tobey was at home when he suffered a heart attack. The mayor was rushed to Baptist Hospital in Memphis where he slipped into a coma and died three days later. The Tobey administration was thrown into chaos with the death of its leader. The city commission was tasked choice available by calling back to service yet another former mayor, Walter Chandler. Chandler was one of the most distinguished citizens of Memphis. Like both Watkins Overton and Frank Tobey, Walter Chandler had been promoted by E. H. Crump. Chandler was Crump's personal choice to take his place in the U.S. House of Representatives in 1934 when the Boss decided to come home to Memphis. Chandler worked hard at being the congressman from Shelby County and enjoyed his job. Congressman Chandler did not much want to leave Washington, D.C. when the Memphis Boss summoned him to take the place of Mayor Watkins Overton who had resigned in 1939. Chandler assumed office as mayor and served loyally and effectively until 1947 when he, too, resigned. Chandler's resignation was due to profound disappointment. Walter Chandler had hoped to move up the political ladder; he had previously announced his candidacy for the Democratic nomination for governor in 1938 but withdrew when it became readily apparent United States Senator Kenneth McKellar was lukewarm to his candidacy. Chandler had thought and expected McKellar

The death of Edward to retire in 1946 when seven years old. Mayor Chandler believed he would have Crump's support for McKellar's seat in the United States Senate. McKellar had no intention of retiring and his friend and political partner E. H. Crump supported the senator's reelection bid. Chandler decided to leave political life and resume the practice of law.

Much to Crump's surprise, Senator Stewart insisted upon running once again and ran hard. When it became quite clear Mitchell's candidacy was going nowhere, Crump thought of switching his support back to Senator Stewart in an effort to stop the hated Kefauver. The Kefauver campaign caught wind of the rumors about Crump dumping Mitchell in favor of the senator and publicly accused the Memphis Boss of proposing to do exactly that. As they hoped, Crump promptly issued an angry denial and stuck with Judge John Mitchell who ran a poor third in the election. Estes Kefauver won the Democratic nomination for the United States Senate with 42% of the vote. The 1948 election saw Crump seriously challenged inside his own dominion of Shelby County. Orgill said he would do his best to implement a "Little Hatch Act" for Memphis. Edmund Orgill's proposals were a far cry from the previous administrations dominated by E. H. Crump. The day after Orgill's announcement, Edward J. Meeman published an editorial endorsing the new mayoral candidate. Meeman wrote Edmund Orgill was offering Memphians a "Program of Progress" for the future of their city. In his announcement, Orgill had urged those who wanted to help to telephone him. He gave his number at Orgill Brothers, which Meeman praised as "getting right down to business." Unlike a contest between Frank Tobey and Watkins Overton, both of whom had ties to the late Ed Crump, Edmund Orgill had come to notice by defying the Memphis Boss by supporting candidates opposed by the machine. ferent visions for the future of Memphis. Both campaigns did not lack money, but there were constant reminders of past associations throughout the campaign, especially those of former mayor Watkins Overton.

Kenneth D. McKellar, Tennessee's longest-serving United States senator, was living in retirement in a suite of rooms at the Gayoso Hotel in downtown Memphis after having been defeated in 1952. McKellar and Watkins Overton had worked together for the betterment of Memphis for decades and were personal friends. The former senator's nephew Judson was was supporting his friend Watkins Overton. McKellar wrote in a letter to Overton, "This note is merely to say I will support and vote for you in the upcoming municipal election and with real pleasure and satisfaction." Overton had begun practicing law as an associate with the law firm where McKellar was the senior partner, a fact the former senator noted in his letter. "I can never forget that day in the long ago, when you came into our law office to begin there your professional life. You were one of the most conscientious, able, modest, delightful and attractive youngsters in Memphis." McKellar recalled both of Overton's wealthy grandfathers, Colonel John Overton and Napoleon Hill, were clients of the senator's law firm as well as "two of the best citizens Memphis ever had." McKellar warmly recalled Watkins Overton's administration as mayor and closed his letter by writing, "If you were a member of my family, I could not think more of you. I am very proud of you and your former record as mayor, and wish you every success."

"A man's got no business resigning and quitting in a huff and going home," when meeting opposition by commissioner, Chandler said. That was a direct blow to Watkins Overton, but Walter Chandler also pointed out the primary defect of the city managercouncil form of government preferred by Edmund Orgill.

"The fact is, the manager is at the mercy of the council . . . Sooner or later you have log rolling." That was supposedly the very evil the commission government was supposed to prevent. "The manager is answerable only to the council," Chandler pointed out, "and you'll find some cities that have it that are very anxious to get rid of it."

Walter Chandler favored neither type of government advocated by Watkins Overton or Edmund Orgill. Chandler liked the mayorcity commission type of government best.

With a very late start, the Orgill campaign hurried to organize itself. George W. Grider became manager of the Orgill for Mayor campaign. Grider was a Navy veteran, a former submarine commander and a local attorney who would later serve on the Shelby County Commission, as well as a term in Congress.

When Overton ment on the people of this complained Orgill was slinging mud, the Press-Scimitar retorted, "If Orgill comes up with a shovel full of 'mud,' that's Overton's fault. It's his record. Not Orgill's." In the end, Edmund Orgill won a smashing victory over Watkins Overton. Memphis preferred to look to the future rather than return to the past. Edmund Orgill quite nearly won the Democratic nomination for governor in 1958. Orgill remained prominent in the business and political life of Memphis until his death in 1982. Watkins Overton died in 1958 from throat cancer, leaving behind his third wife and two small children, including a four-month-old son.

Overton and Orgill had crossed rhetorical swords before. Edmund Orgill, Lucius Burch and Edward J. Meeman had joined city and county managecity."

The members of CRC had intended to support Frank Tobey for mayor in the 1955 mayoral campaign, especially as it became more likely Watkins Overton would run. While Overton was a veteran politician, Edmund Orgill was no stranger to politics. Orgill had been prominently involved in campaigns in the 1948, 1952, and 1954 election cycles. In January of 1955, Orgill had traveled to Washington, D. C. where he hosted a luncheon for the members of Tennessee's Democratic members of the House Representatives. of According to Congressman Percy Priest of Nashville, Orgill had wished to discuss possible legislation pertaining to the expansion of the North Atlantic Treaty.

Ed Meeman's Press-Scimitar avidly promoted Edmund Orgill's mayoral candidacy throughout the remainder of the campaign, while the Commercial Appeal sided with former mayor Watkins Overton.




