## Business parking lot regulations eyed by city council

A proposal to give smaller businesses a break in landscaping and parking lot restrictions created many questions during Tuesday's city council meeting. Although Scenic Knoxville supported lifting some restrictions, the first reading of the ordinance passed 8-0 with one member abstaining.

Scenic Knoxville's Joyce Feld called the proposed ordinance a step forward and she said Scenic Knoxville is "willing to work for a compromise" in order to encourage reuse of existing properties and allow for different businesses to exist at pre-existing locations.

Councilwoman Lauren Rider said that businesses looking to relocate often can't afford the changes in their parking lot currently required by the city depending on the type of business In order to meet city regulations possible new owners resist required curb cuts, closing of an entranceway, or making other changes.

The idea is to drop many of those requirements, possibly including new landscaping.

Mayor Indya Kincannon said the city wants "a walkable community but not place a burden on smaller property owners." Vice Mayor Andrew Roberto said he'd support the first reading but asked, "Is there a different way to approach this?"

Peter Ahrens, Director of Plans Review and Inspections, answered Councilwoman Amelia Parker's question about if lowering parking lot regu-

# Knoxville multi-purpose stadium breaks ground, begins full construction phase

Construction is officially underway following a groundbreaking ceremony for the \$114 million multi-purpose stadium that will bring baseball back to East Knoxville after 25 years.

Community leaders gathered June 13 at the stadium site on the edge of the Old City for a short program with speakers that included City of Knoxville Mayor Indya Kincannon; Knox County Mayor Glenn Jacobs; Dr. Charles Lomax, president and CEO of Knoxville Area Urban League; Rev. Reneé Kesler, president of Beck Cultural Exchange Center; and Randy Boyd, owner of Boyd Sports.

The stadium project reflects the combined efforts of the City of Knoxville;



lations for smaller businesses would lead to lower quality property development.

"I don't think so," he said, adding that some lot regulations will still exist and called the proposal "the best of both worlds."

Councilman Lynne Fugate warned the council to "Don't let 'perfect' be the enemy of better" when considering lot requirements.

Changing the parking lot regulations now goes to the June 27 regular meeting.

In other business, Councilman Charles Thomas applauded a vote to rezone 91 acres between Callahan Road and Merchant Drive from Agriculture to RN-6 Multi-Family Residential. The Central Avenue Pike development will include single-family homes,

"This venue for professional baseball, soccer, festivals and concerts will greatly enhance the quality of life for Knoxville residents and the experience of visitors to our city," Kincannon said. "Outside the stadium, there will be new public plazas and streets vibrant with new businesses.

Randy and Jenny Boyd represented Boyd Sports at the podium last Tuesday. Boyd Sports, LLC, owned by Randy Boyd, owns or operates the Tennessee Smokies, a Chicago Cubs affiliate in Minor League Baseball, and the Appalachian League's Johnson City Doughboys, Greeneville Flyboys, Kingsport Axmen and Elizabethton River Riders. Remember, this is a space that has been dormant for decades. This public-private investment represents new jobs, East Knoxville redevelopment and gamechanging wealth-building opportunities. The total economic impact of this project will be close to half a billion dollars over 30 years."

Jacobs, like Kincannon, was an early

supporter of the stadium project because of its overall benefit for the city and county.

## AMR rate hike approved by Review Board

A rate increase for Knox County's contracted ambulance service, American Medical Response, was approved by the EMS Medical Services Cost Review Board recently. The five-member board held its second meeting on the requested service rate increase and voted to approve the bump in cost for responses with the matter now going to the Knox County Commission.

The commission forgave fines last year for delayed responses by the company due to the pandemic and voted to open the bidding for any emergency service provider, including AMR, to assume the service in February 2024. The new rates will apparently last through the end of the current contract and then a new rate system would be set.

Knox County Chief Operating Officer Dwight Van de Vate said in an earlier meeting that the Cost Review Board has the "sole authority" to approve call rate charges. AMR asked to increase their basic rates from \$326.20 to \$803.88 and up the "advanced lifesaving service" that includes a paramedic and medical technician from \$755.25 to \$983.57. Special Care Transportation, currently set at \$936.34, will go to \$1,320.90. The transport charge will also increase from \$8.73 to \$15.45 per mile.

AMR's Josh Spencer told the review

board that AMR is currently losing money or is "barely breaking even."

A Request for Proposal is open for a provider and apparently, AMR or another bidder will be selected in September for ambulance service next year.

Members of the EMS Medical Services Cost Review Board include Vice Chair Randal Dabbs MD, FACEP, FAAFP and healthcare representative; Courtney Durrett, Knox County Commission representative; Dottie Lyvers, citizen representative; Brad Phillips, EMS representative; and Chair Rick Valentine, EMS representative.

Does the Review Board have the power to approve the rate increase?

"The authority of the Ambulance Rate

Review Committee is established by the contract. They have exclusive authority and their decisions are final," Van de Vate told The Focus.


"The composition of the committee is also established by the contract, in the sense that there are specific requirements associated with several of the positions.

"Two members are to have expertise in emergency medical services but have no current relationship with the provider under contract; one member is to have expertise in health care finance; one is to be a citizen representative; one is to be a county commissioner.

"The mayor nominates and commission confirms," Van de Vate said.

apartments and townhouses. Thomas said that about 17 acres of the hillside will be set aside for public use with a request for Legacy Parks to become involved. Crescent Bend Development LLC requested the zoning change.

A property along Frank Gardner Lane was rezoned from General Commercial to Office.

The council also voted to shift building inspections to the Public Service Division from Plans and Review. Also approved was the 2024 Capital Improvements Budget. The council approved several housing-related grant requests using city, state and COVID funding to go to the Community Development Corporation, CARES, Community Action Committee, Catholic Charities, Salvation Army, Five Points and the East Tennessee Community Design Center. Three resolutions for acquiring \$15.93 million in state and federal grant money for Knoxville Area Transit were approved with matches from the city.

#### Liberals Won't Answer Questions

Congressman Dan Crenshaw of Texas put Meredithe McNamara, an assistant professor at the Yale School of Medicine, on the spot during a congressional hearing about his bill to withdraw federal funding from some hospitals that provide "surgeries, puberty blockers or cross-sex hormones to transgender minors." Crenshaw posed a question to McNamara that was as simple as it was direct: "You've said that we cherry-picked data. How do

The answer was worthy of Malibu Barbie. "So, it is very unscientific and flawed to pick a single study or a single statistic and discuss it in isolation," McNamara replied. "Medical experts are able to talk about all the evidence as a whole." Crenshaw said he total-

ly agreed with that statement. The Texas congressman went on to quote the British Journal of Medicine, which examined 61 systemic reviews and concluded, "There is great uncertainty about the effects of puberty blockers, cross-sex hormones and surgeries in young people." Crenshaw told Professor McNamara the Journal of the Endocrine Society had reached the very same conclusion, as did the American Academy of Pediatrics. "They all cite the lack of evidence," Crenshaw said. Crenshaw stated, "If you're doing therapy, and it's, you know, temporary, fine, whatever, maybe let's try it and see if it works. But when you're talking about permanent physiological changes, do you not agree, just from an ethical standpoint, that you might want extremely strong evidence of the benefits? There's no systemic review that states there's strong evidence of benefits."

"Sir, are you aware of

how the quality of evidence grading system works and how it's applied," Professor McNamara asked, condescension dripping from her voice.

Congressman Crenshaw assured her that he did, which is why he cited the journals he did. Crenshaw asked McNamara, "Which journal says something different? Tell me a journal that has done systematic reviews that cites different evidence, that cites strong evidence of benefits for these therapies."

The professor, smugly assuming an air of superiority, started with, "The standards of care were developed based on extensive . . ."

Crenshaw interrupted, "You're not telling me any study, don't say 'standards of care." McNamara sat there for a moment and the Texas congressman demanded, "Tell me one."

Malibu Barbie was back. "So, um, the standards of care," the professor said.

"The standards of care," Crenshaw reminded her. "That's not a journal, that's not a study. That's not an organization. That's not an institution. You're just saying words. Name one study."

Malibu Barbie, the assistant professor at Yale Medical School, couldn't cite a single source to support her

contention. Her smug and self-righteous expression had faded a little. She must have been a diversity hire.

Noted for his questions in previous case reviews and knowledge of conflict resolution, Croom was confirmed unanimously by the other PARC members as each was polled.



## Non-profit organizations to receive funding in county budget

The Knox County Budget for the next fiscal year includes \$1.27 million for the Knoxville Chamber of Commerce, the receiver of the largest sum of taxpayer dollars

from the general fund. Receiving \$100,000 each will be the East Tennessee Economic Development Agency and Helen Ross McNabb. The Interfaith Health Clinic gets \$56,000 and the West Knox Farragut Chamber gets \$50,000.

Non-profits receiving more than \$40,000 include Catholic Charities and Childhelp Tennessee. Other groups getting tax dollars from the county include Big Brothers and Sisters, Blount Partnership, CASA, Community Mediation Center,

**Disabled American Veter**ans, East Tennessee Community Design Center, Emerald Youth Foundation, Friends of the Library, Keep Knoxville Beautiful, Knoxville Leadership Foundation, Mental Health Association, Muse Knoxville, and Raising a Voice.

The Hotel/Motel Tax Fund also will contribute funds to non-profits including \$4.2 million to Visit Knoxville. The Arts and Cultural Alliance of Greater Knoxville will receive \$425,000 from the fund and Zoo Knoxville will get \$345,000 for

their capital budget. Other non-profits to get funding include the Beck Cultural Exchange Center, Legacy Parks, Asian Culture Center, Women's Basketball Hall of Fame, and the Zoo Knoxville operating budget.



The Gibbs Drive Historic District in Fountain City is a neighborhood of fifty-two residences that reflect the characteristics of the streetcar and automobile suburb in Knoxville. The district has a linear street pattern, broad sidewalks, spacious facade lawns and sidewalks. Beginning in the era of streetcar suburbs, neighborhood development continued throughout the period when automobile usage and ownership became prolific in Knoxville. The predominant building styles and forms are the bungalow, Craftsman, Minimal Traditional and four squares. Overall, the district is an outstanding example of the early twentieth-century trend away from the elaborate Victorian-era styles, to a more simplified floor plan and appearance.

Homes on Gibbs Drive are mainly one and one-half to two and one-half stories in height. Construction is brick or frame,

Membership in the Gibbs Drive Neighborhood Association is voluntary with nominal annual dues of \$10. According to association by-laws, only members in good standing can vote on issues affecting the street.

The neighborhood officers are made up of two co-chairs, a secretary and a treasurer. Officers meet once per quarter ahead of the quarterly neighborhood meeting.

The primary goal of the neighborhood association is to plan community events to encourage participation and involvement as well as unity among the neighbors, in addition to protecting the interests of preserving the street as a historic district.

In the past, the neighborhood has hosted home tours, candlelight and historic walks as well as the annual celebration of the Dogwood Trails and Christmas light contests. We recently were awarded the City of Knoxville's

a protected historic district through the City of Knoxville's Historic Zoning designation as an H1 Historic neighborhood. This would provide certain protections to maintain the historic integrity and appearance of the homes on the street.

Local representatives are City Councilwoman Lauren Rider and County Commissioner Courtney Durrett. We do interact with them often. Councilwoman Rider has been a part of the effort regarding the historic designation and Commissioner Durrett just lives one street over and regularly walks the street interacting with residents. We have a great relationship with both and are grateful for their support.

We are a small geographical neighborhood and therefore have no particular businesses or parks on the street proper. What is the largest problem facing Knoxville? That's a question The Knoxville Focus asked the five people running for Knoxville Mayor. The replies vary and here are their answers.

Burak Er: Major issues and problems confronting our city today involve fiscal difficulties which affects affordability and increased demand for social services and other city services.

Without affordable housing, families have constrained opportunities to increase earnings, causing slower growth for the city.

Constance Every: Poverty! Forty-seven percent in just the Black Demographic of Knoxville alone; 42% citywide, with the greatest impact coming to the Knoxville Native Community. As people migrate from some of the wealthiest states/cities in the nation move into Knoxville and continue to increase the ever growing cost of living with their buy with cash now payments.

Poverty is the root of our crime, homelessness, and affordability. Knoxville Vision must include a plan that will use the People Checkbook for the greatest benefit of Mass Public good such as high quality transportation to get people to and from jobs, creation of satellite campuses with higher education institutions to increase accessibility to necessary skills/ training for the ever changing workforce/job market, and quality youth enrichment that allows our kids to explore their multifaceted talents just to name a few. safety is job #1, and every- States, our rate was one in Knoxville deserves to be safe. I will continue to support our police officers and firefighters who work 24/7/365 to keep our neighborhoods safe. Keeping Knoxville safe takes community trust and involvement, which is why I created the Office of Community Safety and helped launch Turn Up Knox, a street violence interruption organization.

After Public Safety Knoxville's most urgent issue is housing. We need more housing of all kinds, all across the city, for all types of families. Our affordable rental development fund has invested millions in the creation of new housing. I will continue that effort, and facilitate more home construction by the private sector.

As a side note, according to the U.S. Census Bureau, the poverty rate among Black residents of Knoxville was 39.7% in 2017, and has dropped to 21.3% in 2021, the latest year for which data are available. While 21% is still too high, that is real progress.

By comparison, our white poverty rate was 20.5% in 2017, and dropped slightly to 19.7% in 2021. With increased costs, especially in housing, many people are hurting. But we are making progress.

R. C. Lawhorn: There is not a single largest problem facing Knoxville, there are multiple problems. I do not think you can indicate that one problem is more serious than the others. I will fix the Problems.

Women Shelter/ Homeless: The baseball stadium that the City of Knoxville is building will be a positive tax revenue for the city. The women's shelter and homeless shelter were torn down to make room for the baseball stadium. These facilities need to be rebuilt, by revamping old City proprieties. Battered or homeless women have nowhere to go when they need help. The homeless have become a city-wide issue because they have no place to go for shelter and has increased the homeless population due to our fentanyl crisis.

Jeff Talman: I have ringing in my mind the advice offered by the late great management guru Peter Drucker who said, "Don't fix problems, seize opportunities." In our case, I think we have an enormous opportunity to see Knoxville like never before, to imagine Knoxville like never before, and to build Knoxville like never before, but there are challenges.

I think it is first important to look at where we are from a historical perspective. Post WW II the center city of Knoxville, like many US cities, was abandoned by leadership as there was a mass exodus to the suburbs. What remained was older sub-standard housing in established urban neighborhoods. Great public housing refugee camps were established. Knoxville's most fragile people were clustered and concentrated in urban census tracts. All of the housing which was not desired in suburbia, public housing, group housing, student housing, indigent housing, etc, was tightly concentrated in the center city of Knoxville. Critical civic assets such as public schools were simply abandoned. These elegant school buildings such as McCauley School and Rule High School were the centers of public life for decades. Built to withstand everything except ownership by government, they were abandoned and left to rot with no clue as to how damaging derelict buildings are to property values and public perception. If you had any doubt that you lived in a 'bad part of town' all one had to do was to look at how little value the

abuse issues. Drug abuse neighborhood by allowing such abandonment to occur.

> Now many citizens are seeking out housing in the center-city because they want to live in close proximity to Knoxville's defining civic and cultural assets. The University of Tennessee which had long assumed the identity of a commuter college is now embracing its proximity to those same civic and cultural assets. I am one of those who loves downtown and always had the vision for this renaissance even when others did not. I have lived in the Fourth & Gill Neighborhood since January 1984. I have built a mortgage business around helping homeowners renovate, rejuvenate and recycle our older housing stock thus strengthening our great neighborhoods. When I served on the Knox **County Tourist Commission** I consistently wore my colleagues out by insisting that our tourism strategy had to have our revitalized city as its key selling point. I understand the costs, the process and the commitment needed to build our city.

We have a mass migration of people coming to Knoxville. Many of them are seeking out housing for urban living. I have heard the question asked "is the desire for urban living a fad?", I would say that the abandonment of urban living was the fad and that we are now returning to a permanent order for how some, but not all, people wish to live. This brings investment, exciting renovations, new construction, and rising prices, making housing which had been for decades the least expensive in Knoxville, into some of the most desirable and most expensive.

We need honest leadership about what is happening. We need to communicate the 'urgency of now' that existing homeownership opportunities may not be there in the future as the market will price people out. Therefore, we need to do everything possible to help our citizens be beneficiaries in this process. Currently the city is committing lots of public money to address affordable housing. There is not enough public money to really address the challenges at the scale which is needed, which is why the reform is needed to maximize private activity. We need to revamp our permitting processes so that builders, contractors and developers enthusiastically step in to provide the housing inventory which our area desperately needs. We need to direct our neighbors to the lenders and resource providers who can help open the door to homeownership for all who can marshal and pool the resources to do so. By building household wealth, creating jobs and strengthening the tax base, we will have the revenue needed to run the city without having to increase the rate of taxation. # When the Mountain State had Three Senators

Sorting through history is rather like finding an endless trove of buried treasure. There is always something to turn up and over. One of the more unusual historical altercations came from an episode when two political factions warred over a seat in the United States Senate. There is nothing especially unusual about that; what is unusual about this particular event is the fact two different governors appointed two different senators. Unlike the House of Representatives where a special election is called by the governor, when a member of the United States Senate dies or resigns from office, the governor makes an appointment to fill the vacancy. The appointee serves until the next regular election and a successor (which can also be the appointee should he/she run and win) is duly elected.

The politics of West Virginia has been as wild and wonderful as its own Largely state motto.

> It was Neely's insistence in meddling in the 1934 Democratic primary to choose an opponent for Senator Hatfield that his conflict with the statehouse faction came to a head. Clem Shaver, a former chairman of the Democratic National Committee, was a candidate for the Democratic nomination and was politically obnoxious to Neely. Senator Neely opted to back the candidacy of Rush D. Holt, a twentynine-year-old state legislator. No politician in West Virginia had more or better ties to the powerful organized labor movement in the Mountain State than Matthew Neely. At Neely's urging, the United Mine Workers and other labor groups coalesced behind the candidacy of Rush Holt, who won the nomination. Holt went on to win the general election and had to wait six months before he could take the oath of office, as he was not yet the required age of thirty under the Constitution.

At the time, West Virginia governors were barred from seeking consecutive terms. Kump backed his attorney general, Homer Holt (no relation to Rush Holt), to succeed him in the 1936 election. Homer won the Democratic nomination and election. Neely's friendship, political and otherwise, with Rush Holt came to an abrupt and spectacular end over patronage disagreements. By 1936 when Neely was running for reelection to the Senate, he referred to his junior colleague as a "sewer rat" among other lively epithets. With Senator Holt becoming pointedly isolationist in outlook and a foe of the Roosevelt administration, all federal patronage in the state was in Neely's hands. Yet the statehouse Democrats controlled all of the resources of state government and were building up a formidable machine, which was less friendly to the national administration and more conservative generally. Senator Neely realized a showdown would come between the two factions, which were struggling for dominance in the state. Neely announced he would back a challenger for the Democratic nomination for

governor in 1940 against Carl Andrews, the favorite of the statehouse machine. One by one, Neely eliminated every prospective candidate who sought the endorsement of the senator's federal faction. Only one candidate could meet the exacting criteria Senator Neely posed for the governorship: Neely himself.

After a bitter and savagely fought campaign for the Democratic nomination, Neely beat Carl Andrews. It was not the last pitched battle fought between the two factions. Another had been fought in the 1940 the United States Senate where Senator Rush Holt was seeking a second term. Former Governor Guy Kump was the statehouse candidate for the nomination, while local Judge Harley Kilgore was Neely's candidate. Kilgore won, while Kump ran second and Holt trailed in third place. Both Neely and Kilgore won the general election with Franklin Roosevelt at the top of the ticket.

The very first dilemma faced by Matthew Neely was resigning his seat in the United States Senate. Both Governor Holt and Neely appointed men to the U.S. Senate. Governor Holt's appointee was Clarence Martin, a respected attorney and former president of the National Bar Association.

Neely, never one to shy away from the bold or flamboyant, took the oath of office no less than three times, anticipating appointing his own successor to the United States Senate. The first oath occurred "instantly after midnight" on January 13, 1941, and was administered by John The statehouse faction Kenna, a justice of the state West Virginia Secretary of State, by Arthur B. Koontz, the Democratic National Committeeman from the Mountain State, and Hale Watkins, Chairman of the state Democratic Party. Evidently, Matt Neely kept much of West Virginia's political establishment up late that night. Two hours later, Governor M. M. Neely announced he had appointed Dr. Joseph Rosier to the U.S. Senate. Rosier was a resident of Neely's home city of Fairmont and a wellregarded educator and president of the Fairmont State Teacher's College. Knowing his way around Washington, D.C., Governor Neely sent a telegram to Edwin A. Halsey, Secretary of the United States Senate, informing him of Dr. Rosier's appointment. Neely's telegram to Halsey also mentioned he had tendered his own resignation from the United States Senate "precisely at midnight" on January 12. "Dr. Rosier, who is one of West Virginia's most illustrious men will with his duly executed credentials, promptly present himself to you for the purpose of taking the required oath of office. . ."

In between receiving outgoing Governor Homer Holt could level at a colleague and accepting the Rosier appointment, Secretary of State William S. O'Brien took his own oath of office for the new four-year term to which he had been elected in 1940 "in the event any question should arise as to the proceedings tonight."

Neely took the oath of office once again in his study at the governor's mansion and again for the third time at the official inaugural ceremonies. Governor Neely exuded confidence, telling newsmen he was fully confident his own appointee would be West Virginia.

wooly West Virginia, as he did for generations, without knowing something about practical politics. Neely realized the United States Senate retained the sole authority for determining its own membership. The new governor had just thrown a political hot potato in the lap of his onetime colleagues. Neely's resignation also elevated freshman Harley Kilgore to the status of West Virginia's senior U.S. senator. As the U.S. Senate untangled and argued over the merits of which appointee had the legal right to serve as a member of that body, an exasperated Alben Barkley, the Majority Leader of the Senate, growled the entire kerfuffle was at the very least unseemly, if not indecent. In any legislative body, whether it is local or federal, relationships matter. That between Alben Barkley and Matthew Neely was somewhat strained. Barkley had

Senators discussed and argued the various precedents, while others debated the facts surrounding each appointment and the law involved. It should surprise exactly no one that there was maneuvering behind the scenes. The Roosevelt administration exerted all of the influence it could summon on behalf of Dr. Joseph Rosier. Clarence Martin had his own supporters and commanded backing from conservative Democrats and many Republicans inside the Senate. Many of Martin's colleagues from the American Bar Association lobbied hard for his being seated in the Senate.

argued hard on behalf of seating Joseph Rosier. If the spectacle was indeed unseemly and indecent, Barkley said it was the fault of Homer Holt, the outgoing governor of West Virginia and not that of Neely.

The Senate was sharply divided and the vote was close. Clarence E. Martin was denied a seat in the United States Senate by a vote of 40 - 38. Dr. Joseph Rosier, a quiet, white-haired professional educator who had been a faithful supporter of Matthew Neely, took the oath of office.

Matthew Neely had gotten his way and it was common knowledge in the Mountain State that Joseph Rosier was merely a placeholder. As Governor Neely fired those Democrats from state jobs who had been aligned with the administrations of Guy Kump and Homer Holt and replaced them with his own followers, it was generally believed he would Senate in 1942.

That proved to be the case and having merged the federal and statehouse factions, Neely easily turned aside a determined challenge inside the Democratic primary by Guy Kump. Yet the people of West Virginia were not thrilled by Matt Neely's skipping from one office to another at his own whim. Neely lost the general election to an unknown Republican, Chapman Revercomb. The verbose Neely, when asked about his loss, snapped, "A fatalistic philosopher once said that on election day the American people have the right to do anything they damned please. Recent returns from the political front preclude the possibility of refuting this assertion."

party with the 1932 election. As is oftentimes the case, with success came division. The Democratic Party of West Virginia became sharply divided. The factions could be most easily labeled as the "statehouse" Democrats and the "federal" Democrats. The "federal" faction was led by the most colorful and arguably, the most popular Democrat in the state: Matthew Mansfield Neely. Neely was an amazing character and made more and better comebacks than even Lazarus. Matthew Neely had a propensity of being elected and then losing an election and coming back from defeat. Neely had been elected to Congress in a 1913 special election when incumbent congressman John W. Davis had resigned to accept an appointment as ambassador to the Court of St. James. Neely was routinely reelected every two years until the Republican tidal wave of 1920, which swept Neely and the Democrats out of office. Matt Neely aimed higher two years later and beat Senator Howard Sutherland, a Republican, in the 1922 election. Senator Neely was unseated by GOP Governor Henry Hatfield six years later in

ing golf after I married Amy. Her Poppa played and wanted me to go with him. I enjoyed the time with him, but my game was filled with hacks at the ball and worm burners that


rolled along the







torn down. Only film, later videotape, and the power of memory are keeping them alive.

Life as we know it has taken a number of interesting turns.

Closer to home and of equal or greater concern, Larry Munson and John Ward no longer broadcast the Georgia and Tennessee games.

They were two legends who described the excitement of college football from the 1960s onward.

"While Cawood Ledford was my closest friend in the business," said Ward, "Larry Munson was right there, too. His strength was that he could visualize the game for the listener. He was a very good broadcaster, with his own technique."

In markedly different ways, their listeners could feel the game's excitement in each voice, distinct yet different.

John Ward could make the standard broadcast disclaimer ("This broadcast is authorized under broadcast rights granted by the University of Tennessee through the Vol Network, solely for the entertainment of our listening audience...") into an art form. Don't remember ever hearing Munson utter those famous words. Someone did, but probably not Larry.

Munson's rambling monologues, laced with liberal use of the word "we," seemed to go on forever, never finding a period. They were classic.

Ward had a keen sense of anticipation as the play unfolded, with few wasted words.

Both men painted the word picture in markedly different ways, and their fans loved them. Ward disdained the use of the word "we," as applied to Tennessee, but the excitement was still there. John rarely stood up in the booth, but when he did, something special had to have been happening, take for example the 80-yard TD pass from Peyton Manning to Joey Kent in the 1995 Alabama game. For his part, Munson never

did decipher the difference between Vol running backs Don

McLeary and Curt Watson in the 1969 game at Athens, telling of "Tennessee going toward the book store, just handing the ball off to that big running back."

Tennessee ran the ball well that season, and Watson and McLeary each gained more than 100 yards rushing that day. The numbers on the orange jerseys were soaked with North Georgia mud. They weren't easy to see anyway, home or away, rain or shine.

Georgia trailed Florida in the 1980 version of the event formerly known as the "World's Largest Outdoor Cocktail Party." Things looked bleak when the Bulldogs lined up in the shadow of the Gator Bowl's north end zone, trailing 21-20. It was third-and-11.

The south end zone looked miles away but was actually a

mere 92 yards. Getting in field goal range seemed a tall order. Florida players and fans were in victory mode. Happiness was heading toward Gainesville at a feverish pace.

For its part, Georgia wanted no part of losing. In one magic moment, King Arthur pulled the sword from the stone. The Lone Ranger and Tonto arrived just in time to save the little town from the Cavendish gang. Barney Fife found Andy and Helen in the cave. That famous, often grating,

voice was in full flower.

"It will take a miracle now... Do the Dogs have it?... Florida in a stand-up five... They may or may not blitz... Buck back... In trouble... Gonna throw on the run... Complete to the 25... to the 30... Lindsay Scott... 35... 40... 45,

50... 45,40... RUN LINDSAY ... 25, 20...15, 10, 5... LINDSAY SCOTT !... LINDSAY SCOTT !... LINDSAY SCOTT!"

It was a magic moment, unless you were rooting for the Gators.

For Ward's signature moment, you flash back to the night of Jan. 4, 1999, when Tennessee and Florida State were battling for the first BCS National Championship.

"Peerless Price is the wide receiver returning to the Vol huddle with the clock showing 9:45 to go in this game ... This is John Ward and Bill Anderson sending you the action from the Fiesta Bowl in Tempe, Arizona... Tennessee will come to the line with Travis Stephens as the running back. There are two flankers to the left, one to the right ... Florida State in a 5-man front. They're going to blitz this time. Martin back, steps up, struggles, going to throw the ball long, long down the field to Peerless Price... Caught at the 45... He's at the 40, 35, 30, 25, 20. Just give it to him... No flags on the field. Touchdown, Tennessee!"

John's calls of moments like this one have resonated over the years, being savored as a part of life wherever Vol fans gather.

So, here's a tip of the old fedora to Larry Munson and John Ward, who made football exciting for fans over the years, each with different styles, but united by their ability to bring home the action on the field in a memorable way.

Time waits for none of us, and that includes the world of collegiate athletics.

The Southeastern Conference, which announced a couple of years ago the additions of Texas and Oklahoma, announced its SEC schedule for the 2024 season, which also happens to be when the Longhorns and the Sooners join the league.

Despite now having 16 teams, the SEC is sticking with an eightgame football conference schedule. This is welcome news to Nick Saban at Alabama, who spent the past few months politicking to make sure that his game against Western Montana A&T State isn't affected. Every SEC school can keep a prof-

Back in 1992, the SEC grew from 10 to 12 with the additions of Arkansas and South Carolina. Then in 2012, Missouri and Texas A&M expanded the conference's footprint. Which leads us to Texas and Oklahoma next season.

Yes, the SEC looks much different than it did at the time of its founding in 1932. And not everyone is happy about it.

With 16 teams it'll be impossible

to bankrupt the league. Had Twitter been around in 1992, there would have been a #NoArkySC hashtag across the platform.

But there are some positives to the most recent expansion. First, now every SEC team will play in the others building at a minimum every four years. Since Texas A&M joined the SEC in 2012, Tennessee has only played at Kyle Field once, with the Aggies only playing in Neyland Stadium once. You'll get to see games like that more often.

Old Southwest Conference era rivalries like Texas vs. Texas A&M and Texas vs. Arkansas will be renewed too. Those rivalries are built on pure, unadulterated hate, so I'm excited to see them back. The first run through the conference will bring excitement when Oklahoma plays at Gainesville for the first time. I'm not a fan of change for the sake of change. I understand the financial rationale behind the moves. The SEC is trying to stay at the top of the heap. They see the Big Ten and Big 12 making moves (I can't wait for UCLA at Rutgers in Big Ten play!) and won't be left behind. Time waits for none of us.


