It's a new year and Fountain City Auction will kick off 2024 with its 19th annual Advertisement Sale and Country Store Auction on Saturday, January 6, at 2 p.m.

The event is online only and the preview will be held Jan. 4-5 from 9 a.m.-2 p.m.

"It is online only, so people will need to go online and register," Fountain City Auction Co-Owner Greg Lawson said.

The event is held annually in January and is one of the company's biggest events of the year. It always takes place after Christmas, but it is year-round in the making.

"We have regular customers who come in and bring us stuff all the time," Lawson said. "And sometimes, we take that stuff and hold

The funds are part of a larger \$5 million appropriation approved by members of the General Assembly for the Tennessee State Museum in the 2023-24 state budget.

"These historic sites offer great insight into Knox County's past and cultural heritage," the lawmakers said in a joint statement. "These investments will support the mission of these very worthy organizations. We thank the Tennessee State Museum for their preservation efforts and contributions to these important projects."

The funds must be used for building and land improvements, including structural changes and renovations.



## Thousands Of Small Children Are Being Killed In Gaza He's an orphan now, his story on Dec. 14 said: room doctor in Gaza, his access latrines and wash



"A badly burned toddler screamed for a mother he didn't know was dead, screaming because doctors didn't have enough painkillers."

"An eight-year-old whose brain is exposed because bombing damaged part of his skull."

"A teenage girl, her eyes surgically removed, because every bone in her face is smashed."

"A three-year-old double amputee whose severed limbs are laid out in a pink box beside him."

All these horrible things that happened to children in Gaza were described in a mid-December speech to the Irish Parliament by member Holly Cavins.

The same day I saw Ms. Cavins' speech on You-Tube, I read a CNN story about eight-year-old Jinan Mughari and 20-month-old

Jinan was in a full-body cast because of a crushed leg and broken skull. She said, "They bombed the house in front of us and then our home."

As to the toddler, Amir, the CNN story said he "lies silently on the bed - his fluffy hair sticking up, his baby-soft skin violated by a raw, jagged wound across his forehead. Purple bruises swell around one of his big brown eyes."

aunt says, with his parents and two of his siblings killed in an Israeli air strike. But he does not know that yet, his aunt, Nehaia Al-Qadra said. He is too young to understand.

"They found Amir in his mom's arms laying in the street," Al-Qadra said. "His sister died, his brother died, his uncle and his other sister injured in the hospital. Here we are, he doesn't have a mother or a father or an older sister or brother. Now it's just us two and God."

"Amir wants his father. Yesterday he saw a nurse that looked like his dad, and he kept screaming 'Dad! Dad! '," Al-Qadra said. When she needs to calm him down she shows the toddler a video of his

"Israel pounded the length of Gaza Strip on Thursday, killing families in their homes, even as Washington dispatched an envoy to encourage its ally to be more precise in its war against Hamas militants.

"Two weeks after a truce collapsed, the war is now raging across the entire Palestinian enclave and a humanitarian catastrophe is unfolding. "In Rafah, jammed with

people in makeshift tents on Gaza's southern edge, people wept at a morgue where bodies of those killed in the latest overnight air strikes were wrapped in bloodied shrouds. Some were small children."

The story told of two adjacent homes bombed where 26 people were killed. The day before I wrote this column, an emergency

wife and all five of their children were killed by one of the 29,000 bombs that had been dropped at that point.

On Dec. 20, Netanyahu said, "Whoever thinks that we will stop is detached from reality." He dismissed calls for another truce and vowed to fight on until "victory." The Israeli Defense Minister said on Dec. 14 that the war will go on for several more months.

The U.N. said thousands were at risk of famine and that half of the two million displaced were going days without food.

Noelia Monge, head of emergencies for Action Against Hunger, said "Everything we are doing is insufficient to meet the needs of two million people. It is difficult to find flour and rice, and people have to wait hours to themselves. We are experiencing an emergency like I have never seen before."

The president and most members of Congress care first about their own families, but a very close second is their concern about their own re-election. They are all scared of the Israel Lobby.

But the slaughter that is going on now is obvious to all. What Israel is doing is creating even more enemies for the U.S. Any government official who does not speak out against all this bombing is at least practically responsible for the deaths and maiming of thousands of small children and really has the blood of these victims on their hands.

had declared their independence, the proclamation did not have any force of law. Indeed, so as not to offend the neutral states and territories that allowed slavery (Kentucky, Maryland, Missouri and the western counties of Virginia) Lincoln had carefully crafted his words. However, there was one very important provision of the proclamation, which was to have the Federal forces "recognize and maintain the freedom of such persons and will do no act or acts to repress such persons, or any of them, in any efforts they may make for their actual freedom." This was of extreme importance since in earlier years of the war, runaway slaves were often not aided by the federals and were sometimes returned to the confederate lines. Also after the proclamation, the federals started wholesale enlistments of black troops. Although the vast majority were freemen, many were runaways. In the end, more than 200,000 blacks wore union blue and historians find that the superiority of manpower of the federals enhanced by the blacks in blue, hastened the end

of the war. Finally, did my

history teacher concede?

No. She simply stated

emancipation laid the foundation for freedom and had motivated the 13th Amendment which was passed in the Senate before Lincoln's

assassination. Lincoln was emboldened by the Union victory at Antietam in September 1863 which lifted northern spirits after a series of defeats by Lee's army. It prompted him to issue the Proclamation in hopes of dissuading the anti-slavery governments of Britain and France from recognizing the legitimacy of the confederate government. It also allowed him to allow the enlistment of black troops. However, the Proclamation was not met with universal favor in the north, leading to riots in some cities. So should January 1st be "Emancipation Day?" Texas, and many blacks, had long celebrated Juneteenth Day as Emancipation Day. Juneteenth (June 19, 1865) marked the end of slavery in Texas and is now a federal holiday. Fittingly, Texas first enshrined the date as a state holiday in 1980. By 2019, Juneteenth was recognized by 47 states and the District of Columbia. Thus, whether accurately or not, Juneteenth rather than January 1st is Emancipation Day.



# A look back at 2023, part 2

The second half of 2023 saw a small turnout for the Knoxville City Elections with one new councilmember elected as well as a new city judge. Mayor Indya Kincannon was re-elected with an overwhelming vote during the city primary.

Councilwoman Janet Testerman chose not to seek re-election and went on to see the city and county grant approval for Young-Williams Animal Center to take over all animal control duties. Testerman is CEO of YWAC.

The local 2024 races for offices in Knox County kicked off with campaigns for commission, school board, property assessor, law director and criminal court judge. Both the city and county governments focused on housing issues and ground was broken for the mixed-use stadium downtown. The Focus featured various neighborhoods in an ongoing series.

#### July

The Knoxville-Knox County Emergency Communications District Board heard a report from Finance Director John Fugate, who reported a \$4 million boost to take the agency to a \$13 million budget, which would allow an increase in employees and finance a back-up center in the new Safety

The Knox County Commission honored the East Tennessee Veterans Honor Guard and chose attorney Spencer Reed over Troy Jones to replace Magistrate Ray Jenkins. The new Knox County Mental Health Board Committee met for the first time.

The commission looked at parks, a property swap with Axel Logistics, and voted on the meaning of "swimming pool." The Board of Education heard of needs for Special Need Kids and the Merit Board dismissed a grievance by Charles Fair-

An Alternative Response Team was created by the Knoxville City Council, which would also discuss affordable housing, zonings, city buses and the departure of Deputy Chief Brooklyn Sawyers Belk from the police department during July meetings.

The Knoxville Fire Department hosted an open house at Station 11 and Sutherland Avenue saw an active shooter drill.





# Behind the Curtain Women Come Into Their Own

## **Pages from the Past**

majority of the seats on the Knox County Commission and the recent centennial of Tennessee being the state to give women the right to vote, it occurred to me to write a column about some women who were prominent, yet largely unknown. There was a time when congressmen and senators only employed women in a secretarial capacity; at that time, those were usually known as "stenographers" but there were several men who had mastered the relatively new art of the typewriter. Before women got the right to vote, it was almost unheard of for women to occupy the highest staff position in a congressman or U.S. senator's Alben Barkley of Kentucky

larly elected United States senator was Kenneth D. McKellar, McKellar, while a life-long bachelor, was highly supportive of women and was a strong advocate of ratification of the Nineteenth Amendment to the Constitution, giving women the right to vote. One of the most notable of Tennessee's suffragists was Sue Shelton White, who worked on McKellar's Senate staff. At the time, the top staffer in a congressman or senaof staff. Even the top staff member to the president of the United States was referred to as the secretary. McKellar named Miss Shelton as his top staffer. Eventually, Miss Shelton left McKellar's staff and became a practicing attorney, although she returned to federal service under Franklin Roosevelt's New

Some of the women who rose to the top staff positions on Capitol Hill became powerful in their own right. Catherine Blanton was a girl from Sikeston, Missouri, who learned to type and that skill, as well as a determined work ethic and a native shrewdness took her all the way to Washington, D.C. Miss Blanton's first secretarial job was part-time while she was in high school. In 1925, Miss Blanton left Christian College, where she was the secretary to the president of the institution, to go Capitol Hill with Congressman William L. Nelson. She became the top assistant to Congressman Nelson. Catherine Blanton remained in Washington and the center of events through the administrations of Presidents Calvin Coolidge, Herbert Hoover, Roosevelt,

While working for Congressman Nelson, Miss Blanton later recalled, "Since I was permitted to close up the office any time a senator of note was scheduled to make a speech, I heard many orations made by Sen. James A. Reed of Missouri, Sen. Pat Harrison of Mississippi and Sen. William E. Borah of Idaho." In 1929, Miss Blanton became the chief of staff for Senator Pat Harrison, a gregarious and influential senator who became even more so during the New Deal when he chaired the Senate Finance Committee. Harrison failed to become Senate Majority leader by a single vote, losing to in 1937.

# Age of the Body Snatchers

By Jadon Gibson

he 1800s brought an increased interest in the medical profession with medical schools increasing in size and number.

English writer Mary Shelley is best known for her horror novel "Frankenstein," or the secondary title "Modern Prometheus," in 1818. With a growing interest in the human body in the 1800s there was a marked increase in grave robbing in North America, Europe and other parts of the

Daniel Rudolph committed suicide in Topeka, Kansas, in late 1879 and his body was shipped to Sugar Grove, Ohio, for burial. Grave robbing was at epidemic proportions in Ohio at the time because of the numerous medical schools located there. Several individuals at Rudolph's funeral noticed three or four strangers prowling around the graveyard after the interment. The overseers of the graveyard, called

extons at the time, was aware of darkness. the increased incidence of grave

robbing and made it a point to visit the grave during the next two

Just before midnight on the second night he spotted three human forms near the new grave as he approached. The moon shone bright as he neared the fencing and it enabled him to see a pile of dirt that the men had shoveled from the grave. He knew they were grave robbers and could tell by the size of the dirt pile their mission was nearly

"Hey, what's going on here?" the graveyard overseer shouted before discharging his pistol into the air several times. He didn't want to make himself a target should they be armed, so he remained undercover. He knew they would either take to their heels or if armed, they may force the issue with him. As he

In the village of Gann, Ohio, near the same time three men were attempting to rob a grave when their shovel struck a bomb of sorts that had been placed atop a concrete slab above the casket. The device, which was called a torpedo in the newspapers of the day, was devised to prevent the grave from being robbed and to discourage grave robbers. One of the men was killed by the blast and another suffered a broken leg. The third who was assigned to watch hoisted his comrades into their horsedrawn sleigh and took flight.

The Ohio General Assembly passed a measure the following year legalizing human dissection in the state's medical schools. It was a paradoxical situation as the public opposed the practice of human dissection yet expected medical practitioners to be well trained. Bodies were needed for

refused to pass laws that would robbing. permit medical schools to use unclaimed bodies. Medical schools would have to discontinue dissection or bodies would have to be procured through grave robbery. Does this remind you of the great Frankenstein movies of the past? Frankenstein was comprised of parts from more than one body.

An investigation of these thefts in Ohio suggested as many as 5,000 graves were disturbed and bodies stolen for anatomical instruction during the 1800s. The practice was not unique to Ohio as all areas with medical schools needed cadavers.

"Bodies are buried by day and forbidden resurrectionists dig them up by night," the Ohio State University Journal reported in a release Feb. 17, 1871.

"As the medical colleges are beginning winter terms every good citizen would do well to hoped they quickly ran into the study and dissection. Lawmakers be on the alert to prevent grave and the Museum of Appalachia.

"The trustees of Ohio State University have appropriated \$40 for hauling dead horses, cows and other animals too large for the students to carry to the zoology laboratory," the Columbus paper reported. "These snatchers are much less to be feared than those who take corpses for medical colleges."

Dr. Frederick C. Waite said it was a misconception that grave robbing was a normal part of life for medical students but it was a practice at times. Some heard doctor's stories of bold adventure and hair-breadth escapes while robbing graves during the time they were in medical school.



## Sonny **Trotter** announces retirement from coaching

When the 2024 high school girls soccer season begins in August, it will do so without one of its most successful and popular

Sonny Trotter, a fixture on the high school soccer scene for nearly three decades, has announced his retirement from the

Trotter spent the last 10 seasons as the Webb Lady Spartans' head coach, and was relieved of his duties in late November. In a decade at his alma mater, he guided Webb to 100 wins, three district titles and four state quarterfinal appearances.

He also coached five allstate players and one high school All-America standout and 15 players who continued to play soccer in college in his career.

Before taking the reins for the Lady Spartans, Trotter coached at West High School. He coached the Lady Rebels for 16 years, from 1998-2014.

At West High, he was a two-time Knoxville Interscholastic League Coach of the Year. He guided the Lady Rebels to league championships in both District 3-3A and District 4-3A. Trotter also guided the Lady Rebels to eight regional appearances and three region championship matches and three appearances in the state sectionals.

Trotter also started the KIL Girls Soccer Jamboree, a preseason play day that raised money to alleviate insurance costs for high school athletes.

He guided the Lady Rebels to 223 victories.

After he was dismissed from Webb just before Thanksgiving, he considered taking the opportunity to coach at Oak Ridge High School after Lady Wildcats' head coach Donnie Green stepped down to begin


