



Sales tax referendum's inclusion on Nov. ballot up to city council

Knoxville Mayor Indya Kincannon took to the public forum podium Thursday to request support from city council on placing a referendum on an increase on sales taxes before voters in November.

Vice Mayor Tommy Smith chaired the workshop and all the council except Amelia Parker attended. Kincannon walked the council through a slide show detailing the proposed hike in sales tax from 2.25% to 2.75%, the maximum allowed by Ten-

nessee legislation. The proposal's language will be finalized by the council and others and will see two council votes in June.

The mayor confirmed that, if approved, the final language would go on the ballot. The current November ballot has five district council races but the referendum's outcome would be decided by all city voters. Knox County Election Director Chris Davis told the meeting adding



Tapper's book apparently says that Biden's inner circle "couldn't believe how easily (the media) swallowed campaign lies" and how eager reporters were to say something Trump said was false.

Will Talman qualify as a candidate?

The Knox County Election Commission meets Tuesday, June 10, to review the list of candidates for five seats on the Knoxville City Council, set up the August 26 primary, and rule on the residential requirements of one council candidate.

According to meeting agendas released by Chris Davis, administrator of the Knox County Election Commission, the 8:30 a.m. special-called hearing concerns a qualifying petition submitted by Jeffrey Talman, a possible primary candidate for the Knoxville City Council District 4 seat. Also in that primary are Matthew DeBardelaben and Jane George.

The charge is that Talman listed a vacant lot, 616 Luttrell Street, as his 4th District

residence. Talman said he's renovating the lot to build his new home and plans to

reside there before the August election. The public hearing will open with five minutes given to Talman and a "presentation of facts" by Davis. Election commission members may ask questions, Talman will speak again, and the commission will vote on whether or not he qualifies to seek the office. A decision will be made and the hearing will then be followed by the regular meeting of the election officials.

The regular meeting's agenda includes considering the list of qualified candidates and early voting locations for the August 26 primary, appointing election officials and machine technicians, and hearing the administrator's report. The hearing and meeting are open to the public.

Changing the rules about how the Knoxville City Council operates may not be as easy as many members of the "Procedure and Charter Review Task Force" expected. The group of current and past council members met Tuesday to continue the effort and ended the meeting after much discussion and few actual changes.

given to a councilmem- many times as needed. ber to present a resolution was considered, and the task force went back and forth between the existing rule that is not followed, the current unofficial policy that violates the rule and a future policy to resolve the debate. If nothing is adopted, the council will continue to violate its original rule and allow a sponsor to speak unlimited times on an issue.

The council often allows speakers and debate on a resolution or zoning matter before it votes to consider a motion. Vice meetings electronically Mayor and District 1 Councilman Tommy Smith doesn't want a debate opened before the sponsor introduces the issue. Task Force Chairwoman Lynne Fugate, a former school board member, noted that's how the school board handles agenda items.

Smith said that if a matter can be debated before it is opened from the agenda, he could set up numerous public speakers and stall the meeting for a good length of time. The task

members also discussed how many times a sponsor of a resolution can speak on the issue and for how long. Current rules call for a sponsor to speak no more than two times but the rule is not currently followed. Smith suggested allowing a sponsor to speak three times. The members also discussed new state legislation permitting, if selected and adopted, council members to take part in in case of weather, military service or medical problems. Smith said the council should opt out of adopting it and Fugate referred to an incident in the past where a school board member was hospitalized and permitted to vote from the hospital

the referendum to the ballot would cost between \$15,000 to \$20,000.

Should Knox County choose to join the city's tax increase, all city and county residents would vote on the idea in November at a much higher cost for the election commission, which Davis estimated at "several hundreds of thousand dollars." However, if the city voters choose to increase the taxes and the county votes it down, both the city and county would lose the issue.

Kincannon said the tax increase would only apply to the first \$1,600 in items bought in the city and would not be added to the cost of groceries, prescriptions, rent, gasoline, bus fares, property taxes, utility bills, baby formula or health care visits.

Most of the council members commented or asked questions concerning the possible loss of federal funding and grants. Kincannon said the estimated revenue from the sales tax increase isn't a back up for those losses but part of a five-year plan to





Code Annotated 39-14-146, within 72 hours, the section increases penalties for law allows the values to shoplifting in certain situations, reflecting the state's tougher stance on retail theft.

Tennessee

Tennessee does not use the term "shoplifting" in its statutes. Instead, it's prosecuted under theft laws when someone takes merchandise without paying and with the intent to deprive the merchant of that property. Common examples

include hiding items, switching price tags, or walking out without paying. While the general theft statute applies, it becomes shoplifting when the victim is a retail merchant.

Under this statute, penalties are enhanced bumped up by one level when certain aggravating factors are present: the theft caused over \$1,000 in damage to the store; the offender used tools or devices to disable security systems; two or more people worked together to commit the theft; the offender had a prior theft conviction

two years. That means

a misdemeanor could become a felony, and a low-level felony could jump to a more serious charge with longer prison time.

If multiple thefts occur

be added together and charged as one crime a key provision that targets repeat or organized offenders. In addition to criminal

charges, retailers have the right to seek civil damages under Tennessee Code Annotated section 39-14-144. They can recover the retail value of the goods, up to \$1,000 in damages, plus attorney's fees. This gives businesses a legal way to recoup losses even if prosecutors don't bring formal charges. Shoplifting is no longer

treated as a minor offense in Tennessee. Enhanced penalties, aggregation rules, and civil remedies all send a clear message: theft from merchants will be prosecuted aggressively. Anyone facing these charges should consult an attorney - the consequences can escalate

The Senator From Louisiana John H. Overton

Pages from the Past

Holmes Overton served as United States senator from Louisiana from 1933 until his death in 1948. Throughout the first part of his senatorial career, Overton suffered from his affiliation with the notorious political machine of Huey Long. An excellent lawyer, Overton had been Long's attorney and was elevated to Congress in 1931 when incumbent James Aswell died. Overton won the special election to succeed Aswell and, in 1932, Huey anointed his friend as the Long machine's candi-

date to oust U.S. Senator

Edwin S. Broussard.

Huey Long's clarion call to make "Every Man a King," and every woman a "Queen," as well as his constant orations against wealth and the wealthy gave Louisiana's "Kingfish" a national following that impressed even President Franklin D. Roosevelt, who thought Huey to be one of the most dangerous men in the country. Of course, Huey was a millionaire through his ownership of the "Win or Lose" oil company, which certainly seemed to win far more often than it lost.

Overton was the son and grandson of jurists and his great-grandfather during the Civil War. Overton had been a founder of the Good Government League of Louisiana, which had been formed to defy the notorious machine in New Orleans.

The assassination of Huey Long in 1935 went a long way in rehabilitating Overton's image. Overton's association with the Long machine receded somewhat, at least as far as most newsmen were concerned, and his reputation changed as he worked hard on behalf of the people of Louisiana and was regarded as an able member of the United States Senate. Politically, Senator Overton had done his homework and was well-liked in his home state as evidenced by his repeated victories at the polls. Senator Overton became recognized as an expert in the field of what the Shreveport Journal referred to as "waterway improvements." Overton chaired a committee on rivers and harbors in the Senate and championed legislation and projects all of which did much to

cal alliance with Huey Long, the senator was a strongminded individual with strong likes and equally strong dislikes. Overton's Senate office operated on the regular Eastern Standard Time, which he referred to as "God's time." The senator's likes included a special coffee pot kept near his desk in the Senate Office Building, where his daughter Katharine brewed him French coffee at least four times daily, according to TIME magazine.

> John H. Overton had held no elective offices prior to his candidacy in the 1931 election to succeed Congressman James B. Aswell. Overton had run for the United States Senate in 1918 in the Democratic primary, facing Congressman Edward Gay and former Governor Luther E. Hall. Overton ran third. Following the death of Congressman Aswell, Overton faced no opposition for the Democratic nomination in the special election, which in Louisiana at the time was tantamount to election.

After having represented Huey Long when the governor was being impeached, the grateful former governor chose Overton as the machine's candidate to run against Senator Broussard. Edwin Broussard was a strong opponent of Huey Long and outspoken about his

distaste for the "Kingfish."

Broussard accused Long of having "bought the legislature," controlling every department and agency in Louisiana, and intimidating "the business people." "If you don't believe that the business people have been intimidated," Broussard cried, "ask your banker." Broussard insisted Huey Long had been "elected to Constitution and ideal of the United States Senate by the greatest fraud, deceit and corruption in the history of the state." Senator Broussard pointed a finger at John Overton, saying his opponent was at the very least complicit in Long's political maneuvering. "In all these actions he has been advised by John Overton and everything I say about Long applies to Overton with equal force,"

> An able and nimble public speaker, Overton had the full backing of the formidable Long machine. Unlike Huey, who cultivated a "man of the people" image and a frequently vulgar character, John Overton was more aristocratic and polished. Overton was more dignified than Long and some of those supporting Senator Broussard sought to make Huey the issue. Shreveport's Mayor George W. Hardy told one audience, "The issue is Huey P. Long. John Overton is the shadow, the puerile instrument used merely to further the purposes of Huey Plundering Long."

> John Overton had been instrumental in helping Huey Long's rise to political prominence in Louisiana. Overton had been one of the original leaders of Long's successful gubernatorial campaign. John Overton had been chief counsel to the governor when the effort was made to impeach Huey Long. When Long ran to unseat Senator Joseph Ransdell, Overton was once again one of the governor's top political leaders. Long's backing of John Overton, first to succeed Congressman Aswell, and

When Earl K. Long, brother of the late Huey, sought the governorship, Senator Overton refused to support him inside the Democratic primary, saying to do so would have betrayed his original patron. Unfortunately, the 72-year-old senator was ailing. Three days after Long's inauguration, John Overton died in Bethesda

Naval Hospital. John Overton had been working at his office, but the following day remained at home, complaining of not feeling well. The senator's condition grew worse, and he was taken to Bethesda Naval Hospital, where doctors quickly diagnosed that Overton was suffering from an intestinal blockage. The senator underwent surgery, and the following day, a report was issued saying doctors assessed the senator's condition as "satisfactory." The operation was quite serious, and the next report was that the senator had rested comfortably during the night and his condition was "no better and no worse."

Family and friends were

encouraged by Overton's

reaction to the surgery, although his condition was still assessed as "critical." One Louisiana newspaper reported, "His general condition is slightly better this morning," according to the hospital. Unfortunately, it did not remain that way.

A day later, Louisiana newspapers began reporting the senator had pneumonia. That was followed by reports that Overton was gradually becoming weaker. On May 11, 1948, the Shreveport Times blared on its front page that the senator was worse and "his chances for recovery are now considered 'poor.'" The bulletin noted the senator was considered "critically ill" by Bethesda's physicians. Evidently, the senator's heart was having trouble enduring the trauma inflicted on his aging body, and the result caused a "circulatory failure." The senator had suffered several heart attacks over the preceding five years, and he began to fade. The end came at approximately 3:50 a.m. on May 14, 1948. John Overton's wife Ada and daughter Ruth were at his bedside when he slipped

quietly away. Senator Clyde Reed, a cantankerous man representing Kansas in the U.S. Senate, walked over to the Democratic side of the aisle in the Senate Chamber and placed a vase of red gladioli on John Overton's desk. His voice was "choked with emotion" as he told Overton was 68 years his colleagues "these flowers are so symbolic of the strength and character of

> John Overton." Mrs. Overton chose in Washington, D.C., preferring to return home to Louisiana. The senator's body was taken home to casket into the two-story home he had lived in for more than a quarter of a century. It was common at the time for a body to be placed inside the parlor of one's home and Senator Overton lay in repose inside his home and most of the downstairs rooms were packed with floral tributes. At the head of the senator's coffin was a floral arrangement of pink peonies sent by President Harry Truman. At the senator's feet were white gardenias from his colleagues in the Senate.

> The Shreveport Journal eulogized Senator Overton in an editorial published after his death. "John H. Overton proved his invaluable worth by his effort in every role he filled in a life of brilliant accomplishments."

William Gannaway 'Parson' Brownlow

The controversial politician William Gannaway "Parson" Brownlow led Tennessee's successful readmission into the Union. It was the first state of the Confederacy to do so.

During this rough and ready period of American politics words, mud, fists and even bullets flew. The most contentious battles were over the course of American democracy and the question of slavery and its expansion. One of the most unusual political figures was Tennessee Governor William G Brownlow, "the Fighting Parson." How did he become one of the most divisive figures in

William G. Brownlow's advice on how to deal with an opponent was controversial: "Lather him with aqua fortis (nitric acid) and shave him with a handsaw." Wow!

Tennessee history?

the fevered run-up to the Civil War, Brownlow supported slavery but opposed secession. During the war he supported emancipation. After the war he was Reconstruction governor of Tennessee and attempted to extend civil rights to Black Americans, but proved ineffectual in combatting the rise of the Ku Klux Klan.

Brownlow began his career as a carpenter and following a conversion experience became a Methodist minister. The paucity of settlements on the Appalachian frontier led him to proselytize on horseback. Brownlow rode and preached hard, going after those he thought insufficiently pure.

The Fighting Parson was sued for libel more than once. That was before he became a newspaper editor. After he fired up the

neutral on any issue. In in Elizabethton, Tennessee, the assassination attempts began. The motto of the Whig was "Unawed by power, unbribed by gain, the people shall be heard and their rights vindicated." The editor's preliminary address to readers warned of the threat of "national despotism." Brownlow became a

> prominent figure in the Whig party which had coalesced in 1834 to oppose Andrew Jackson. They took their name from the Whigs (or patriots) of the American Revolution who in turn took their name from British Whigs who favored reform of colonial policies. The new party brought together members of the older National Republican and Anti-Masonic parties. It was middle-class entrepreneurial and modernizing but strongly against the mass democracy of

the Whigs also condemned Jackson's Indian policies. In 1845, Brownlow ran for Congress only to be defeated by Andrew Johnson.

campaigned fiercely against secession because it threatened the Union and the Constitution. He argued that slavery could survive within the Union. Tennessee did secede in June of 1861 and Confederate troops occupied the eastern part of the state and arrested leading Unionists. Brownlow managed to keep his paper going until October, defending those arrested. Then he went into hiding, was arrested for treason, released and went into exile in the North.

In the North, Brownlow lectured and excoriated the Confederacy finally coming around to an anti-slavery position. When Union Jackson's Democrats. A troops occupied Tennessee

Brownlow followed and started a new paper, The Knoxville Whig and Rebel Ventilator, as fiery as ever.

As President Lincoln's The combative Brownlow successor, President Andrew Johnson backtracked on Reconstruction. Brownlow's enmity for his old political foe was reawakened.

> He supported Johnson's impeachment. He also shepherded Tennessee's re-admission to the Union, the first state of the former Confederacy to do so. Otherwise, he doesn't have such high marks as a politician amongst historians. Author Steve Humphrey called Brownlow's enfranchisement of former slaves "born of political expediency rather than from noble writings are both historic motivation."

When the war ended, Brownlow replaced Andrew Johnson as governor of Tennessee. He was reelected to that position in





There are more ways to score on defense than on offense, their reasoning went. In their day, the team that won the coin toss generally took the ball, unless there was some weather or other field issue involved. Consider what Russ

Bebb wrote about the 1954 season. "Almost unbelievably, Captain Darris McCord won the coin toss in each of the 10 games, and each time Tennessee chose to kick off." That came in a 4-6 campaign, the last for head coach Harvey Robinson before Wyatt came marching home.

"The conservative approach is fine with the public when the team is winning," added Bebb, "but it is bad news for the coach in a losing year."

In more recent years, the team that won the toss could defer taking the ball on offense to the second

Tennessee kicked off in the 1973 contest, and Wayne Wheeler caught an 80-yard TD pass from Gary Rutledge on the game's first play, The Vols recovered for a 21-21 tie going into the fourth quarter, but Alabama won going away, 42-21.

Twenty-two years later

immediately marched for started on the 20, when Peyton Manning found Joey Kent for another 80-yard score that set the tone for the Vols' first win over Alabama since 1985. John Ward said, "80 yards, Joey Kent... Touchdown... on Play... No. 1". The Vols won, 41-14.

When the Vols and Kentucky squared off in 1980, the Vols were in an offensive funk. In pre-game commentary, Ward asked Bill Anderson about the game, with Anderson replying he didn't really know what might happen. It had been that kind of season, with the Vols scoring but 28 points in the previous four games, all losses.

Willie Gault returned the kickoff 92 yards for a score, and the Vols won 45-14. Points for the Vols came in droves that day, much to everyone's surprise.

Just to show it wasn't a fluke, he ran the second half kickoff 95 yards for a score the next week, Tennessee 51, Vanderbilt 13. Ward said, "Willie Gault has run all the way to the State Capitol."

There are those who say the kickoff is merely a way to start the game, but how teams respond goes a long way in determining who wins, who loses, and why.






