County unveils monument to honor Tucker Blakely

The Knox County Sheriff's Office and the Powell Community honored one of their own early last week.

The county unveiled a stone memorial monument to honor fallen sheriff's deputy Tucker Blakely on Tuesday afternoon.

The monument is located at the corner of Emory Road and Brickyard Road, just one block from where Blakely attended high school and played in the Powell High band.

Blakely was killed in the line of duty on Oct. 2, 2023, while answering a domestic violence call, leaving behind his wife, Katarina, and son, Hendrik.

Blakely's widow spoke at the dedication, along with Knox County Mayor Glenn Jacobs, Knox County Commissioner Rhonda Lee and Knox County Sheriff Tom Spangler.

The sheriff was emotional in his bring back Daddy.

"When one of my officers, one of my deputies, gets hurt or makes the ultimate sacrifice, that's on me," Spangler said. "He won't be forgotten. All I can say is, 'I'm sorry, Tucker, job well done, young man. You served us well.

"This memorial means an awful lot to this community, but it also means a lot to the Knox County Sheriff's Office. This memorial here stands as a promise that we will never forget his courage, his kindness or the ultimate sacrifice he made to keep our commu-

"We can't take away the heartache from the family and everybody who loved Tucker," Commissioner Lee said. "We can't bring back the son. We can't bring back the husband, and we can't

"But one thing we could do is do something to remember Tucker."

Jacobs noted that Blakely's loss left a loss for the sheriff's office, the Powell Community and across Knox

"His loss is felt by this community and to all of Knox County," he said. "This serves as a message to his family that he won't be forgotten and that our men and women in blue step forward when others step back."

Katarina said that the memorial will forever honor Tucker's memory and serve as a spot where Hendrik can come and see his father.

"It's nice ... that'll be a memory for future generations who won't have known Tucker (and) their families that don't know him, thinking that they can come up here and see (this)," she said.

Knox 911 continues to expand

During the quarterly meeting of the Knox County Emergency Communications District (Knox 911) last week, Director Brad Anders brought the group up on current and future changes, and the members learned the organization is doing very

well financially. Anders noted several employees with 15 to 30 years of service and said the number of employees is growing with the addition of former AMR dispatchers. He also said that the call center continues to be temporarily located at the Knoxville Safety Center while the main building on Bernard Avenue is being renovated. He added that 14 to 16 new employees may be added in January and spoke briefly about a future automated computer answering service that may route emergency and

dispatch system, Anders said, may be joining the Tennessee Advanced Communications Network. Currently, the Knox County system's radios are in a Valley System that limits the organization in width and frequency. He said the TACN is spending \$8 to \$10 million on a new tower system on House Mountain, which would add 20 new radio channels.

"I don't see a downside," Anders said of the benefits of joining the state-wide system. He also noted that many emergency groups that belong to the 911 organizations are using "Phase One" telephones and will need to update to Phase



CDM Smith was also approved to do a design study of a greenway connection between the Fort Sanders neighborhood and Tyson Park in a \$980,770 contract agreement.

In an 8-1 vote, the council approved a \$10 million commitment for affordable housing if the November 4th sales tax ballot referendum is approved. Councilwoman Amelia Parker voted "No" and said the plans did not include more for low-income and homeless residents, and the proposal did not "address the total need."

meeting The City of Knoxville Rules of Procedure and Charter Review Task Force wrapped up its final meeting Tuesday afternoon with tweaks to a report for the city council.

Council attorney Rob Frost had suggested changing the name of a standing group from the Charter Committee to the "Charter Advisory Panel."

"Also, she seems to be of the opinion that she can talk to another commissioner about what she calls procedural issues and not substantive issues. I don't know whether this is an Eric Wiatr interpretation of the open meetings law, but it is clearly wrong," Buuck continued.



Danny Hutchins, an East Tennessee native and longtime band leader for Country Music Hall of Fame member Charley Pride, has been presented with Lifetime Membership in the Knoxville Songwriters Association.

Larry Cope, KSA president, and Randy Ott, past president, surprised Hutchins with the honor Oct. 14 when he was the lead performer at the group's annual music festival in the Fountain City Library.

Cope said Hutchins was recognized "for more than a halfcentury of musical creativity and leadership, excellence in performance on the world stage, and steadfast support of East Tennessee songwriters."

"Danny Hutchins generously shares with new writers his knowledge of songwriting and the music business," Ott said. "KSA members have learned a lot from him and appreciate his advice on how to improve our songs."

Hutchins, an Oak Ridge native, says he "started banging around on the piano when I was two." By the time he began playing music professionally at age 13, he had learned keyboards, guitar, bass

Young-Williams Animal Center, **Knoxville Fire Department** partner to help lost pets get home

Young-Williams Animal Center has partnered with the Knoxville Fire Department (KFD) to provide pet microchip scanners at Station 3, located at 204 E. Baxter Ave., and Station 17, located at 4804 Western Ave., as part of a new initiative to help reunite lost pets with their families faster.

Scanners are now available at both stations, giving community members a convenient and accessible way to check stray or lost animals for microchips. This initiative aims to quickly reunite lost pets with their families, who often live just a few blocks from where the animal was found.

A demonstration of the technology at KFD Station 17 today showcased how the scanners work with the goal of reducing the number of

animals entering the shelter system.

"These scanners are a simple but powerful tool to help get pets home faster," KFD Deputy Chief of Administration Robert Cheesman said. "Our fire stations are trusted community hubs, and we're proud to support this effort to reunite families with their pets."

The two stations were selected based on heatmapping data showing high volumes of stray animal calls in the surrounding neighborhoods. Most pets are found within a mile of their home, often just a street or two away, making neighborhood-based scanning a practical solution. Heatmapping is a graphical representation of

John G. Townsend of Delaware

Pages from the Past

was a reformer; while he served in the United States Senate, he was a stalwart conservative. A highly successful business entrepreneur, John G. Townsend was a towering political figure inside the First State as Delaware's governor during the First World and U.S. senator during the Great Depression

John G. Townsend was a

man of quite humble ori-

gins who made a fortune for himself and provided jobs for others. Townsend began his working career by becoming a relief telegraph operator for the Pennsylvania Railroad in his native Maryland. That caused the young man to observe that the railroad needed cross ties and pilings. The future governor gathered up pilings and crossties and sold them to the railroad. Eventually, he took his profits and organized and operated a sawmill to provide them. Townsend moved to Selbyville, Delaware, and began growing strawberries. Eventually, the crop and his business became so large, Townsend was referred to as the "Strawberry King of America." During his years in Washington, D.C., Townsend was well known for sending boxes of large, luscious strawberries to the members of Congress and the White House. To transport his strawberries to big refrigerated cars. Even pondering what to do with surplus strawberries led to another money-making enterprise. Townsend refused to feed the surplus strawberries to the hogs or simply dump them on

the open market. Walking

into a store in Millsboro,

Delaware, Townsend point-

ed to a bowl of vanilla ice

cream and asked, "How

would you like to have

to Delaware. Growing the tasty fruit caused Townsend to start his own bank, which became the second largest in Delaware. John Townsend continued to expand his agricultural holdings, raising chickens, growing soybeans and corn as well, which were feed products. Townsend also ventured into vegetable processing, and his company specialized in freezing peas and lima beans for consumption by American households. John Townsend was also

known to have the largest

While serving as green bean cannery in Delaware's governor, the world. Townsend was John Gillis Townsend Jr. one of the largest orchard owners in the country, the other being his senatorial colleague Harry F. Byrd of Virginia. John Townsend was

also credited by some in agri-business for the discovery of the usefulness of soybeans as fertilizer. Townsend had experimented with planting hundreds of acres of "worn out land" with soybeans and immediately noticed the soil was revived once the beans were plowed under.

Townsend's hard work and shrewdness gave him a reputation for having the "Midas touch"; every business he started became successful and made money. The life of John G. Townsend was a classic poor boy made good tale. The son of a farmer who also worked as a mechanic, Townsend's formal education ended in grade school. Townsend was known for several traits that came in handy both in his life as a businessman and as a politician. John Townsend was a truly friendly man with a warm personality. He was also known for having the courage of his convictions

John G. Townsend's success in business and interest in the Republican Party led to his nomination for the governorship in 1916. Townsend faced Democrat James H. Hughes, with whom he would later serve for four years in the United States Senate. Delaware was a genuine two-party state, and election contests were usually hard fought with either party having a chance of winning. John G. Townsend won the governor's race while every other Republican on the statewide ballot lost. Under Governor Townsend, Delaware adopted its first laws on clean working conditions for women, pensions for mothers, child labor, workers' compensation, and the creation of the State Highway Department during the first legislative session of his governorship. During the second session, Governor Townsend pressed the legislature and won approval of a commission for the Blind, Deaf & Mute, increased spending for highways, and created an entity which eventually became the Department Welfare. It was Governor John G. Townsend who created the budget system utilized in Delaware for decades after he left the chief executive's office. After leaving the gover-

nor's mansion in 1921, Townsend gave most of his attention to expanding his various business enterprises. Townsend was in Florida on a business trip in September 1928 when the Republican State Convention nominated him to run for the United States Senate to challenge Senator Thomas F. Bayard Jr. The Bayard name was one of the best-known in the state. Bayard was the son and namesake of a long-serving United States senator, ambassador to Great Britain, and secretary had won a seat in the U.S. Senate in 1922. The two senatorial candidates were a contrast in personalities and backgrounds. John Townsend had been born in Maryland and had risen from quite modest circumstances to become a very wealthy man through his business acumen. Bayard was married to a DuPont, perhaps the most famous name in Delaware; every inch an aristocrat and scion of inherited and mari-

The 1928 election was a true test of the former governor's personal popularity with the people of Delaware. It was a great year for Republican candidates, with Herbert Hoover winning the presidency in a landslide. John G. Townsend Jr. won just over 60% of the votes cast in the Senate race.

tal family wealth.

One of the newly elected senator's first legislative acts was to draft an amendment to give agriculture the same advantages under law as those granted to industry. It was the first act of its kind anywhere in the world and was crucial in creating the thriving agri-business in the United States. legislation enacted in the

new members of the Senate find their way to the committees where they have not only their interests, but also whatever expertise and experience they might have earned throughout life. That was true of John G. Townsend who chaired a committee on audit and expenditures, as well as having a seat on the Senate Banking Committee. Townsend's business connections and amiable personality made him a prodigious fundraiser for his party, and he became the chairman of the Republican Senatorial Campaign Committee, a post he continued to hold long after he had left the U.S. Senate.

During his service as a member of the United States Senate. Townsend was awarded an honorary degree as a Doctor of Letters by the University of Delaware, which amused

Townsend Senator ran for a second term in 1934 and once again faced Democratic attorney James J. Hughes. The senatorial contest was hard fought, with Hughes running as a supporter of President Roosevelt and the New Deal. Townsend was a critic of much of the New Deal, but was popular enough to buck the prevailing political tide and won with quite nearly 53% of the vote.

John G. Townsend was a candidate for a third term in 1940 and faced attorney James M. Tunnell, who had lost a race for the U.S. Senate in 1924. Townsend campaigned, as most incumbents do, on his record in office. The senator wryly noted a fact about politics rarely ever mentioned, saying, "Elections have been decided by those qualified to vote but who stayed at home on election day." Tunnell criticized Senator

Townsend, whom he described as one of the "most hardshelled, diehard conservatives in the U.S. Senate." Jim Tunnell accused Townsend of having opposed legislation beneficial to farmers, as well as the Social Security Act. In a radio speech, Tunnell narrowed down his

criticism of the senator's

record, noting "Senator

Townsend had fought the interest in the Republican New Deal program at every Party in Delaware or step of the way."

Townsend retorted, "I ever lose interest in him. make very few speeches. But I serve on more committees drafting bills than any other man in the Senate. And by serving, I mean I work." The senator noted he had been one of those who had written the appropriation bills for defense for the last five years. As to his record in the Senate, Townsend said it had been "built not on politics but on what I believe is best for the State of Delaware and for our country." The senator pointed to his having voted for a 33-1/3 percent increase in Social Security and ticked off a series of national bills and how they would affect the State of Delaware. It was to no avail as it was a Democratic year in the First State.

Townsend's sons were all involved in his many businesses, but the former senator still kept his hand in all of them. The senator also remained in Washington, D.C., much of the time in his capacity as chairman of the Republican Senatorial Campaign Committee. John Townsend was wellliked by his former colleagues, Republicans and Democrats alike. President Harry Truman demonstrated that when he appointed former Senator Townsend as an alternate delegate to the United Nations meeting in London in 1945. Townsend spent several months in Europe touring former battlefields and viewing the carnage and destruction left by the Second World War. Upon his return to the United States, Townsend said he held out great hope for the world through the United Nations.

John G. Townsend remained highly popular with Republicans in his home state of Delaware and was offered the nomination to once again run for the United States Senate in 1946. "I'm 75 years old," the former senator replied. "You'd better find a young-

In the SEC, events on or off the playing field often carry over into everyday life, all part of the rivalries - some ancient, dating more than 100 years, along with others of more recent occurrence.

There are figurative and literal lines drawn in the sand between seemingly rational and reasonable people, but also people who take the proceedings seriously.

Historically, Tennessee has had its hotly debated moments fans have never forgotten. Consider the missed field goal at the South end against Alabama in the rain in 1966 that sealed an 11-10 Tide victory.

Was it good or not? Charles W. Bowen, the referee that day, waved it off, and that settled that. Bowen did not stride to the center of the field and utter those famous words: "The previous play is under video review."

There's nothing like a quarterback Dewey Warren, who held for the decisive a much drier Cliff Hare kick, has steadfastly maintained, then and now, that Auburn, but that was just the kick was good. Often in error, but never in doubt, the saying goes.

Then there was the (supposed) completion to Jabar Gaffney that gave Florida a 27-23 win in 2000. Officials Steve Shaw and Allama Matthews discussed the play briefly before Shaw ruled the touchdown would stand. That decision resulted in a hail of projectiles from the lower regions of the North stands hitting the orange and white squares where the play finished. That was not a good look.

Both moments of controversy were followed by key wins the next year against the same opponents, with these supposedly negative events used as motivation.

Consider the afternoon the heavens opened over Neyland Stadium during the 1973 Auburn game, Tennessee leading 13-0 in a contest the Vols eventually won 21-0.

Whenever Tennessee got the ball in the monsoon, Vol head coach Bill Battle, acting on advice from Gen. Neyland's playbook, kept kicking the ball back, letting Auburn handle the slippery pigskin. That somehow offended the visitors, and they weren't happy again until the next year's game on the Plains

The score that day, at Stadium, was also 21-0, a coincidence.

After LSU ran two pass plays in four seconds against Ole Miss in 1972 to win 17-16, there was a sign on the Mississippi-Louisiana border that read: "You are now entering Louisiana. Please set your watch back four seconds."

Ole Miss publicists had a creative response to the game's outcome. The authors of the 1973 Rebel football guide listed the final score as "Mississippi 16, LSU 10 + 7."

Kentucky folks will never forget the ending of the 2002 LSU game. With but a couple of ticks left on the clock, the entire Commonwealth seemed poised to celebrate an upset win over the Tigers, including the team dumping Gatorade on head coach Guy Morriss.

As the game ended, LSU completed one of those "Hail Mary" passes for a score that shocked everyone in blue.

Someone in the Kentucky press corps headlined the frantic finish "Christian Laettner in Cleats," referencing the game-winning shot in the East Regional Finals at the Meadowlands in 1992, one that also sent the Commonwealth into collective apoplexy and Duke into the Final Four.
