### Early voting picks up in city election

Thursday was the halfway mark for early voting for five new Knoxville City Council members and the city sales tax referendum. As of Thursday, 5,112 people have voted with 651 of those coming as absentee or nursing home bal-

precinct leads the early voting with 1,535 people voting, followed by New Harvest Park with 976 voters. The Expo Center, which opened four days after other precincts began voting, had 605 voters. The City-County Building precinct had 501 votes, Eternal Life Church had 430 votes, and the South Precinct at Meridian Baptist The Downtown West Church had 414 voters.

"We are at the halfway point of early voting, and turnout has been over double what we saw through the first half of early voting for the City Primary. The referendum question seems to be driving a lot of interest, and I think steady turnout will continue all the way through Election Day," Chris Davis, administrator of the Knox County Election Commission, told The

Most of the attention went to council races in the Second and Fourth Districts. The overwhelming age range of voters to cast ballots was over 55. Slightly more females voted than males.

Early voting continues until Thursday, October 30, and the General Election is Tuesday, November 4.

### **Partisan politics** debate continues at Knox County **Commission**

Today's regular meeting of the Knox County Commission could see opposition to some commissioners' proposals that other commissioners view as partisan politics. The debate began during the agenda review meeting last week after motions by Angela Russell, Andy Fox and Rhonda Lee saw some push back.

Russell defended her and Fox's charter change suggestions dealing with

the use of the local Hotel-Motel Tax funds. She wants restrictions placed on the use of the funds going to non-profit organizations. She wants the nonprofits to undertake a pre-application audit, provide information on the organization's officers, and detail how any county funds would be spent.

Commissioner Damon Rawls pushed back and suggested a 30-day delay on the discussion and was critical of a Fox attachment to the Russell

### New subcommittee begins work on county ethics

The new Knox County Ethics Subcommittee met recently to begin the process of reviewing "Ethics Policy and Procedures" for

the next four months. Chairman Michael Bittel began the meeting by suggesting Krystal Gibson as vice chair, but she declined. Byron Wood was then chosen for the seat, and Steven Goodpaster was selected as secretary.

Bittel then explained what he saw as the "scope" of the review. Goodpaster said he has assembled lots of information on the Code of Ethics and said he would share it with the subcommittee. Attorney David Sanders

said he should send the information to the legal secretary, Rhonda Bennett, to be reviewed and sent to the other members rather than sharing

it directly with them. Sanders then spent several minutes talking about the Sunshine Law, which prohibits members from discussing any related business outside a public meeting. The members asked several questions about how they could communicate with each other, one suggesting an online public forum such as the Knox Commissioners have, but Sanders reminded them they could not reply to suggestions or comments on the website. Bittel went over the



### How does the county sell property below what is owed in taxes?

The Knox County Insolvency Committee met Monday briefly to approve a request to sell county-acquired property below the taxes due. The board, chaired by Commissioner Terry Hill, heard Ben Sharbel of the Procurement Department explain the process.

county acquires the property, and Sharbel said that the property is usually held for three months to a year before the county conducts a surplus sale. Each sale must be approved by the Insolvency Committee to permit the property to be sold for less than the back taxes owed.

The Knox County Commission's consideration of a rezoning request for seven dwelling units per acre, an increase from two units originally requested, has been postponed until November. Benjamin C. Mullins is representing the request for the 205 North Wooddale Road property, which was before the commission's zoning session in September and then again on the meeting agenda last week. The planning commission has recommended

**Knox County's Oldest Cemetery**

In a quiet, picturesque setting on Asbury Road east of downtown Knoxville at the merging of the French Broad and Holston rivers lies the oldest cemetery in the county and the site of some of the earliest Christian worship

This is the site of Lebanon in the Fork Presbyterian Church, which was organized in 1791. For a year or two before the church was organized, Rev. Samuel Carrick, the first pastor, had been preaching outdoors to congregations in the area. He had come from Virginia to establish Presbyterian churches on the frontier. J. G. M. Ramsey, in his pamphlet "History of Lebanon Presbyterian Church 1791," described Rev. Carrick as "the strange ambassador for Christ to the pioneers of Tennessee, and the frontiersmen of the West, whose was 'The voice of one crying in the wilderness, prepare ye the way of the Lord, make his path straight."

A grove of cedar trees and the location in the fork of the rivers gave rise to the name of this outpost of Christianity.

Rev. Carrick went on to become the pastor of Knoxville's First Presbyterian Church and president of Blount College, later called the University of Tennessee.

The congregation continued to grow and included all Presbyterians in the area, including Adair's Station, four or five miles above First Creek, and all of the Holston and French Broad rivers.

The congregation continued to meet outdoors until the first church building was built in 1812. That first building was

constructed from unhewn logs, without a window or a door. It was located a little west of the latest building. When the congregation outgrew this building, services were held again outdoors in the surrounding cedar grove. As the congregation grew, nearby landowner Colonel Frances Ramsey donated nine acres of land on which a 40-by-60-foot building of hewn logs was built. Ramsey was also one of the first elders in the church. The building was covered with shingles and had a floor. There was one small window near the pulpit without a sash or shutter. This crude edifice was replaced by a stone building in 1808. When the stone building began to deteriorate, another building was built in 1848. It served the congregation until the latest building was built in 1902. That building was destroyed by fire in 1981. The bell in the center



### District 1 candidates answer Focus questions

Early voting is underway as ten people vie for five seats on the Knoxville City Council. District 1's Tommy Smith has chosen not to seek re-election and Karyn Adams and Becky Jones are seeking that South Knoxville seat. The Focus asked them four questions and their verbatim replies are below.

#### Should city council races be by political party?

Karyn Adams: The City Council races are non-partisan, meaning candidates don't identify themselves with a particular party. The races have been non-partisan since the early 1990s. These remain the only nonpartisan races in the City, and I can say as a candidate and as a citizen, I believe they should remain so. Nonpartisan races allow all voters (and candidates) to focus on the issues that voters are most concerned with - for example, housing availability, speeding on their street, sidewalks, or keeping their neighborhood park

require a political party to address. monies raised through the proposed They need a councilperson who is actively engaged in the district and city and who takes the time to listen and understand. Almost every door I have knocked (on), and that's thousands of households throughout District 1, have expressed relief and appreciation that this is not another "us vs. them" political race, but instead, a community-driven and community-focused one. Becky Jones: Yes, it will boost voter

turnout and enable voters to make more informed decisions.

#### Do you favor the proposed halfcent sales tax increase?

Adams: It's important that every voter understand that the only thing the City's proposed .2 percent sales tax has to do with the City Council elections is that it is on the ballot at the same time. None of the candidates currently running for City Council have any additional sway or say in this tax proposal. My vote, like every citizen in District 1, counts the same - one vote. When I look

up to snuff. These aren't issues that at the City's proposed use for the tax - sidewalks, affordable housing, park improvements, and infrastructure - these are uses I am personally aligned with. So for my one vote, yes, I will most likely vote in favor. But as a candidate, it is not my job to persuade people to vote on this measure in either direction. My job is to listen and ask what people in the district and the city are thinking. Thus far, the biggest concern expressed is not about the tax but about the follow through. How can the public be sure that the City will follow through and spend monies as promised. If the proposed tax passes, I am committed to holding the current administration and future administrations accountable for fulfilling these promised infrastructure improvements. If the tax fails, I am committed to working with the City and community to find alternative ways for funding ongoing infrastructure needs.

Jones: No. Any candidate unable to provide a clear yes or no on this critical issue should not be taken seriously by voters.



### The Gentleman From Maryland Senator John Marshall Butler

Today, with the occasional exception, Maryland is a solidly Democratic state, especially on the federal level. The last time a Republican was elected to the United States Senate from Maryland was 1980, when Senator Charles "Mac" Mathias was reelected. During the decade of the 1950s, the Free State had two Republicans representing it in the U.S. Senate. Most of the Republicans who got elected to public office in Maryland were more moderate than solidly conservative. The exception, at least to some degree, was John Marshall Butler. When referred to as a member

I thought the liberal elements were straying pretty far from the concept of constitutional government that had been taught me. When the former senator died, the Baltimore Evening Sun published an editorial acknowledgnewspaper described as vice in the First World War, of John Marshall Butler. having been won due to "a shamefully manufactured smear against" the incumbent. Yet the Evening Sun stated it was frequently overlooked that Senator Millard Tydings "had dangerously neglected his Maryland political roots" and made himself vulnerable to a serious challenger. As a person, "not even liberals who knew John Butler could bring themselves to dislike him," the newspaper admitted. "His views were rigidly orthodox, his creativity limited," the editorial stated, but Butler was also a man who possessed "a warm human touch and a personal straightforwardness which caught and held the affection even of those profoundly in disagreement." The Evening Sun editorial readily confessed

Rather, Butler was a senator "who paid close attention to the interests of his state, particularly to its economic linchpin, the port of Baltimore, its shipyards, and the American merchant marine." Many senators, feeling the weight of the world upon their shoulders, were beaten in the next election simply because they seemed to forget the worries of the folks back home.

Butler's intense devotion to Maryland's interests was described by the shipping correspondent for the London Times, who thought the senator was "the foremost champion in the United States Senate of the American shipping and shipbuilding industries."

Tall, erect, a man of striking personal appearance, John Marshall Butler looked like a United States senator. At 14, John M. Butler sold newspapers and got a job in a mattress factory, and earned money to send himself to Johns Hopkins University and the University of Maryland Law School. Butler married Mary Louise Abell, whose great-grandfather had helped to found Baltimore's Sun newspapers. During his time in college, Butler was both a scholar and an where he enlisted in the 110th Field Artillery of the 29th Division. Upon returning home to Maryland, he returned to his studies but had to quit again to help his ailing father in the elder Butler's real estate business. John M. Butler studied law at night and earned a degree from the University of Maryland Law School. Butler joined the firm of Venable, Baetjer & Howard, becoming a part-

ner in 1939. Prior to 1950, John Marshall Butler had enjoyed the life of a successful and prosperous attorney. The Butlers had three children, two boys and a girl, and Butler's only public service was as a member of Baltimore's Civil Service Commission. Few gave Butler much of a chance to defeat the venerable and formidable Millard Tydings in 1950. Even Franklin D. Roosevelt had found it impossible to dislodge Tydings from the Senate. Senator Tydings had been one of the more conservative Democrats who had incurred the displeasure of President Roosevelt. Roosevelt sponsored Congressman David Lewis to challenge Tydings inside the Democratic primary in 1938 and visited the Free State to speak on

his behalf. FDR was embar-

rassed when Tydings won

Butler began the 1950 campaign as an unknown and faced David John Markey in the GOP primary. Markey had been the Republican nominee for the U.S. Senate in 1946 and quite nearly beat Governor Herbert O'Conor, losing only by 2,232 votes out of more than 470,000 cast. John M. Butler actually lost the popular vote in the Republican primary to Markey by 1,889 votes, but as Maryland used a county unit system to determine the winner (rather like the Electoral College), Butler

won the nomination. The 1950 elections were rough on a number of Democrats seeking reelection to the United States Senate. Both the majority leader and majority whip were defeated in reelection bids, but perhaps the biggest political upset of the night was John M. Marshall Butler's victory over Millard Tydings by more than 43,000 votes. It was a GOP year in the Free State in 1950, with Theodore McKeldin, a Republican who had been popularly elected as the mayor of Baltimore, winning the governorship. McKeldin was a more moderate Republican, and the two men would find themselves on opposite ends of the fight between Senator

Robert A. Taft of Ohio and

Dwight D. Eisenhower for the Republican presidential nomination in 1952. Governor McKeldin backed Ike while Senator Butler touted his friend Bob Taft.

Senator Tydings challenged the result of the election, seeking to oust Butler from the Senate for having used unfair means to defeat him. The Senate, controlled by Democrats, seated John M. Butler. As a member of the U.S.

Senate, John Marshall Butler was a staunch anticommunist, sponsoring the Communist Control Act, which would have outlawed the Communist Party in the United States. Butler's bill would also have allowed those organizations infiltrated by Communists to be prosecuted. Senator Butler was a strong supporter of the Constitution amendment proposed by his colleague, John W. Bricker of Ohio, which would have limited the president's authority in foreign affairs which was then won by interviewed by a reporter by requiring the approval of George Mahoney. Senator Butler was a conservative during his time in the United States Senate on the national issues coming before that body. Butler supported civil rights as he believed every person had the right to vote under the Constitution. The senator was insistent that taxpayers receive fair value for the expenditure of their tax dollars. Plain-spoken, Butler was never shy about expressing his views, but his concentration upon the parochial interests of his state made him popular with Marylanders and a difficult target for Democrats. There was hardly any industry important to Maryland that did not receive help from Senator Butler and his office during his 12 years in the Senate. Butler was also highly popular amongst some unexpected groups, like the longshoremen, due to his support for the shipping industry, so vital to the Maryland economy.

His defeat in the 1950 election rankled Millard Tydings, who never got over his loss. The former senator resolved to try and win back his seat in 1956 with both men girding for a bitter rematch. Tydings only narrowly beat George Mahoney, a contractor who had lost two races

for the U.S. Senate and

two gubernatorial races.

George Mahoney had a strong appeal for working-class Democrats, and while Tydings was no born aristocrat, the former senator certainly had, over the years, acquired something of a lordly manner and lived that way as well. Tydings and his wife, the daughter of former ambassador and attorney Joseph Davies, who had been married at one time to the richest woman in the world, Marjorie Merriweather Post, heiress to the cereal fortune, lived on a large estate in Havre de Grace, Maryland.

Tydings was stricken with what was publicly announced as an attack of shingles, but was actually encephalitis, an inflammation of the brain. By 1962, Senator John M. Butler was tiring of political life. Every indication pointed to his being able to win a third term in the Senate if he ran. Troubled by a few physical ailments, the 65-yearold Butler announced he would not seek reelection. Butler's announcement in December 1961 stunned his own party and Maryland Democrats as well. Senator Butler mysteriously said "compelling personal reasons" had caused him to come to the decision not to run again. Butler had earlier suffered from a virus that doctors had a difficult time managing, while the senator had a fever that ran as high as 105 degrees. "My eleven years in the Senate have been the most satisfying of my life," Butler said in a statement to the press.

Maryland Republicans were panicked by the idea that Senator Butler would not run again and begged him to reconsider. Newspapers reported the senator was giving thought to becoming a candidate again. Shortly before the filing deadline, Senator Butler reiterated his decision not to seek reelection. "I must abide by my

Free State Republicans had hoped Butler would run again, along with former governor Theodore McKeldin, seeking to return to the statehouse. McKeldin, away in New York to make a speech, told a reporter Senator Butler's decision not to run again "makes the prospects for

me less attractive." In 1964, former Senator John M. Butler accepted the post of state chairman for Maryland of Barry Goldwater's presidential campaign. Butler and Goldwater had served for a decade together in the U.S.

Senate. After his retirement, Senator and Mrs. Butler moved to a condominium in Cross Keys Village, where he enjoyed playing gin rummy and still occasionally made speeches at Republican get-togethers.

Butler disliked the idea of special interest groups and how candidates for public office had to try and woo them to win an election. "I said what I thought, and they either voted for me or not," Butler said.

The former senator and Mrs. Butler traveled by automobile to St. Simon's Island off the coast of Georgia, where they enjoyed a vacation in March 1978. The couple was on the way back to Maryland when they stopped off at a Rocky Mount, North Carolina, hotel. Once in the hotel room, John Marshall Butler suffered a massive heart attack and died.

Prominent members of the community, as well as Revolutionary War soldiers, are buried in the cemetery. One of the earliest graves in the cemetery is that of

Elizabeth Carrick, wife of the pastor. She died in 1793 at the time an Indian attack was expected upon Knoxville. All the men of the community had gone to defend the city. Therefore, the women of the community took Mrs. Carrick's body in a canoe down the Holston River to the cemetery and attended to her

George McNutt, one of the first elders of the church, is buried there.

A large section of the cemetery is dedicated to Colonel Ramsey and his family, including his son, J.G.M. Ramsey, who was a historian and Confederate treasury agent, and the colonel's brother, General John C. Ramsey, who served the Confederacy in the Civil War.





### November 1959: A memorable Homecoming Day triumph

The game came a week after eventual Heisman Trophy winner Billy Cannon's historic Halloween night punt return earned LSU a 7-3 win over Ole Miss. That game was barely over before Tiger coach Paul Dietzel began worrying about the game in Knoxville, a venue where his teams had never won during his time at LSU, Army, and South Carolina.

It was Homecoming Day, with the temperature dropping into the 20s and LSU having to send out for extra gear. A crowd estimated at 47,000 showed up, including members of the 1914 SIAA championship squad led by head coach Zora Clevenger. The Vols were 4-1-1 coming in, with a loss to Georgia Tech and a tie with Alabama marring their

While LSU had dotted the Vol schedule infrequently over the years, Tennessee fans still had the 1959

The day was Nov. 7, game circled prominently a two-point conversion try 1959, when LSU came on their calendars. The Vols early in the final stanza had already knocked off No. 3 Auburn in September, and this was a chance to show that Tennessee was "back" after 1958's 4-6

> The week of the game, Knoxville radio personality Bill Ross penned a prophetic ode: "LSU, who are you? You won't be first when the Vols get through!"

> The game was a classic case of LSU letting the underdog Vols hang around until the guys in orange took advantage of two major breaks in the third quarter. There was an interception linebacker Jim Cartwright (Athens) returned for a touchdown. Then followed a fumble recovery by fellow linebacker Ken Sadler (Livingston), leading to a touchdown run by fullback Neyle Sollee (Jacksonville, Fla.). The quick explosion of points excited the capacity crowd.

Cotton Letner, a native of Ten Mile located south of head coach Bowden Wyatt's Kingston hometown, knocked home the winning extra point, just as he had booted the winagainst Auburn.

Dietzel's worst fears were realized as the Tigers full force. went home on the short

and held on the rest of the way. Bill Majors (Sewanee), Wayne Grubb (Athens), and Charlie Severance (Knoxville) made the play at the northeast corner. Sports Illustrated ran a photo of "The Stop" the next week. Many Vol fans consider this the most famous defensive play in school history.

Urban legend exists that the failed two-pointer cost LSU the game. Not so. LSU had three possessions afterward, one in Tennessee territory and two near midfield, but could not overcome the deficit. In 1987, Charley McClendon, a 1959 LSU assistant, said it was a no-brainer to go for two. Looking back, there was considerable time left, plenty of time to get back to the end zone or kick a field goal.

The win over LSU was the last win of the decade of the 1950s, as the Vols dropped their final three games, to Mississippi (37-7), Kentucky (20-0), and Vanderbilt (14-0), who won in Knoxville for the first time in 22 years. A 5-1-1 ning field goal weeks earlier team quickly became a 5-4-1 team and the famed "Gay Street wolves" were in

game would be the Vols' worst defeat the week after their greatest victory. Kentucky had been a thorn in the Vols' side the entire decade with a 6-3-1 advantage, even after the Vols had opened the decade by winning in 1950 and 1951. Vanderbilt won twice in the decade, in 1954 and 1959.

The decade had started out strong, with a 29-4-1 record from 1950-52, in Gen. Neyland's final three years at the Vol helm. In 1953 and 1954, Harvey Robinson found out quickly that following a legend was not the way to fame and fortune.


