KCS celebrates academic growth, recognizes reward schools

In an event that was meant to both inform and celebrate, Knox County Schools honored 18 reward schools at an event at Lonsdale Elementary School last Wednesday.

The annual meeting was held at Lonsdale because that school was removed from the state's critical list.

The event celebrated four consecutive years

of growth for the district, which was designated as a district in need of improvement by the state just four years ago. That designation meant that Knox County Schools ranked in the bottom 5% of districts in Tennessee.

"Four years ago, Knox County Schools was a district in need of improvement," KCS Superintendent Dr. Jon Rysewyk said.

"That was unacceptable."

"For the next two years, we focused on our four core priorities. We raised expectations, and we made progress."

The work paid off as the district received a rating of satisfactory. Rysewyk was pleased, but knew the district wasn't quite where it wanted to be.

"We made improvements,"

Council passes \$9.4 million for police department

The Knoxville City Council, in an 8-1 vote, approved \$9,407,699.82 in additional funding in a contract with Axon Enterprises Inc. on Tuesday. The "goods and services" within the agreement include additional drones, cameras and video equipment and services in the amended 10-year contract.

Councilwoman Amelia Parker opposed the agreement, which Mayor Indya Kincannon claims will "allow all officers to have what they need." Parker tried to delay the vote until a study is released with results from other cities trying out the drone-video method. She disagreed with the \$3.7 million per year agreement.

"We rushed into a contract last year and are now being asked for another increase," Parker said, and tried unsuccessfully to delay the vote in order to have a public hearing.

Police Chief Paul Noel told the council meeting, "We've been very open."

In the meeting, Mayor Kincannon announced that the police department is up to full strength.

The council members had several questions and comments, including Charles Thomas, who noted that the drones will not film while flying to dispatched locations, and all

footage not involved in a crime would be erased after 15 days.

Parker had several questions and was given an additional five minutes to ask them. She wanted to know about operational and redaction policies, if the drones had license plate readers or facial recognition capabilities and who would operate them.

Kincannon replied that most of Parker's questions have been answered. Noel said the drones would not be used for surveillance.

Also passed in an 8-1 vote was an increase to the city's contract with Highstreet IT Solutions for services to transfer data to Oracle Fusion Cloud ERP on a request from the city's Innovation and Technology Department.

Postponed for two weeks was a \$60,000

funding of six community-based organizations after Councilman Denzel Grant questioned some of those chosen by the Office of Community Safety and Empowerment. He questioned why some of the smaller non-profit groups were not included.

The council moved to deny, in a 7-2 vote, a request for a zoning change from RN-2 to RN-4 residential at 1137 Simpson Street. The townhouse development decision came after Councilwoman Karyn Adams said it would mean a character loss in the neighborhood.

Commission ironing out new electronic voting process

The recent zoning session of the Knox County Commission was the first public meeting where members utilized electronic voting. Until now, all votes during meetings have been verbal, spoken by each commissioner as their names were called. The new system will be used for the first time in a full commission meeting today.

Chairwoman Gina Oster apologized to the audience in the session held in the small assembly room.

"I'm sorry, everybody, we're just learning the electronics," she told the meeting, adding, "This is our first live meeting, so we're just being a little slow, so we apologize."

"And we're out of sorts, we're not in the main meeting room," she added. Due to the Martin Luther King Jr. holiday on Monday, the commission's regular

meeting was moved back a day and to a different room, as the city council has the main assembly room every other Tuesday.

Oster then opened the voting, and shortly said, "There's time if you want to change your vote." She then announced voting was closed and announced that the zoning change request passed, but no total count was given.

The Focus asked Oster some questions and asked for a statement.

"I felt like the electronic voting went well, being our first time using it in a meeting and being in the small assembly room since we are usually in the main assembly," Oster replied. "Also hosting our junior commissioners for their first meeting. We had a lot going on, but I felt like it went very well."

Can the commissioners see how the other commissioners vote as the vote is being taken?

"We open the vote and

commissioners vote, then I allow a change of vote for commissioners and then close the vote. Everyone

can see the voting live."

Why isn't the total vote announced if there is one

Geopolitical Intrigues

The enemy of my enemy is my friend.

A friend selected this week's topic when he asked my opinion of President Trump's focus on Greenland. Despite the ongoing insurrection and fraud in Minnesota, the world has moved on from Venezuela, Iran, Gaza and the Ukrainian "killing fields." Now everyone is talking about Greenland. Trump even explained it to the Davos Devotees.

I'm no geopolitical expert. I'm just a retired doctor with an opinion column in a local newspaper. But, I enjoy researching a topic and learning, so here's what I discovered about Greenland and why we should be interested in that huge, frozen island, dubbed a land, but it "sure ain't green."

I was mystified by Trump's interest in Greenland, but the simple answer is geography. Greenland is "on the northern frontier of

the Western Hemisphere" and lies between us and Russia across the Arctic Circle.

Norsemen from Norway settled the southern part of Greenland in the 10th century when the climate was warmer during the Medieval Warm Period, 900-1300 AD. (Tell Al Gore there was no industrialization then, proving his infamous CO2 hockey stick chart was bogus.) Presumably, it was warm enough 1000 years ago for some greenery, so Norseman Eric the Red used this fact to encourage settlers. Viking descendants lived there for 400 years, but left when the Earth again cooled. Inuit peoples arrived in the 13th century, and their descendants largely comprise the current 57,000 population.

The island is an autonomous territory of Denmark because Norway ceded Greenland to Denmark in 1814. During WWII, the US controlled Greenland to prevent a Nazi occupation.

Because of its strategic location, President Trump says we foolishly gave it back to the Danes after the Second World War. I agree, but hindsight is often better than foresight.

Greenland is covered with ice, and the small shrimping industry is insufficient to support the islanders. As a result, the territory is supported by Danish subsidies of 600 million dollars a year. There are claims that Danes have abused the islanders and consequently, a strong independence movement exists. NATO provides Greenland's security. And since the US is in NATO, we provide security against Russian and Chinese military ambitions in the Arctic region, including Greenland (Danish Defense Intelligence Services data). Does anyone think Denmark or the European Union could or would defend Greenland against Chinese and Russian aggression? If you believe that, I have swamp land in Florida I'd love to sell you.

I don't believe President Trump is planning to use force to acquire Greenland. In fact, he said so in Davos, Switzerland. So the media can stop clutching their pearls. He is using leverage to gain a strategic advantage in Greenland. Trump reported that his meeting with the Secretary General of NATO went well, and a deal regarding

Greenland is in the works. Consequently, Trump canceled the upcoming tariffs, and the stock market surged.

Russia already has extensive bases in the Arctic, and Trump wants to keep Russia out of Greenland. The president has plans for a missile defense shield (Golden Dome), which will protect North America and Europe from the ballistic missiles of a rogue state like North Korea. Expanded surveillance systems in Greenland will therefore be needed. Bill O'Reilly has written that we also want to establish a submarine base in Greenland. Furthermore, Greenland is crucial to ocean shipping lanes. And there is also the issue of rare earth minerals in Greenland, crucial for tech and AI, but Trump says this is less of an issue than security.

The outcry against Trump is largely from Democrats and elitist, priggish Europeans who hate President Trump. I'm making generalizations, and of course, there are exceptions, but many European leaders despise Americans whom they consider upstarts. Europeans especially bristled that Trump cajoled them into paying for their defense. The EU has a population and economy comparable to the US, but it has depended on the US to pay for its defense. And Trump warned them about

depending on Russian oil and gas for their industries and economy, which have suffered as a result. Furthermore, buying Russian oil and gas has funded Putin's war in Ukraine.

I now further digress into a bit of history for geopolitical context. In 732, at the Battle of Tours, the Frankish (French) king, Charles Martel, defeated a Muslim invasion of Europe. Then in 1571, the Venetian navy defeated the Ottoman Empire fleet at the Battle of Lepanto, again blocking the Muslim invasion of Europe. Without these two rejections, we might all be speaking Arabic. How odd that current European leaders allowed myriads of Muslims into the EU, who, like illegals in the US, resist assimilation. Although Muslims make up a small percentage of Europe's current population, by having more children than Europeans, they will ultimately replace the indigenous European population.

If you still doubt the importance of geopolitics, the UK's prime minister, Starmer, will soon surrender the critical Indian Ocean base, Diego Garcia, to Mauritius, which "has a close trading relationship with China." The base was integral to Midnight Hammer, our destruction of the rogue state of Iran's nuclear facilities. I pray the Brits' 50-year lease is as

solid as our Guantanamo base lease in Cuba, and our guys will be able to use the base.

You might think this essay's header quotation was a reference to Euro bros who oppose the Trumpster. It is actually a reference to the red-green alliance. And you say, What is that?

Intersectionality is the association of diverse and even oppositional perspectives that nonetheless align against a common enemy. It is because their common enemy is Western Civilization, America and, of course, President Trump, the defender of both.

Affordability Problems Caused By Democrat Big Government Policies

Democrats all over the country are gleeful because of one word – affordability. They seem to believe that if they shout this word enough, it will stop the downward slide their party has suffered over the last several years.

However, they should not celebrate too soon. A CNN poll on December 18 said Democrats in Congress have never rated as low as they are now, with a minus 55 number, meaning unfavorable in the high 70s as opposed to favorable ratings only in the low 20s.

Even longtime Democrat consultants Ruy Teixeira and John Judis wrote a book about three years ago entitled "Where Have All The Democrats Gone?"

They wrote: "In the past few decades, the Democratic Party has undergone a seismic shift. Kitchen-table issues like the economy and public safety

have been overshadowed by more elitist topics like identity politics, gender ideology, defunding the police, climate change, and the vaguely defined yet rigidly enforced ideology of anti-racism, which sees white supremacy as the force behind every institution in America."

What the Democrats don't seem to realize, or wouldn't admit even if they did, is that they are the ones primarily responsible for making everything so unaffordable.

First, the Democrats for many years have been a socialist party that has never seen a department or agency to which they would not give big spending increases. They have led this nation into a \$38 trillion national debt. They also have caused many state and local governments to go deeply into debt, too.

All this wild spending has led to almost unbelievable inflation, causing most things to cost many times more than they did 25 or 30 years ago. Can you believe there are pickup trucks that cost almost \$100,000?

Inflation and the fact that government at all levels has taken and continues to take more and

more private property have made houses unaffordable for most Americans, especially young couples. The high taxes in Democrat-run cities and states, and less and less private property even in Republican-run cities and states, mean that new houses have to be built on postage-stamp-size lots and that more people are being forced into apartments and townhouses.

Crowding more and more people into smaller and smaller living areas means less privacy and more traffic and crime and disputes between neighbors.

Too many politicians have proudly created or expanded parks. We now have so many thousands of local, state and national parks and recreation areas that most are hardly used and will not be used unless we find some way to put our entire population on permanent vacation.

Also, sometimes I have seen stories that say "Judge saves land from development." They should read "Judge makes it harder for young people to buy homes." The same should be said for nature conservancies that always leave life estates for the donor's family, but then leave out

other young people.

These donations also mean less property on the tax rolls at the same time that teachers, firefighters and police want more raises, which means that taxes have to keep going way up on remaining private property.

What Democrats and socialists do best is take what is a very minor problem for a very few people and turn it into a major problem for everyone. There is no better example of this than what the federal government has done in regard to healthcare.

If there was one lesson I could get through to students, it would be that on anything the government subsidizes, costs are going to explode. You just don't have the same pressures or incentives to hold down costs and operate efficiently that are in the private sector.

Before the mid-1960s and the creation of Medicare and Medicaid, medical care was less than five percent of the GDP, and almost everyone could afford it. Now it is approaching 20 percent, and only people like Bill Gates, Warren Buffett, Jeff Bezos and major college football coaches can easily afford it.

During my first term in Congress, I was invited to speak to an American Medical Association meeting in Colorado Springs. The then head of the AMA said in his talk that he had told his members they should not oppose Medicare because "doctors would get their share." And, boy, have they.

I play golf with several doctors, and when I told one of them this story about Medicare, he said, "It's made us wealthy." In every government program, there are always some who get rich while most end up paying a lot more than they get back.

Thank goodness we don't buy food the same way we pay for medical care. The only way we can ever hope to bring down medical costs would be to get the government out of the way and get it back to being between the doctor and the patient, but unfortunately, there's no hope of doing this unless or until the whole system collapses.

I could give many other examples, but I will stop with just one more. It shocks students at the University of Tennessee when I tell them it was just \$90 a quarter when I started there in 1965. The Democrat leader, Rep. Steny

Hoyer, said the University of Maryland was just \$87 a semester when he started there a few years earlier.

People could work part-time, as I did, and pay all their tuition. Nobody got out of school with a debt unless they bought a car or partied all the time. Then, colleges and universities started pushing the student loan program, and now students get out owing many thousands, and college presidents and administrators make some of the highest salaries in this country.

Student loan debt has grown to more than a trillion and a half, and an article in Reader's Digest a few years ago was entitled "Student Loan Slaves". I saw one study several years ago that said college and university fees were 450 percent higher than they would have been if there were no loan program. Most students think it is one of the best things that ever happened to them; actually, it is one of the worst.

As Ronald Reagan and probably many others have said, if someone says they are from the federal government and are here to help you, watch out.

Mrs. Haslam was also known for working with Maryville College, Child and Family Services, the Tennessee Arts Commission, the Great Smoky Mountains National Park, the Webb School of Knoxville, and the Junior League of Knoxville.

Natalie Haslam was also a member of St. John's Episcopal Church and was the mother of three daughters, stepmother of three children, and the loving grandmother of six grandchildren, and the proud great-grandmother of seven great-grandchildren.

Natalie Haslam meant so very much to her husband and family, but she also meant much to our community. Throughout her long life, Natalie Haslam remained generous, always giving freely, not just money but also of herself. Mrs. Haslam's was a life well-lived. Most importantly, throughout her life, Natalie Haslam radiated the music that can only be generated by love for family, friends, Knoxville and East Tennessee. It is a tune that will continue to ring in the ears of her family and friends for the rest of their own lives. There is no greater gift than that.

and we reached a rating of satisfactory, but we weren't satisfied with just being satisfactory," he said.

KCS now has a top rating from the Tennessee Department of Education, but Rysewyk, while happy with the designation, said that the district wouldn't become complacent.

"We're still looking for ways to improve," he said. "It truly takes a village."

He also noted that the improvements would not have been possible without the teachers, principals,

families and the Knox County Community.

"This is a result of the hard work of our teachers and our principals and the hard work of our students," Rysewyk said. "To our families, you are your child's first teacher, and we don't want to replace that. We appreciate you trusting us with your children."

The district's annual report was released at the event and made available to those in attendance and Rysewyk vowed to remain transparent about the school system's efforts to

improve.

"This doesn't happen in every community in the state," he said. "We're here today to celebrate the success of our schools, but we're also here to tell you what we're doing."

"But this doesn't happen in every community. This is not required by the state."

Road closure request disputed by neighbor

It’s seldom that a partial road closure becomes a dispute between neighbors. When the Knox County Commission meets in regular session, the request of Larry and Emily Gray to close a portion of Wye Way Lane, off of Alcoa Highway, is on the agenda. During the commission’s agenda review meeting last Tuesday, the proposal saw some opposition.

During the agenda session, 9th District Commissioner Andy Fox asked two neighbors to speak on the requested closure of that dead-end portion of the neighborhood road. Larry and Emily Gray of 4604 Wye Way Lane made the closure request, and Jacene Witzel, representing her father, Maynard Witzel of 4631 Wye Way Lane, spoke.

The Grays said they lost property to the state with the expansion of Alcoa Highway, and said they want the road, starting at their property, to be closed so they can build another home. Ms. Witzel said closing off the road would hinder fire protection to her father’s home downhill from the Gray property.

The Grays said that Witzel has his own driveway for fire truck access.

Asked about the closure request, Engineering and Public Works Director Jim Snowden said the matter should actually go through his department, but made no recommendation on the outcome.

At-large Commissioners Larsen Jay and Kim Frazier voiced some concern about closing that part of the hilly road. The commission is scheduled to meet this afternoon at 5 p.m.

the School for the Deaf in Texas. He recalled how the school was on the same parade route as JFK. He settled in Knoxville in the sixties and dedicated his talents to the University of Tennessee, leaving a lasting impact through his commitment to education.

Bill’s fascination with puzzles took root in childhood and flourished in his retirement, where he spent time in a studio at the Museum of Natural History in Murfreesboro, demonstrating and teaching the art of jewelry making. During the COVID-19 pandemic, he found joy in assembling puzzles alongside his wife’s caregiver while

his wife enjoyed her reading. The largest puzzle he tackled was a remarkable 2,000 pieces, with most of his challenges ranging from 1,000 to 1,500 pieces. Now, his desk is filled with a stack of puzzles, each one waiting to be brought to life.

Currently, he is captivated by three dimensional puzzles, which he describes as “tactically irresistible.” Bill has even created a working pinball puzzle and intricate puzzles that involve 75 pages of instructions, showcasing his dedication to the craft. He actively encourages fellow residents to engage in activities like puzzles, believing they are “vital for keeping the mind sharp.”

Bill believes puzzles are “something of value and very enjoyable.” Moreover, he views puzzles as a fantastic way for children to remain engaged and steer clear of screens.

“It has to be more than just exercise,” Bill believes; he sees it as an opportunity to “invigorate the mind.”

His hope is to inspire others to explore passions “beyond Bingo or watching TV.” Bill connects with fellow residents and engages in conversations with those facing Parkinson’s or Alzheimer’s, passionately fostering their involvement and encouraging them to view puzzles as a meaningful journey towards therapy.

Politics and religion return to county commission agenda

If last week’s Knox County Commission agenda review meeting is any indication, it appears that much of today’s regular meeting will include personal politics and religious beliefs. The debate about national and state issues will probably continue to dominate future meetings.

Commissioner Andy Fox wants to present his “A Christian’s Biblical View of Illegal Immigration,” and Commissioners Damon Rawls, Larsen Jay and others may object.

In last week’s agenda review, Fox argued that most people’s view of the Bible’s stance on immigration may be wrong, and Rawls said Fox is not an ordained minister and he, Rawls, opposes such a presentation.

Jay said that immigration is no part of the commission’s powers and the Fox presentation is not a voting matter, adding, “You are opening Pandora’s Box.”

Fox replied that state and national resolutions are pending on Illegal Immigration, and that the

commission has broad powers, adding that Knox County “has 25,000 people living here illegally.”

Another resolution on the agenda is from Commissioner Rhonda Lee, who wants to affirm “local discretion with proposed laws and responding to School Board Legislative Priority # 6.” She described the resolution as helping to detect illegal alien children in local public schools and supporting state legislation on the issue.

Commissioner Courtney Durrett objected to the proposal, saying such matters fall under the power of the local school board, which has already voted to permit all children to attend school.

“As a body, it is not appropriate for us to take a position,” Durrett said. Lee replied that she wants the state legislature to know the position of the commission. Should such a state law pass, it apparently would either restrict attendance based on proof of citizenship or require tuition from alien students.

Knox County Law Director David Buuck called

Lee’s resolution a “moot point” and added, “We have no power over the public schools.”

Chairwoman Gina Oster noted there is no such current state law and said she was told by state Representative Jason Zachary that should the state pass a similar bill, the federal government could pull its \$1.2 billion funding from the state.

Buuck told the commission he “cannot imagine the state or Congress is going to take away free public school attendance.”

Rawls said passing such a resolution could open up the county to damages. Fox said that the education of alien children is not in the state constitution, which simply states “free public schools.”

Lee has another resolution recognizing the U.S. Constitution during the nation’s 250th Anniversary, and that discussion has been deferred to their June meeting. Fox’s motion to urge the sheriff’s department to take part in the 287(G) Task Force Model has been moved to February’s commission meeting.

The Knox County Commission meets today, and several senior centers may get additional funding from the state. The resolutions, on the agenda's general consent calendar, would be funded with additional money from the state Department of Disability and Aging.

Son Ryan Tyree shared a story of a 1993 sleepover at a friend's home and an accident he had when he had his learner's permit. He said his father handed him the keys afterward and told him

Bo Roberts, then president of the 1982 World's Fair, told stories of Tyree's FBI service and shared fond memories of the two of them being members of the Swine Tastes club many years ago.

Setting Direction Before the Drive

In 2026, most of us would never begin a long drive to an unfamiliar destination by simply pulling out of the driveway and hoping we figure it out as we go. The days of Rand-McNally grid maps are over, and before the car even moves, we enter the destination into a GPS. We wait for it to load. We listen to the first instruction. Only then do we begin the journey. Psalm 143:8 reflects that same instinct, but for the soul. David is not asking God to redirect him after he is already lost.

He is asking for guidance before the day begins. He is essentially saying: "Let the morning bring me word of your unfailing love and please show me the way I should go." Like a driver pausing to set the route, David pauses his heart long enough to hear from the One who knows the road ahead. This verse is not a call to rush into productivity or problem-solving. It is an invitation to pause. To stop long enough to hear that inner voice that desires to lead us. David is

asking for one thing before the day unfolds: a word from God that specifically reminds him he is loved. Not because the circumstances have changed, but because God has not. Practically speaking, this means we do not have to start our day with answers. We can begin it with assurance. Before opening a social media app, checking an email, scanning the news, or replaying yesterday's worries, we can take a quiet moment, perhaps just a sentence-long prayer, and say, "Lord, let me hear Your love this morning." That may look like reading a single verse slowly. It may mean sitting in silence for sixty seconds

or listening to some heart-stirring worship music. It could be as simple as reminding yourself, God's love for me is not fragile today. Small practices, done consistently, shape how we carry the day. David also says, "For in thee do I trust." Trust here is not emotional certainty; it is a daily choice. Some mornings, trust feels strong. Other mornings, it feels like a decision made with trembling hands. Both are still trust. Practically, this might mean naming one thing you cannot control and consciously placing it in God's care rather than rehearsing it all day. I love the language that says, "Cause me to know the way wherein I should walk." In other words, "Lord, show me the way I should go". This isn't a demand for a complete roadmap; it is a request for the next faithful step. It is waiting for the next GPS turn. Often, God does not reveal the entire path, but He will make the next step clear. Sometimes that step is a conversation you have been avoiding, a task you need to finish, or simply choosing patience over frustration.

Then in the latter part of that verse, David says, "for I will lift up my soul to thee." What he is saying is that he entrusts his life to God. He is releasing the burden of having to carry everything himself. We can do the same in very practical ways: by refusing to shoulder guilt that God has already forgiven, by asking for help when we are overwhelmed, or by allowing ourselves to rest without apology.

Psalm 143:8 reminds us that mornings do not have to start with pressure. They can begin with presence and many times with praise. A moment of trust. A word of love. A quiet surrender. You may not know everything that today holds, but you can know who has you. And sometimes, that is all the strength the morning needs.

Soup and a hug

Before I begin, I'd like to offer an apology to my editor for any and all errors that might be contained in the draft I send her. A couple of weeks ago, I had cataract surgery on my left eye. Next Wednesday, I'll have the other eye fixed. Right now, it's difficult to deal with one good eye and one bad. I see clearly out of my left eye, but my right eye is fuzzy. So, right now, I have to wear my glasses to type or read, but my repaired eye's sight is blurred when I have the spectacles on. I'm told that before long, both eyes will clear so that my sight is laser sharp.

All of this preface is given to state my amazement at the medical procedures of today. When I was a boy in grade school, our neighbor underwent cataract surgery. I don't recall how long he stayed in the hospital, but for several days, he lay flat on his back with sandbags on either side of his head. They were so placed to keep him from moving his head at all. Doing so could have damaged his eye permanently.

My experience was much different. I arrived at the doctor's office at 7:00 a.m., so that staff members could prepare me for surgery. Like always, no food or water was allowed after midnight, so my stomach growled loud enough for nurses to hear. An I.V. was set up before rolling me into the operating room. I remember seeing the doctor for a couple of seconds. The next thing I recall was being asked if I wanted something to drink. Before noon, I was home and snoozing the afternoon away. That evening, I attended choir practice.

Amy suffered from a gallbladder ailment early in our marriage and came out of surgery with three small incisions. In a couple of days, she was home. My cousin, on the other hand, was sliced wide open when her gallbladder was

removed. On one trip to Isle of Palms, my dear wife spent a woeful night battling nausea and pain. At some point in the early morning, we zoomed to the hospital. Her appendix had gone "kaput." The doctor there didn't want to operate until the blood thinners that she took were no longer problematic. By the end of the week, she was pumped full of antibiotics and pain meds, so we traveled home. The doctor at Parkwest Hospital said the appendectomy shouldn't have been delayed. The next morning, he operated, and late that evening, we drove home.

Joint replacements shock me. Knees and hips are swapped out of folks' bodies. As soon as they are awake, patients are walking in the hallway. After an initial physical therapy session, folks are shipped out of the hospital with therapy dates for the coming weeks.

The most unbelievable thing to me is the short stay in hospitals for new mothers. When Lacey was born, she was jaundiced, so for a week, Amy and Lacey stayed in the hospital so that my daughter could spend time under a light to cut back the overabundance of red blood cells.

These days, moms go in, suffer through hours of torturous labor, deliver a baby, and head home the next day. That seems to be a cruel way to treat new moms. They should have at least a couple of days to recuperate before going home to begin months of little sleep, dirty diapers, and early morning feedings.

I'm sure that future medicine will be much more advanced. Those in the medical profession one hundred years from now will look on surgeries of today as butchery. I suppose that illnesses will be cured with unthinkable new devices and medicines.

Our medical gains have been overwhelming in the last twenty years, and I'm sure they will continue to improve each year. I just hope that those treatments to come include a bowl of chicken noodle soup and a hug from a loved one. Medicine heals the body; soup and a hug soothe the soul.

Pages from the Past

Andrew Jackson May was a colorful Democrat whose career was derailed by corruption. The backwoods lawyer from rural Kentucky was one of the fiercest critics of the Tennessee Valley Authority in the House of Representatives. May was a man who relished holding power and did not hesitate to use it. During his time in Congress, Andrew J. May rose to become chairman of the House Military Affairs Committee, a position that gave him great power, especially after the United States entered the Second World War. Yet that committee chairmanship would also help to bring him to ruin.

The most widely read news magazine in the world, TIME, noted that Congressman May "reveled in having generals at his beck & call." Should "a 'warm friend' or a good constituent" want "a favor (perhaps a war contract, perhaps a son sent to O.C.S. [Officer Candidate School]), Andy would pick up a phone, summon the official to his office, and arrange it on the spot."

Solidly built and balding, A. J. May was elected the Commonwealth's state attorney several times, sat as a judge of the circuit court and had business interests in coal and banking. May ran against Congresswoman Katherine Langley, a flamboyant woman who had taken the place of her husband in the House of Representatives after he had been forced to resign. Mrs. Langley was popular in her own right, and when May contested the 1928 election, he lost to the Republican incumbent. Two years later, May ran again and with Kentucky, like the rest of the country, suffering from the Great Depression, he won a narrow victory in the general election.

Another challenge awaited the freshman congressman when he was forced to run statewide as Kentucky's legislature had failed to redistrict, meaning every candidate for the U.S. House of Representatives had to run at large. Andrew J. May made an impressive showing in the 1932 election, running second out of nine inside the Democratic primary and fourth in the general election.

May's district contained several Republicans, and while he continued to be reelected every two years, he did not win general elections with the usual majorities associated with longtime or powerful incumbents. In 1942, Republicans did well in the midterm elections, and Andrew J. May won his reelection campaign by only 540 votes over Republican Elmer Gabbard. In a rematch two years later, with Franklin D. Roosevelt at the top of the Democratic ticket, May

increased his margin by more than 3,000 votes.

During his first term, Andrew J. May arrived in a House barely controlled by the GOP. The House majority was close enough that it switched due to a number of deaths, including that of House Speaker Nicholas Longworth. Following the 1932 election and the beginning of Franklin Roosevelt's presidency, Andrew May became a solid supporter of the New Deal.

Congressman May represented a district that produced coal, and this was the basis of his opposition to the TVA. May reasoned that with more electric power, there would be less need for coal. TVA adherents in the House had to overcome the adamant opposition of several congressmen like Andrew May and Andrew Edmiston of West Virginia, who put coal before anything else. A coalition of opposition composed of Republicans and conservative and coal state Democrats proved to be a formidable obstacle for the supporters of the Tennessee Valley Authority in the House of Representatives. It often-times fell to Tennessee's powerful Senator Kenneth McKellar to rescue TVA from its opposition in the House.

While many believed May did a good job as chairman of the House Military Affairs Committee, he was not immune to making blunders, some of them quite serious. Congressman Andrew J. May horrified most of official Washington when he returned to the Capitol following a visit to the war zone. The garrulous congressman let it slip that American submarines usually survived attempts by the Japanese Navy to destroy them because their depth charges exploded well before coming close to the submarines. Unfortunately, May made his statement at a press conference as chairman of the House Military Affairs Committee. Once his comments were public, it soon became readily apparent the Japanese read American newspapers as well and had adjusted their depth charges to explode at a far deeper depth. The commander of the U.S. Navy's submarine fleet in the Pacific theater of the war, Admiral Charles Lockwood, thought May's loose lips had been responsible for the loss of perhaps ten submarines and the deaths of as many as 800 seamen. "I hear Congressman May said the Jap depth charges are not set deep enough," the admiral growled. "He would be pleased to know that the Japs set them deeper now."

An obscure, hardworking, unassuming United States senator from Missouri came to national

attention through his chairmanship of the Senate War Investigating Committee, which rummaged through paperwork, witnesses, and a myriad of details to uncover corruption and waste in contracts related to America's war effort. The notoriety gained by Harry Truman as head of the committee, which became known as the "Truman Committee," helped to catapult him into the vice presidency and ultimately into the White House. It was through the former Truman Committee, then headed by Senator James M. Mead of New York, that something odd came to light as it sifted through the Garsson munitions company's records. TIME reported there was "talk of packets of \$1,000 and \$3,000 sent" to the congressman from the Garsson Washington office. "There was the peculiar circumstance that May had endorsed a check as the president of the Cumberland Lumber Co., which the Garssons paid for lumber that was never delivered or even cut," the news magazine noted.

Congressman May bleated it was all a political smear. Yet the pressure brought about a sudden heart attack. May hurried back to his home in Prestonburg, Kentucky, and tried to get himself reelected.

May remained holed up at his home in Prestonburg, and May's doctor announced the congressman was too ill with heart problems to be able to go and vote. Dr. John Archer described May as being in "critical condition," although the congressman remained at home rather than a hospital. Dr. Archer opined that May might never be able to return to Washington, even if he were reelected.

Senator Mead told newsmen, "We are willing to wait patiently until Mr. May is well enough to testify, but we want to hear his story when he is ready to tell it."

After his lengthy service in the House of

Representatives, it soon became clear Andrew J. May had lost the confidence of many of his constituents. The congressman was opposed by the United Mine Workers' union.

After sixteen years in Congress, Andrew Jackson May lost to an unknown Republican, 34-year-old returning veteran, Howes Meade. Meade's victory had been overwhelming, as the newcomer garnered quite nearly 60% of the votes cast and carried all but two counties inside Kentucky's Seventh Congressional District. Congressman May carried only two counties and only barely carried his own county of Floyd.

Enough voters believed the charges against May to have voted him out of office. Worse was to come for the former congressman when a grand jury indicted his good friends Henry and Murray Garsson, as well as the Garsson company's business agent in the Capitol, Joseph F. Freeman. They were indicted for having conspired to defraud the government of the United States. Former Congressman Andrew Jackson May was accused of having taken \$16,000 in checks and cash from the Garsson brothers, as well as arranging for the payment of \$53,634 more. It was the equivalent of almost \$1.2 million today, a sum which astonished many of the folks in May's former congressional district.

May traveled back to Washington, D.C., where he pleaded not guilty and issued a perfunctory statement saying he was sure to be vindicated. The former congressman was required to sign a \$2,000 bail and meekly asked, "My heart is hurting me-- can I sign something and go to my hotel?"

On July 3, 1947, Andrew J. May was convicted by a jury of having accepted bribes as chairman of the House Committee on Military Affairs. Murray and Henry Garsson had

been charged with excessive profits from contracts steered to their company by Congressman May, and there were accusations that the company had manufactured defective mortar shells, which led to the deaths of American soldiers.

Among those who attested to May having sought favors for the Garssons was General Dwight D. Eisenhower and Secretary of War Robert Patterson.

"I was superintendent of a Sunday school and taught Bible class in Kentucky. I have never tasted liquor, wine or beer, and I have never used tobacco in my whole life," May pleaded. "I have never received a dollar that was not honestly earned."

Andrew May contended he and the Garssons had gone into the lumber business together to supply much-needed box lumber to the Garssons' munitions business. May insisted he had only been the manager of the Cumberland Lumber Company. The government retorted that the Cumberland Lumber Company had never shipped "a single stick of timber to the Garssons." May insisted he had paid it all back, "every cent of it," or had spent it on the plant of the Cumberland company.

May, seemingly unable to accept the jury's verdict, appealed his case to the United States Supreme Court. When the high court refused to hear his case, Andrew J. May went to prison at age 74, sentenced to serve eight months to two years. May was incarcerated at the federal prison near Ashland, Kentucky, roughly 60 miles from May's home in Prestonsburg. Judge Henry A. Schweinhaut had refused to consider giving the former congressman a more lenient sentence, snapping, "The integrity of the national Congress is at stake."

The former congressman served only nine months before being released. George G. Killinger,

chairman of the Federal Parole Board, acknowledged the former congressman had been granted a parole. Killinger said May had an "outstanding record" while in prison and that the former congressman had been "a wonderful influence on fellow inmates." While in prison, Andrew J. May worked at the prison library.

Ironically, it was the same man who originally headed the committee that helped to ferret out the information of May having accepted bribes that gave him a pardon. President Harry S. Truman pardoned the former congressman in 1952. That same year the Kentucky Court of Appeals restored Andrew J. May's license to practice law, which he had lost upon his conviction.

Not everyone was forgiving. The Paducah Sun-Democrat published an editorial questioning the accolades bestowed upon Andrew J. May and took issue with House Majority Leader John McCormack of Massachusetts, who had said the people of May's former congressional district remained proud of him. The Sun-Democrat reminded its readers that the voters of Kentucky's Seventh Congressional District had "rejected him by an overwhelming vote when May ran for reelection while under indictment on the bribery charge."

The editorial stated it had no wish to "belabor a criminal whose case has already been adjudged by a jury of his fellow citizens," but protested the attempts "to honor a man who patently dishonored himself and his high responsibilities" which made the editor "a bit sick at the stomach."

For the rest of his life, Andrew J. May loudly proclaimed his innocence. The former congressman lamented he had lost his life's savings in defending himself and that he had been prosecuted for the sake of political expediency.

The 84-year-old former congressman was admitted to a hospital suffering from a kidney infection and "other complications." May's condition continued to deteriorate. Andrew J. May died September 6, 1959.

The former congressman retained some of his personal popularity in a few counties of his old congressional district. When he died in 1959, Governor Lawrence Wetherby and Bert Combs, the Democratic nominee for governor that year, attended May's funeral rites in Prestonburg.

Jayson Berlin is Knox Schools’ longest-running Athletic Trainer

The profession of a high school athletic trainer could involve life or death, since his or her arrival could be the first on the scene.

On the other hand, it’s much more likely to be a career filled with lifelong friendships and a lot of thanks and respect from those students who received his or her help when injuries occurred.

Our spotlight today is on 52-year-old Jayson Berlin, who is employed by the Knoxville Orthopedic Clinic and is Knox County Schools’ longest-running AT. He’s now in his 18th school year. He chose Austin-East High to work at out of four or five other Knox County schools.

His workday starts around 2:30 at A-E, depending on the sport.

In pre-COVID, the athletic trainers would begin their workday at the KOC office. “We either put on braces or did home exercise programs,” said Berlin. “It was time we had to spend outside of the school at KOC. We do not go to the office anymore. We come straight to the school.”

The end of his workday depends on the sport. After the girls’ and boys’ basketball games, he’s usually through at 9 o’clock.

“For Friday night football, we could work until 10 or 11 o’clock,” said Berlin. “It all depends on the season, the sport, the location

you’re at.”

Jayson never knows what the day will have in store for him.

“Never, and that’s the thing I like about it,” he said. “It’s something

that’s repetitive and the same thing over and over like an assembly line.”

The quieter the better, too, in Berlin’s work days.

“Usually if it’s a hectic day, something drastic has happened,” he said. “And I say this to the kids all the time: I love my job, and I really hate working, because when I’m working, somebody is really hurt.”

Berlin went to Oak Ridge High School and played various sports, including football and wrestling. He attended East Tennessee State University and earned a bachelor’s degree in athletic training in 1997.

Before he came to Knox County in 2007, he had worked in his field in Greene and Cocke counties for seven years and was the first athletic trainer at Cocke County High.

Berlin works with all of the sports at Austin-East. He said football or basketball keeps him the busiest.

His worst and busiest day as an athletic trainer at A-E?

“I would say the busiest was probably a late night traveling to Chattanooga for a football game,” said Jayson.

“One of the terrible ones was an injury coming out of Gatlinburg-Pittman on a football Friday night about five or six years ago, and we had a young man hurt. They had

to load him into an ambulance. We are trying to play a game. The ambulance took a while to get to UT, so I'd say that was probably stressful because it was a fairly bad injury."

So Berlin said he's been blessed as far as catastrophic injuries or anything like that.

"Yes, I was here the day the shooting happened," he said. "Was that a stressful day? Without a doubt. Then the boy got killed here at school. I mean, I've lost a lot of kids from my time here ... I can't count, but I've been to a few funerals."

"I'm here for the community, the kids – athlete or

not – I mean, I've dealt with teachers, faculty, parents. Again, it's not just athletes. If somebody is hurt; even on the other team, I'm here for them. And I think a lot of people know that."

One incident like that occurred just last Wednesday. Berlin was working the Carter at Austin-East boys basketball game, and a Carter cheerleader was hurt as she fell on the floor during a timeout.

The Carter athletic trainer had reported earlier that he wasn't feeling well and would not be at the game, so Berlin was aware of it and checked on the girl the same way he would

have with one of his own student-athletes.

Earlier that night, Berlin wrapped one of his players' ankles and also had to attend to another with a pretty bad bloody nose.

"If a fan at the game has a problem, we help them too," pointed out Berlin.

"For an athlete or any kid, the hardest part is the injury."

"My biggest reward is to see kids come back from an injury."

"I've loved this job. It's been a blessing. The community's great. I wish more of the positive would be seen outwardly."

My wife and I visited campus the other day and simultaneously came to a disconcerting conclusion. Progress has hit the Vol campus. There are new buildings dotting the landscape. Many campus landmarks are gone.

There's little evidence that a basketball arena ever graced the corner of Volunteer and Lake Loudoun Boulevards. It was called Stokely Athletics Center, and some of the best college basketball ever played in Knoxville was contested within those walls.

I also remembered that there was one part of Stokely Athletics Center where I hadn't been and I never will. I had always made plans to visit, but never pulled the trigger to do so.

The site in question is the broadcast area over the arena's east side from which John Ward and many other luminaries called the games. The first game was against Michigan in December 1966, through to the finale against Georgia in February 1987. And many more in between.

The Vols won the inaugural and finale, thus giving a touch of symmetry to the history of "Good Old Stoke," the title imprinted on a large, remarkably detailed photograph last seen hanging in David Grim's office.

The Stokely broadcast perch was unique, suspended high over the arena floor, giving new meaning to the term "birds-eye view." There were times the term was literally true, as birds of all feathers would occasionally have to be shooed out of the arena by someone in authority.

The "birds-eye view" appellation should not be confused with "Byrd's-Eye View," Ben Byrd's daily column in the Knoxville Journal in those long-ago days.

In much smaller arenas, the radio broadcast location might have been on the floor, or even worse, at the back of the lower level of stands at mid-court. At the Armory-Fieldhouse, the broadcast locations were at the top of the football bleachers that comprised one side of the court. Not at Stokely, however.

Consider that the broadcast area was up the steps through the east stands, row-by-row, to the top, probably row 60 or higher, then across a metal walkway to the broadcast area.

Making the trip to the broadcast area was almost like traversing one of those rickety bridges spanning the looming chasm in "Indiana Jones." You looked down at your own peril, someone said, as you carefully inched along the catwalk.

It was a "great location," Ward once said of the view from high above, adding that it "offered a better vantage point."

"When I do broadcasts, I prefer to be working upstairs because I can see the game unfold better," said Ward. Thinking back, in the case of Stokely, there's upstairs, and then again there's "upstairs."

Walking through the halls of Stokely, with or without making the trek onward and upward, it was easy to close your eyes and hear Ward's calls of the memorable moments of Tennessee hoops echoing through the miracle known as the "mind's eye."

"You walked, sir!"

"Did he make it? He MAAADE it!"

"Ernie G from Tennessee!"

"KINGGGG of the Volunteers!"

"Willie B of Millen GI!"

The Cignetti Problem

Well, Curt Cignetti just screwed up the coaching system...

Unless you've been sitting under a rock for the last couple of years, you know the story.

Curt Cignetti, a former Alabama assistant coach under Nick Saban, had been a head coach at Indiana University of Bloomington, Elon University and James Madison. Following the 2023 season, he was hired to be the head coach at Indiana, the losingest team in the FBS.

Going into the 2024

season, the Hoosiers were 502-717-46. They hadn't won a bowl game since 1991. Two years later, Cignetti has Indiana at the top of the college football world. Indiana just put the capper on a 16-0 season, with a Big Ten title, dominant playoff wins over Alabama in the Rose Bowl, Oregon in the Peach Bowl, and then a national championship victory over Miami... in Miami.

This was no fluke. Cignetti built a battering ram in Bloomington. This is the new Alabama, a team that runs roughshod through opponents,

a new version of bullyball. Certainly, having a Heisman Trophy-winning QB in Fernando Mendoza helped, but it isn't like that roster is stocked with 4 and 5-star talent. This is a team that has gone 27-2 over the last two seasons.

And what Cignetti has accomplished has completely changed how college football fans view their programs.

From the end of the 2024 season to the end of the 2025 season, there have been over 30 coaching changes in the FBS, an absurd amount of turnover. Major programs like

Penn State, LSU, Florida and Auburn fired their coaches and brought in guys that they expect to achieve big things in the years to come.

But if Cignetti can turn Indiana into a national champion in only two seasons, why can't everyone achieve big things in a short period of time? In this new era of unlimited transfers and NIL, a roster can change overnight. Development is not as important as talent acquisition.

Fans of programs across the country who have been trained to make their

donations and buy their season tickets and parking passes and be patient aren't willing to "trust the process." They want to see results, and they aren't content to wait very long anymore.

In Tennessee's case, Josh Heupel is heading into his sixth season as the Vols head coach. He's accomplished a good amount, including wins over conference rivals Alabama and Florida. They've played in a major bowl game, beating Clemson in the Orange Bowl following the 2022 season, in which UT was ranked 1st for a week in

the playoff rankings. They also earned a spot in the 2024 CFB playoffs.

But 2025 was, by most accounts, a down year for Tennessee football, and the pressure on Heupel starts to increase. The 2026 schedule is much tougher. Schools are more willing to pull the trigger on a coaching change much faster today than they were in the past. Buyouts are not always a deterrent.

Curt Cignetti has changed college football ... and it's up to his counterparts to keep pace.

Brian Tate is the player with the most experience on Bearden Middle School's boys basketball roster.

Tate, an eighth-grade point guard, was around when the Bruins won the championship last season, and on Thursday night, he played like a savvy veteran as Bearden routed South-Doyle, 61-28, in the second round of the Knox County Middle School Basketball Conference Class AAA Tournament in West Knoxville.

"Brian is the one guy back from our championship team last year, and tonight he did a good job helping us after we got off to a slow start," Bruins' coach Ben Zorio told The Focus. "We're a young team, and Brian and his experience really helped us.

"He played well on offense, and he also played well on defense."

To say that Bearden got off to a slow start is an understatement. The Cherokees were hot out of the gate, scoring the first seven points of the contest and opening a 7-0 lead when Mason Talley scored just before the midway point through the first quarter, forcing Zorio to call a timeout.

The Bruins finally got onto the scoreboard with three minutes left in the opening frame when Aiden Reed made a free throw with three minutes remaining in the opening frame.

Shortly after scoring Bearden's initial point of the game, Reed was saddled with foul trouble and relegated to the bench for the remainder of the first

"Koi played well," Zorio said. "We rebounded well, and we played well on defense.

"LJ Fedor came in ... really came in and gave us a big spark, particularly defensively,"

Myrion Huley paced the Cherokees' attack with 11 points on the night.
