Knox County changing its zoning terms

The Unified Development Ordinance (UDO) now being developed for Knox County will, among other things, change the zoning

code terms and zoning districts.

Allison Mouch, a consultant from Orion Planning + Design, hosted an online presentation Tuesday to explain the proposed changes. More than a dozen people joined the public session,

and the next will be scheduled for February.

The final recommendations will go to the Knox County Commission in May.

Mouch said the idea is to be as transparent as possible and

get input and questions from the public.

Tuesday's session dealt with zoning and focused on four types of land use: walkable compact growth, suburban growth, rural areas and other areas.

Some of the proposals include changing the names of zones, such as turning AG (agricultural) into AR (Agriculture Rural). Other new category name changes suggested included RR for rural

Committee assignments, mental health on Tuesday council agenda

When the Knoxville City Council meets on Tuesday, several council members and citizens will be assigned to various committees and boards.

Mayor Indya Kincannon wants to reappoint Dennis Murphy and Ben Ream and appoint Jack Coker to the Better Building Board. She will also reappoint Will Dorsey, Mark Grayson and Ashley Beals Pace to the Public Arts Committee.

Council members being named to boards and committees by Vice Mayor Lynne Fugate include Nathan Honeycutt to the Pension Board, Doug Lloyd to the Golf Course Advisory Committee, Debbie Helsley to the Knoxville Zoological Gardens board, and Denzel Grant to the Public Property Naming Committee.

The full council will select members and chairs for both the Rules Committee and the Audit Committee.

Six community-based organizations could receive \$60,000 from Empower Knox Youth Mental Health, and \$650 in Neighborhood Small Grants Program

funds for community-building support could go to the Western Heights Neighborhood Association and the Old Sevier Community Group.

Leland C. Hume and the West Hills Community Association are appealing a ruling of the Board of Zoning Appeals, which decreased the minimum lot width for townhouses on Gallaher View Drive.

The Citywide Traffic Signal Maintenance Project may award \$150,000 contracts to three companies, and the Salvation Army may get \$205,000 in Homeless General Funds for plumbing repairs and improvements at the Joy Baker Center and Hope Manor.

The East Magnolia Avenue Resurfacing Project may see stamped crosswalk replacements, new green bike lane markings and traffic signal upgrades in a \$109,563 agreement with the state.

Applications for two state and federal government grants are on the agenda for improvements to Gov. Ned McWherter Park and Suttree Landing Park.

Knox 911 director reports to board

Brad Anders, executive director of the Knox County Emergency Communications District, reported to the board recently, detailing various efforts and updates within the system. He highlighted employees with at least 15 years of service and also said that six new people have been added to the call center.

Anders also said that seven new team members are in class and may be added in March.

The director said a local delegation will meet for breakfast on February 20 at the Bernard Street center for an update on supporting Senate Joint Resolution 0048, which would increase the 911 surcharge on telephones to \$1.86, up from \$1.50. Senator Becky Duncan Massey is a sponsor in the Tennessee Senate, and state Rep.

Michele Carringer carries the proposal in the state House.

Anders also praised the Knox County Emergency Medical Service's Nurse Navigation Program, which he said responded to 4,926 calls last year. He noted that 2,427 calls were resolved outside the EMS system, and 1,383 callers received services without going to the Emergency

Room.

The call center, Anders said, is getting new console furniture in March, and equipment is being tested. Currently, the 911 call center is temporarily located in the Public Safety Complex and, after testing, will move back to Bernard Street.

"We will be adding a quiet room on our main level as well as a new

Mother's Room and some fitness equipment," Anders told the meeting.


Financially, the Emergency Communications District is in good shape. The audit has been completed and submitted to the state with "no findings in the audit," Anders said, noting that the 2027 budget is being planned with a focus on continued facility improvements, technology upgrades and increased training for the staff.

Over the next 12 to 24 months, the system, according to Anders, will be focusing on real-time transcription and translation, looking for a partnership with the Tennessee Advanced Communications Network, finding an AI-based product to allow non-emergency calls to be answered virtually, and adding more alarm companies that would report directly to the 911 system.

Loons, Scofflaws and Anarchists

For the mouth speaks what the heart is full of. Jesus Christ (Luke 6:45)

I've never been to Minnesota. Until recently, most of my awareness of that part of the country came from watching the Minnesota Vikings professional football team and listening to Garrison Keillor's "Prairie Home Companion." Keillor introduced me to the land of 10,000 lakes through his imagined small town of Lake Wobegon, "Where all the women are strong, all the men are good looking, and all the children are above average." It's sad this idyllic place doesn't exist, but sadder is that many like me now envision the land of 10,000 lakes as the land of 10,000 loons, at least in Minneapolis. Hopefully, there will be some "de-escalation" of the conflict between ICE and the loons, scofflaws and anarchists.

After calls between Minnesota's Governor Walz,

Minneapolis Mayor Frey and President Trump, there should be agreement that illegal criminals in custody will be released to ICE, instead of the street. Seems pretty straightforward, though, at this writing, Frey continues to posture for his Somali handlers and leftist base, and Walz's newfound spirit of cooperation remains suspect. I will go out on a limb and make a prediction: if Walz and Frey continue to waffle and fail to do what is lawful, President Trump will invoke the Insurrection Act and restore law and order.

If there had been Minnesota political leadership and police cooperation with duly authorized federal agents, it would not have been necessary for federal officers to go into the streets and re-arrest criminals convicted of rape, pedophilia, homicide and more. There would have been no protests, riots, assaults on ICE officers,

road blocks or people shot by officers.

A scofflaw is a "contemptuous law breaker." There should be no debate that criminals should be arrested. And by definition, illegals have broken immigration law. Therefore, a criminal illegal is subject to arrest under federal and local law. You may disagree with a law, but you do not have the right to refuse a law without consequences, including arrest and prosecution. It would seem that "Mogadishu-west" is rife with scofflaws. How can the misguided notion of protecting criminals instead of citizens be logically defended?

I'm glad for the reported "de-escalation," but I'm curious why Walz suddenly called President Trump. At issue are 1300 criminal illegals currently jailed in Minnesota (470 have already been released in Minnesota). Local and state police should cooperate with ICE, allowing agents of the Department of Homeland Security to be withdrawn since they will no longer be needed as backup for ICE enforcement.

Perhaps Walz and Frey have concluded that they are losing the political argument. UT law professor Glen Reynolds recently described a frightened squid squirting ink into the water as a metaphor for

Minnesota politicians using the ICE protests to obscure fraud investigations. Apparently, these investigations and the recent Department of Justice subpoenas for Walz, Frey and others have made a difference. However, I believe the discovery that members of the Walz administration were using The Signals Network to allegedly coordinate protests in Minneapolis is an even bigger issue. (The Signals Network is an "online means of communication.") Furthermore, 5000+ donors connected to the network were "indexed and exposed," which brings me to my next point for consideration.

Anarchy is "a state of lawlessness or political disorder due to the absence of governmental authority." The absence of Minneapolis police to control protesters attacking federal agents fits Mr. Webster's definition.

Have you ever wondered about supposedly "spontaneous" protests? How do protest leaders seemingly show up with bullhorns, the protesters sport matching shirts, carry professional signage and have protest gear including gas masks, shields, etc.? This takes coordination and money. Make no mistake: these sham protests are well funded by the George Soros organization and

others.

Recently, Bill O'Reilly introduced me to tech mogul and communist Neville Roy Singham, who now lives in Shanghai and funnels millions to the Democratic Socialists of America and radical groups in Minnesota involved with the anti-ICE protests. In fact, Singham-allied groups are planning a "nationwide shutdown targeting schools and businesses" for Friday, January 30. This is not "organic activism." Vice President JD Vance agrees, tweeting on X about "engineered chaos" in Minneapolis.

But there's more to this tangled web. I recently learned about "nudge" technology, where behavioral responses are engineered by governments, political parties, politicians, NGOs (non-governmental organizations) and especially the media to "trigger" responses. The concept originated with Richard Thaler and Cass Sunstein in 2008. The perspective is that people's decisions are "shaped by emotional triggers rather than rational calculation."

In Romans 5:7, Paul argued that someone might give their life for a good person, but not a bad one. No rational person would sacrifice their child for a criminal alien. Yet the "people of the lie" are

taking the side of criminals above citizens. We are being "nudged" to accept a delusion and a perversion. Keep this in mind as you survey the news and especially as the midterms approach.


America is in a new civil war manipulated by overt and shadowy forces. I feel less animus toward the manipulated loons in Minneapolis and elsewhere, who are what Lenin referred to as "useful idiots." I have greater condemnation for the scofflaws who contemptuously break civil law. Perhaps I should use the word discernment instead of condemnation. I don't hate anyone, but some of these miscreants test my patience.

My greatest challenge of condemnation, judgment, or discernment is reserved for the anti-American anarchists and the Marxists who fund them. Their vile, hate-filled rhetoric is a window into their lost souls. They are driven by a perverse, hate-filled ideology and are deadly. Perhaps the grace of Christ can save these tortured and lost souls. But they should count their blessings that I am not the one to sit in judgment of their ultimate fate.

Most Want Criminal Aliens Punished, Then Deported

During each of my 30 years in Congress, I had the privilege of attending the annual State of the Union address. On January 24, 1995, I heard President Bill

Clinton say the following:

"We are a nation of immigrants. But we are also a nation of laws. It is wrong and ultimately self-defeating for a nation of immigrants to permit the kind of abuse of our immigration laws we have seen in recent years, and we must do more to stop it."

He also said that "All Americans...are rightly disturbed by the large numbers of illegal aliens entering our country. The jobs they hold might otherwise be held by citizens or legal

immigrants. The public service they use impose burdens on our taxpayers."

He received a standing ovation from almost every member of Congress, both Democrats and Republicans, at the end of this one minute and 24 second part of his speech. You can easily see this online today. Over the last 32 years, the number of illegal immigrants has exploded.

All records were broken during the Biden administration as he and his top officials encouraged it because

the Democratic Party has become heavily dependent on foreign-born voters.

President Trump was elected with a very large number of his votes coming from fed-up former Democrats who wanted him to stop the flood of illegal immigrants coming here and the loss of so many good jobs to other countries.

I became one of Trump's earliest endorsers primarily because of the anti-war, America First views he had expressed. But when he called the next morning to thank me, I told him we needed to be tougher on trade and immigration. When I handed the phone to my late wife, he told her, "Your husband sounds just like me."

Now, not only has the flood of people coming here illegally been almost stopped, but the Department of Homeland Security reported that 622,000 were formally deported in 2025 and that another 1.9 million self-deported due to stronger enforcement of our laws, including laws against illegal hiring.

The Immigration and Customs Enforcement Agency (ICE) has been targeting felons, and many thousands who have been deported had committed very serious crimes. Of course, all of the adults had violated our immigration laws by coming here illegally in the first place.

Most in the national

media have not been reporting about the thousands of murderers, rapists and child sex offenders who have been removed. Instead, because of their hatred for President Trump, they have leaped onto the minuscule number of mistakes made by ICE officers, especially those that have tearjerker elements.

It is very unfortunate that two people have been killed by ICE officers, and detailed investigations are ongoing. If the officers shot without just cause, I am sure that they will be severely disciplined, and lawsuits are probably already in the works.

I am glad that our immigration laws are finally being enforced, and I commend the officers who are trying to do this work. Their jobs have been made much more difficult by very hateful leftist organizations.

Rep. Tom Emmer, who is from Minnesota and is one of the Republican leaders in the U.S. House, said most of the people he represents support law enforcement and that many of the protests have been led by paid left-wing outside agitators.

The American people have always been the most generous and sympathetic people in the world. No other country has even come close to doing as much for people from other countries as we have.

As I mentioned in last week's column, every

country has natural resources and/or natural beauty – and usually both – that could make any country wealthy if it allowed capitalism, private ownership of property and enforced law and order.

However, the economy in most countries has been wrecked by socialism so that now probably five billion people around the world live in what we would consider to be bitter poverty. Most would think they had died and gone to heaven if they could come here to live.

But our entire infrastructure – our schools, roads, jails, sewers, hospitals, housing, police and fire protection, etc., – just could not handle the very rapid influx of hundreds of millions of people who would come here if we simply opened our borders.

This country, as we know it today, would end. We already have too many people here whose love is for their home country. Britain has not been enforcing its immigration laws, and Fox News reported a few days ago that 40.6% of that country is now foreign-born and the number one name for boys born last year was Mohammed.

It has been said that if you don't have borders, you don't have a country. We need to have a legal, orderly, and limited system of immigration, and it must be enforced.

Should student information be given to ICE?

That was the question before the Knox County Commission last Thursday when District 7 Commissioner Rhonda Lee asked the full commission to support a proposed state law. Lee postponed her resolution "affirming local discretion consistent with the proposed state law and responding to the School Board Legislative Priority #6" to April.

Here's the language in Lee's resolution:

"The Knox County Commission urges the Tennessee General Assembly to support proposals allowing school districts to collect or monitor student immigration status, as such authority may reduce financial liabilities and risks borne by local governments, lower long-term administrative costs, and minimize operational distractions from teaching and learning. The Commission further affirms the State of Tennessee's compelling interest in

protecting public education for the children of citizens of Tennessee."

The Knox County Board of Education had voted 6-3 to not prohibit undocumented school students from attending the public schools. The three dissenting votes came from school board members Betsy Henderson, Lauren Morgan and Steve Triplett.

District 9 Commissioner Andy Fox postponed his presentation about his views of Christianity and undocumented aliens. Fox had previously postponed a resolution that called on the Knox County Sheriff's Office to expand its cooperation with ICE in the 287(G) Task Force Model.

Speaker after speaker opposed the Lee and Fox resolutions, published and scheduled on the agenda, out of a gathering of about 70 that was encouraged by Indivisible Knoxville.

Both Lee and Fox responded to the crowd and defended their positions, with Fox quoting

scripture amid shouts from the audience.

Despite the encounter between the crowd and the two commissioners, the commission managed to discuss and resolve other matters on its agenda.

The Knox County School's annual report showed about 58,000 students and the system is now the 68th largest district in the country. Dr. Jon Rysewyk reported on his four years as superintendent, bringing the system from "unsatisfactory" to "advancing" and noting a new low in teacher vacancy. The progress at Lonsdale Elementary was highlighted.

The commission declared January as Human Trafficking Prevention Month in a motion by Chairwoman Gina Oster and Knox County Mayor Glenn Jacobs.

A discussion on a request to close part of Wye Way Lane was postponed for 90 days to give the property owners who requested the closure time to have a survey completed

and possibly resolve the litigation between the Gray family and the state. Engineering Director Jim Snowden said the delay would give the neighbors time to agree on what parts of the dead-end road could be closed.

The commission also approved extending the contracts with Angelic Ministries and Volunteer Ministry Center, maintaining their HUD program funds, in an 8-2 vote.

More than a dozen subdivision streets were approved to move to county maintenance, with most of the roads in Districts 6 and 8.

Nathan Butler was named to the West Knox Utility District Board, and Lee Igleheart and Pamela Stout were chosen as members of the Agricultural Extension Committee.



residential, NR for neighborhood residential, MR for mixed use, TND for traditional neighborhoods, RHB for rural crossroads and rural living, and BC for Business and Commercial.

Other zoning term changes include TC for town center, LI for light industrial, HI for heavy industrial and CO for corridor overlay and technology.

The changes proposed are meant to better define zones and districts by consolidating and updating the land use terms. The next step would include general building standards for lots and buildings, parking and loading, non-conforming zones and public input.

Knox County Mayor Glenn Jacobs speaks to CAK Patriots Club

On January 21, Knox County Mayor Glenn Jacobs visited Christian Academy of Knoxville’s Patriots Club, offering an honest look at the demanding reality of his role. He quickly dismissed the perception that a mayor’s life is glamorous, instead highlighting the strenuous work required in public office. Mayor Jacobs described his role as ensuring that the people who “are actually out there doing the work” can do their job. When discussing the essential tasks of managing the

county’s finances, particularly taxes and debt, Mayor Jacobs was candid: “All (of) that’s really boring, but that’s actually my job.” The mayor highlighted the equal importance of interacting with the community, noting that public interaction reveals “what’s on people’s minds and what changed some of the ways I thought of things, as well as things I hadn’t even thought of.” Student Owen Blankenship remarked, “I really like Mayor Jacobs’ lower impact approach to government and simply

letting people be people.” “Too often in politics, especially in Washington, it’s a big bubble,” Jacobs told the students. “All they do is talk to each other; most of them have no idea what folks in Knoxville want.” Mayor Jacobs’s address centered on redefining the politician’s role as a “servant leader,” a concept he defined by two core responsibilities: the first is ensuring the success of every individual on his immediate team through empowerment and mentorship. The

second—equally crucial—is serving the broader community with meaningful and impactful actions that improve citizens’ lives. Mayor Jacobs’s speech ended with some powerful advice: “Know your ‘why’ in politics.” This powerful statement holds beyond the realm of politics, urging aspiring leaders to root their drive for public service not in personal ambition, but in a clear, principled commitment to the common good of their state and nation.

Exploring Highway 63 to Huntsville

A Day Away

Just north of Knoxville, up Interstate 75, is a road that you might want to take a day to explore. If you're not from East Tennessee, or even if you are, you may not be familiar with the Senator Howard Baker Highway, or State Route 63. Just past Caryville, you can leave I-75 at Exit 141 and head northwest on SR 63 and come to the little community of Pioneer, on the northwest corner of Campbell County. That little historic residential

neighborhood has an old and now new post office and a few residents.

It's on the corner of the Royal Blue Wildlife Management Area.

Continuing west, you'll pass several small communities until you reach Huntsville, the home of former U.S. Senator Howard Baker. The town of about 1,500 people was named for the "Hunt" shelter nearby, a rock shelter used by long hunters long before the American Revolution. The town became the county seat of Scott County, formed in 1849.

Scott County is unique among Tennessee counties in that, when the state voted to join the Confederacy during the Civil War, the people of Scott voted to withdraw from Tennessee and form the "Independent State of

Scott."

The First National Bank and the former three-story Scott County Jail are on the National Register of Historic Places. The historic old jail became a museum and paranormal center and is open to the public for tours. The Historic Scott County Jail's website is www.historicscottcojail.com, and its staff can be reached at (423) 663-5353.

If you walk the trail behind the building, you'll come to the Old Town Springs Park, a mini-park with a greenway trailhead, and a surprising gorge with a waterfall.

Scott County claims it is the entrance to the Big South Fork National River and Recreation Area, a huge national preserve with towering cliffs, waterfalls, forest, rock formations and natural arches.

Huntsville's famous Baker family began with James Baker moving here just after the Civil War. He was an attorney and newspaper publisher. His son, Howard H. Baker Sr., served in the U.S. Congress

and his son, Howard Baker Jr., became a U.S. Senator, Majority Leader and White House chief of staff.

Just off the grounds of Scott County High School is the Museum of Scott County. It features early pioneer exhibits. Just next door is the U.S.S. Battleship Memorial Museum, which houses the largest collection of U.S.S. Tennessee memorabilia in the world and is dedicated to survivors of the attack on Pearl Harbor.

The museum complex has more than a dozen log and stone buildings with exhibits for ancient and modern times, historic artifacts, and learning labs for children. One of the buildings traces Senator Baker's history with a replica of his grandfather's law office, as well as examples of the senator's passion for photography.



If my eyes are healed from surgery, some of my time will be spent burning the piles of brush that have accumulated since last year. When Amy and I first moved into our house, Mr. Nelson allowed me to pile

sticks and other yard trash on a pile that he kept. When the snow came, he walked out to the pile, poured kerosene on strategically placed wads of newspaper, and then put a match to the pile. It flamed quickly, and then Mr. Nelson pulled out his secret weapon: an electric leaf blower. He flipped the switch and pushed the highest volume button. That fire sucked in the air and quickly became a blast furnace. Sticks, stumps, and old pieces of firewood were turned to ashes before long. By evening, the entire mound turned to ashes. Even the next morning, he could stir those ashes, put more sticks on them, and create another fire.

My concern is that the power might go out. We live on electricity since no gas lines have ever been run in our part of Ball Camp. Food will be fine with the cold weather. My mother used to talk about heavy snows that knocked out the power. She boxed the food from the refrigerator and set it outside. I think I can do the same. We have bread, milk and eggs, so

trips to the grocery store won't be necessary.

What I don't want to happen is to lose the heat. In younger years, the cold didn't bother me so much, but these days, I don't fare so well. My feet and hands become icy. My nose "runs like a sugar tree," and every joint aches. Our fireplace hasn't been used in years and is probably filled with gunk. We have enough blankets to keep us from freezing, but being stuck inside with no television, limited amounts of power on electronic devices, and no lighted way through the house isn't much fun.

I just looked at another prediction that showed the worst of the weather hitting farther south. That's fine with me. In fact, I hope no snow or ice develops the entire winter. Cold temperatures that kill the ticks and other bugs are the only kind of winter I want. Of course, I don't control the weather, so I'll wait and be ready with my shovels, fire starters, and warm clothing. More than likely, we'll survive. Don't be surprised if nothing comes. It's happened before.

Louis Rabaut of Michigan

Pages from the Past

There were several Congressional districts across the country largely populated by immigrants. There were districts in New York City with a heavy Italian population, while similar districts in Illinois and Michigan were inhabited by Polish citizens. Across the Midwest, there were states where German-Americans were an important constituency. Most of the Congressional districts heavily populated by immigrants and the children of immigrants belonged to labor unions and were an integral part of the local work force; they were extraordinarily patriotic, proud to call themselves Americans. One son of immigrants was responsible for making an important addition to the Pledge of Allegiance. It was Congressman Louis C. Rabaut who was responsible for inserting the phrase “under God” in the Pledge of Allegiance. Rabaut was also the sponsor of the “Pray for Peace” postage cancellation, which, I believe, is still used today.

When the debate about adding the language “under God” to the Pledge of Allegiance was being held on the floor of the House, Congressman Louis Rabaut, an eloquent speaker, told his colleagues, “You may argue from dawn to dusk about differing political, economic and social systems, but the fundamental issue which the unbridgeable gap between America and Communist Russia is a belief in Almighty God. From the root of atheism stems the evil weed of communism and its branches of materialism and political dictatorship. Unless we are willing to affirm our belief in the existence of God and his creator-creature relation to man, we drop man himself to the significance of a grain of sand and open the floodgates to tyranny and oppression.”

With the onset of the Great Depression, many citizens who were the product of immigration or the children of immigrants were hit especially hard by the faltering economy. Like millions of other Americans, they were drawn to the Democratic Party because of the candidacy of Franklin Delano Roosevelt.

Louis Charles Rabaut was himself the son of immigrants who had come to the United States from Flanders. Rabaut ran for Congress the first time in 1932, facing Carl Weideman in the Democratic primary along with at least five other candidates. Weideman and Rabaut fought for the nomination inside a district in Michigan’s Wayne County, which runs from the east side of Detroit toward Hamtramck. Weideman won a comfortable plurality of just over a third of the

vote inside the Democratic primary. Rabaut ran a somewhat distant second, polling slightly more than 23% of the vote. Weideman went on to win the general election against incumbent Congressman Robert H. Clancy, an enterprising politician who had first been elected to the U.S. House of Representatives in 1922 as a Democrat. Clancy lost his reelection bid in 1924 to Republican John B. Sosnowski. Evidently not one to give up easily, Clancy switched parties in 1926 and managed to defeat Congressman Sosnowski in the 1926 GOP primary. In the 1926, 1928, and 1930 elections, Robert H. Clancy faced the same opponents in the primary and general elections, beating John Sosnowski in the Republican primary and William Donnelly in the general election. Sosnowski was not a quitter either and ran for Congress an astonishing twelve times, although he only won the 1924 general election.

Congressman Clancy’s district had been slightly altered due to redistricting following the 1930 election and the Democratic tide, as it did with so many GOP congressional candidates and incumbents, doomed his candidacy, although he won a very respectable 47% of the vote in what was a dreadful year for Republicans. The Fourteenth Congressional District was, according to the Detroit Free Press, “as varied as one can find in Michigan,” which “took in the eastern portion of Detroit from Field and the river up Van Dyke to Eight Mile and east to the city limits” and also included the wealthy Grosse Pointes.

Carl Weideman went to Washington, D.C., to take part in the first Hundred Days of FDR’s New Deal. Congressman Weideman’s support for President Roosevelt did not prevent him from being challenged once again inside his primary in 1934. Evidently, Weideman did not suit everyone inside his district, as the Detroit Free Press recorded the congressman was “particularly a thorn in the flesh of the organization Democrats.” Rabaut was a colorful lawyer, a Catholic with nine children, four of whom joined religious orders. One son became a priest, while three daughters became nuns. The Free Press thought Louis Rabaut made the most of a “good singing voice and an affinity for God.” A staunch Catholic, Rabaut was horrified in the 1950s when a birth control proposal was being considered by Congress. “My views are known,” Rabaut barked. “I’m dead against it. It would create a bad example to a lot of little towns.”

The fight between Rabaut and Weideman, according to the Detroit Free Press,

was especially hard fought with “no quarter asked” by either side in “the stand-up-and-fight battle” between the opponents. The primary election was a photo finish, with Rabaut winning by 471 votes. Not surprisingly, the primary election was close enough that Congressman Weideman demanded a recount, which confirmed Rabaut as the winner. The general election was easier with Rabaut polling over 62% of the vote against Republican John McPherson. Louis Rabaut became a fixture inside Michigan’s 14th Congressional district and would remain in the U.S. House of Representatives until his death in 1961, with but one two-year interval.

Like his predecessor in Congress, Louis Rabaut had a habit of bucking the party leadership when it suited him. The Detroit Free Press readily acknowledged Rabaut “frequently displayed an independence in Congress which at times must have annoyed Democratic leaders in Congress.” Yet the Free Press believed it was Rabaut’s political independence that helped him with the folks back home, although the newspaper thought the key to the longtime congressman’s success with the voters was due to his personality and demeanor. The Detroit Free Press described Louis Rabaut as “a warm, friendly man who possessed the common touch,” which the newspaper was convinced was “the chief ingredient of his political success.”

Not a shy man, Louis Rabaut apparently had a fine singing voice and was a soloist in the House of Representatives in 1946 for a service to commemorate those members of Congress who had recently died in office. Rabaut was accompanied by his daughter, Joan Marie. That same year, Rabaut’s son,

Vincent, and daughter-in-law made him a grandfather for the first time.


Providing excellent constituent service to the people of his congressional district, Louis Rabaut was routinely reelected with large majorities until 1946. The Democrats had enjoyed majorities in both houses of Congress since Franklin Roosevelt’s election in 1932; by 1946, Roosevelt was dead, World War II was over, and soldiers were returning home to their families. Harry S. Truman had succeeded FDR, and the scarcity of some products and the economy irritated many voters. 1946 proved to be a banner year for Republicans, who swept Democrats out of both the House of Representatives and the United States Senate. Republicans picked up 11 seats in the Senate and 55 seats in the House. One of the Democratic districts lost in the 1946 election was that held by Louis C. Rabaut. Congressman Rabaut was stunned to lose to plumb-ing contractor Harold F. Youngblood. The Detroit Free Press summarized the new GOP congressman as “a rough diamond type who works hard, follows the party line in Congress, and preaches small-business man’s doctrine.”

There was little doubt in anyone’s mind that the 62-year-old Louis Rabaut would run again in 1948 to reclaim his seat in Congress. Rabaut was certainly acting very much like a candidate, serving as the principal speaker at the Annunciation church in the heart of his former Congressional district to honor a popular priest who had died and dedicated his life to helping homeless children. Mrs. Rabaut was certainly doing her part for her husband, hosting a tea at their five-bedroom home for the Peter and Paul unit of the local Jesuit

Seminary.

Running again in a presidential election year (albeit one in which Harry Truman was expected to lose to New York Governor Thomas E. Dewey), Louis C. Rabaut handily defeated Congressman Harold F. Youngblood, winning by almost 57% of the votes tallied. Youngblood proved to be a determined candidate and ran again for Congress in 1950, 1952 and 1956. Evidently, many Republicans inside the Fourteenth Congressional District did not believe Harold Youngblood would be the strongest candidate they could field in a general election, as he lost the GOP primaries in 1950 and 1952. Finally, in 1956, Harold F. Youngblood barely managed to scrape past his nearest competitor inside the Republican primary to win a rematch with Congressman Louis C. Rabaut. Unfortunately for Youngblood, despite the highly popular President Dwight D. Eisenhower running at the top of the ticket, he fared little better against the deeply entrenched Rabaut than he had in his losing 1948 reelection campaign. Eventually, apparently having tired of Michigan’s frequently brutal winters, Harold Youngblood retired to the warmer clime of Arizona, and he ran for Congress inside the GOP primary in 1962, only to lose badly.

By 1959, Louis Rabaut was ailing. The congressman was taken to Bethesda Naval Hospital after becoming ill in his office. Doctors diagnosed Rabaut as suffering from cerebral ischemia, a spasm in a small blood vessel in the brain. Rabaut’s stay in the hospital varied, depending upon which news outlet one believed, but it seems reasonably certain the congressman was out of his office for several weeks. According to one source, Rabaut returned to Capitol

Hill after only two weeks, but the Detroit Free Press reported that Congressman Rabaut needed seven weeks to recover from his illness. As with every aging incumbent, Rabaut’s office attempted to minimize the episode. A spokesman for Rabaut was quick to say the Congressman was “in wonderful physical shape,” and there was no reason to believe there would be any recurrence of his ailment. The spokesman added there was certainly no permanent damage to the congressman’s brain.

The 73-year-old Louis Rabaut was easily reelected in 1960, winning roughly 63% of the vote against Republican challenger Lois V. Nair and several other candidates in the general election. Death finally found Congressman Rabaut while he was doing what he loved best: meeting and greeting people. On Sunday, November 12, 1961, Congressman Louis Rabaut was attending a testimonial dinner honoring Thaddeus M. Machrowicz, who had just been appointed to serve as a federal judge. Machrowicz had been a congressman from Detroit before being appointed to serve on the federal bench. More than 1,000 people had gathered in the Knights of Columbus Hall in Hamtramck, Michigan, to fete the former congressman. As Rabaut started toward the podium to make his speech, he collapsed from a massive heart attack. Dr. Raymond Suwinski jumped up and tried to revive the stricken congressman while paramedics rushed to the location. Although Dr. Suwinski later said Rabaut’s breathing was restored when oxygen was administered, the congressman was pronounced dead at 10:40 p.m. when he arrived at St. Francis Hospital in Hamtramck. Doctors at the hospital had made every effort to save the life of the 74-year-old congressman, massaging his heart and giving him oxygen for an hour and fifteen minutes before sadly concluding it was to no avail.

Although a lawyer by trade, Louis Rabaut had worked in real estate for some years before winning election to Congress. A rough and tumble campaigner who enjoyed people, Rabaut represented, according to the Detroit Free Press, “a weird hodgepodge of the rich, the well-to-do and the poor of the 14th District.” While Rabaut had been largely invulnerable at the polls, there was to be no political dynasty in his family, although his son and namesake, Louis Jr., tried. The younger Rabaut had lost a campaign for the Michigan State Senate precisely because voters were wary that he was attempting to position himself to succeed his father in Congress. Louis Jr. ran in the 1962 special election to replace his father and lost the Democratic nomination.

In 2024, Tom Barrett, a Republican, was elected to Congress from Michigan, and is Rabaut’s great-grandson. Barrett occupies the office once used by his great-grandfather in the Longworth House Office Building.

Death on the prairie

The 7th Cavalry was a force to be reckoned with in the old American West. Stationed out of Fort Wallace, Kansas, these men engaged in battles with various Indian tribes and some of the bad men of the Old West.

Bands of warring Indians were raiding the Kansas settlements in the 1860s,

and the commanding officer at Fort Wallace asked Col. Homer Wheeler to deliver dispatches to Colonel Bradley, who was camped a hundred miles away. The travel would be extremely dangerous, so Wheeler was told he could find a competent man of his choosing, and that they would receive a hundred dollars each if they returned successfully.

Wheeler immediately decided that Johnny Langford, a half-Cherokee Indian, was the man for the mission.

"Me and Johnny enjoy a little hazardous adventure from time to time," Col. Wheeler said. "And we can use the money."

On the first night, after several hours of travel, they came upon a band of Indians whom they heard celebrating in the distance. "We've not lost no Indians so let's not get mixed up in that bunch," Langford offered before they made a large circle around and avoided their camp. They located Colonel Bradley's camp after twenty hours of travel.

"I'm anxious for you to return as quickly as possible with a message for Col. Bankhead," Bradley impressed upon the two tired men. "These messages are very important and may end up saving the lives of a great many settlers."

"We are tired and our horses need rest as they've been ridden very hard," Wheeler countered.

"Of course, you must rest," Bradley agreed. "Now, if you'll be ready to travel in four or five hours, I will have fresh horses for you and one hundred dollars each."

The men knew the duty

was fraught with hazard, but were confident in their abilities, plus neither man had even held a hundred dollars before. They would also receive a hundred dollars each from the commander when they returned to Fort Wallace. After sleeping for a few hours and eating a good meal, the men were on their way.

On the return trip, Wheeler's horse came up lame about twenty miles out of Fort Wallace. The men alternately rode the sound horse while the second man walked. Eventually, they arrived at the fort only a few hours later than they would have otherwise. Fortunately, the men avoided the Indians on the return.

A few days later, Langford was made an assistant. After that, he had trouble with a teamster named Roche. The men shot each other, but Langford luckily survived with only a wound through the shoulder. Following a full investigation by the commanding officer at Fort Wallace, it was determined that Langford acted in self-defense and was not charged.

Roche's brother didn't agree with the commander's findings and waited for an opportunity to exact his

revenge.

A few months later, he learned that Langford was sleeping on the roof of a ranch house on Rose Creek. He enticed a group of inebriated men to go with him to "get even" with Langford. McClure, the owner of the ranch, called for Langford to come down, but didn't tell him there were several men looking for him.

"They would have never been able to take him alive," Col. Homer Wheeler related later. "He likely would have escaped or driven the mob away. Langford was a real man, handy with guns or fists and survival skills better than any other. They might have gotten him, but mobs are usually cowardly when you get right down to it, and Langford was a tough egg to deal with."

The mob had the drop on Langford, however, and put him in a wagon and took him to a tree near the stagecoach station.

Langford sized up the situation right away by Roche's commentary, and immediately spoke up, saying his actions in the shootout with his brother was not his fault, and that he acted in self-defense. He saw his words fell on deaf ears. "Well, if you're hanging me, I don't want to go with my boots on,"

he offered as he reached down to take them off.

He expected someone to stop him, but they didn't, and when he got the first boot off, he used it to knock the wagon driver in the head, and then attempted to jump off the wagon. There were too many men, however, and he was soon under their control.

"I'm not afraid to die," he told them when it became imminent that his time had come. "I'm telling 'ye here and now that I'm gonna make your lives here a living hell. I'll look for any way I can to come back to get each and every one of 'ye."

Col. Wheeler said that he later heard that Langford, the half-Cherokee, gave an Indian war whoop and leaped from the wagon, hanging himself.

Wheeler went on to say that he knew two of the men who participated in Langford's hanging and said neither of them had any peace of mind after that for as long as he knew them.

Carter was 12-0 in the county including their run to the Knox County AA title and overall 24-0.

Trull finished with 14 points in the second half and a total of 19 points. Leach chipped in eight points, including two 3-pointers. Samantha Burnett added six points.

Caroline Howard and Emersyn Phillips led Gibbs with 10 and nine points, respectively.

Throughout the 2025-26 season, the Farragut Middle School boys basketball team has won more than its share of close games. And on Wednesday night, the Admirals had to work a little overtime to defeat a scrappy Halls squad and win the Knox County Middle School Basketball Class AAA Tournament.

After trailing throughout much of the contest, Farragut came from behind to notch a 42-39 overtime victory over the Red Devils in a battle of division champions before a packed and spirited house at South-Doyle Middle School.

"There were a couple of times tonight that I thought we were done," Admirals' coach Shane Wells said. "But our kids came back, and that shows a lot about their character.

"We've been in a lot of close games, and we've won almost every one of them. We were extremely fortunate to win tonight, and we've been extremely fortunate all season."

After the first quarter, the Red Devils, who won the East Division, and Farragut, the West Division champ, were locked in a 9-9 tie, and Halls had a 19-17 lead at halftime.

The Red Devils, thanks to a shot from Cruze Yanniello as time expired in the third frame, held a slim 31-29 advantage heading into the final six minutes of regulation. Halls also had a lead in the waning seconds of

the fourth quarter until Farragut's Henry Crecy buried a 3-pointer as time expired in the fourth quarter, knotting the contest 36-36, and sending the game into overtime.

The Admirals seized control quickly in the extra fame as Crecy grabbed an offensive rebound and promptly scored, making it 36-36. From there, Farragut never trailed again as it controlled the offensive glass. Benji Evans also scored off an offensive rebound in the extra frame.

'A season part strange and miserable'

The month of August 1992 and the days beyond had a significant impact on the history of the Vol football program.

One journalist described the campaign as “part strange and miserable.” Head trainer Tim Kerin, a prime John Majors confidante since the days at Pittsburgh, had died early that month, doctors calling the cause of death a “dissecting aortic aneurysm.”

Tim’s was a voice of reason, a voice of integrity, tempering the often volatile Majors’ personality. Tennessee later named the training room in the Neyland-Thompson Center in his honor and memory.

A week or so later, Majors left practice early, with the media being told it was for a doctor’s appointment. That was correct as far as it went. The next morning, a local radio station announced Majors was undergoing heart surgery. He would miss the first three games of the season, with AD Doug Dickey naming offensive coordinator Phillip Fulmer interim head coach.

It probably didn’t help matters that Majors came back before anyone expected, the Sunday night after a 31-14 win over Florida, the second win over the Gators in the past three years. Many people close to the Vol program believed that circumstances might have been different, considering Kerin’s relationship

with Majors.

The schedule-maker had also made things worse. There were successive losses to Arkansas (25-24) and Alabama (17-10) and open dates before and after a one-point loss at South Carolina (24-23). That trip will never make any list of the Top 10 road trips in Vol history.

It was a dark and foreboding time, one during which the Vol

family seemed to be torn asunder, with the fan base choosing sides. There was considerable discussion of broken promises, bad relationships, and disloyal behavior. Media “source stories” appeared daily on the front pages of statewide media.

No one, save those involved, knows the entirety of the story.

Things came to a head at a media conference in Memphis

on Friday afternoon and evening, Nov. 13, at the Wilson World Hotel. That venue is gone, but the memories linger. The Vols played Memphis State the next day at the Liberty Bowl. Vol fans were shocked at what was transpiring, gathering at the hotel and at the Liberty Bowl with saddened faces, many fighting back tears, not believing what was happening.

Majors resigned that night, saying, “Since I have not been given the opportunity by the UT administration to remain as head football coach, I am, effective Dec. 31, 1992, relinquishing my duties connected to the University of Tennessee.”

The announcement of the end of the Majors Era came in the Bluff City, where his playing career at Tennessee had started more than 38 years before with a 19-7 win over Mississippi State.

Looking back, there was certainly travail in the program that fall. Emotions ran high. Regardless of the position Tennessee fans might have taken, choosing sides helped no one. Times were tough enough playing in the SEC without internal strife in the program.

One of the most poignant post-game moments that day was watching John Elizabeth Bobo Majors, John’s mother, leaving the stadium and walking into the late afternoon shadows, alone with her thoughts and memories.

The name “Majors” is written large in Tennessee football history, as Haywood Harris has noted.

John’s brother, Bill, was killed in the car-train wreck in October 1965 that also took the lives of fellow assistants Bob Jones and Charley Rash.

“It is enough for longtime residents of this community to say he was a Majors,” Harris wrote for the Houston game a week later. That’s how strong the Majors name was and still is today around Big Orange Country.

Majors and the Vols swept the regular season’s final three games, defeating Memphis State (26-21), Kentucky (34-13) and Vanderbilt (29-25). Fulmer was named head coach Sunday night after the Vanderbilt game.

A 38-23 victory over Boston College in the Hall of Fame Bowl made Fulmer’s head coaching debut a successful one.

One other conclusion is inescapable.

“Majors’ programs were widely regarded as one of the nation’s best,” wrote the Knoxville Journal’s Russ Bebb. “To many people, he was Tennessee football. Majors might have painted himself into a corner, but no matter what he might have done to bring about his ouster, no matter what demands he might have placed on the administration, he deserved a far nobler farewell.”
